Monthly Report of Recent Economic and Financial Developments¹ March 2008

The Bank's View²

Japan's economy is expanding moderately as a trend, although the pace of growth has been slowing mainly due to the drop in housing investment and the effects of high energy and materials prices.

Exports have continued to increase. Business fixed investment has also continued to trend upward, as corporate profits have remained high although they are leveling off. Private consumption has been firm in a situation where household income has continued rising moderately. Meanwhile, public investment has been sluggish. Housing investment has remained at a low level, although there have been signs of recovery. With these developments in demand both at home and abroad, production has been more or less flat lately, partly in reaction to the relatively large increase in the second half of last year.

Japan's economy is expected to continue expanding moderately, although the pace of growth is likely to slow for the time being.

Exports are expected to continue rising, as overseas economies are likely to expand although at a slower pace. Business fixed investment and private consumption are likely to follow an uptrend against the background of generally high corporate profits and the moderate rise in household income. Housing investment is expected to recover gradually, although it is likely to remain sluggish for the time being. In light of these developments in demand both at home and abroad, production is expected to increase, after being more or less flat in the short run. Public investment, meanwhile, is projected to be on a downtrend. Due attention should continue to be paid to factors such as uncertainties regarding future

developments in overseas economies and global financial markets, as well as the effects of high energy and materials prices.

On the price front, the three-month rate of change in domestic corporate goods prices has been positive, mainly due to the rise in international commodity prices. The year-on-year rate of increase in consumer prices (excluding fresh food) has been rising since around the end of last year, due to the increase in prices of petroleum products and food products.

Domestic corporate goods prices are likely to continue increasing for the time being, primarily reflecting the rise in international commodity prices. The year-on-year rate of change in consumer prices is projected to follow a positive trend due to the rise in prices of petroleum products and food products in the short run and the positive output gap in the longer run.

As for the financial environment, the environment for corporate finance is accommodative. Credit demand in the private sector has been more or less flat. The issuing environment for CP and corporate bonds has been favorable as a whole, although issuance spreads on those issued by firms with low credit ratings have expanded slightly. Lending attitudes of private banks have continued to be accommodative. Under these circumstances, the amount outstanding of lending by private banks has been increasing moderately, and the amount outstanding of CP and corporate bonds issued has been above the previous year's level. Funding costs for firms have been more or less unchanged. Meanwhile, the year-on-year rate of change in the money stock is around 2 percent. As for developments in financial markets, in the money markets, the overnight call rate has been at around 0.5 percent, and interest rates on term instruments have been around the same level as last month. In the foreign exchange and capital markets, the yen has appreciated against the U.S. dollar compared with last month, while long-term interest rates and stock prices have fallen compared with last month.

The Background

1. Economic Developments

<u>Public investment</u> has been sluggish (Chart 4). Looking at monthly indicators, the amount of public construction completed—which reflects the progress of public works—declined in the third quarter on a quarter-on-quarter basis, and fell also in the fourth quarter. The value of public works contracted—a measure that reflects public orders—registered a sizeable decline in the third quarter on a quarter-on-quarter basis, then inched up in the fourth quarter, but fell again, albeit marginally, in January compared with the fourth quarter. Public investment is projected to be on a downtrend due to tight national and local fiscal conditions.

Real exports have continued to increase against the background of the expansion of overseas economies (Charts 5[1] and 6). They rose substantially, by 5.2 percent, in January compared with the fourth quarter, after having exhibited high growth throughout the second half of last year.

As for real exports by destination (Chart 6[1]), exports to the United States rose in January compared with the fourth quarter after having marked a quarter-on-quarter decline in the fourth quarter. As a trend, however, they have remained relatively weak since around the end of 2006. By contrast, exports to the EU and East Asia rose in the fourth quarter and continued to increase in January compared with the fourth quarter.³ Exports to other regions (such as the Middle East, Latin America, and Russia) have remained high, mainly in automobile-related goods to the Middle East.

By goods (Chart 6[2]), exports of automobile-related goods have continued their solid increases, mainly due to the high growth in exports to other regions. Exports of capital goods and parts have continued to trend upward, to a wide range of regions, despite fluctuations in those to the United States. Exports of IT-related goods have risen moderately, assisted by steady global IT-related demand (Chart 7[1]). Exports of intermediate goods have also been on an uptrend, mainly in high

value-added goods used for IT-related goods and automobiles. Exports of consumer goods have been on an uptrend, mainly in digital home appliances, albeit with somewhat large fluctuations.

<u>Real imports</u> have been more or less flat (Charts 5[1] and 9). Real imports decreased by 0.6 percent in the fourth quarter on a quarter-on-quarter basis, but then increased by 1.3 percent in January compared with the fourth quarter.

The recent trend by goods shows that imports of capital goods and parts (excluding aircraft) have continued to be on an increasing trend, reflecting the uptrend in domestic business fixed investment. Imports of IT-related goods have been trending upward since around the middle of last year when domestic inventory adjustments were completed (Chart 7[3]). Imports of raw materials and intermediate goods have remained more or less flat on average, since firms have cut back on imports of materials in response to the trend of rising import prices. Imports of foodstuffs and consumer goods have been on a declining trend, mainly due to the rise in import prices.

Net exports in terms of the real trade balance have continued to be on an upward trend, reflecting the aforementioned movements in imports and exports (Chart 5[2]). The surplus of the nominal balance on goods and services has expanded only modestly assisted by the rise in crude oil prices.

Exports are expected to continue rising, as overseas economies are likely to expand although at a slower pace (Chart 8[2]).

As for the environment surrounding exports, in the United States, the economy seems to be slowing down further as adjustments in the housing market have continued to protract, financial institutions have taken tighter lending stances, and indicators related to employment as well as consumption have shown relatively weak movements. In the EU, the economy has also started to slow down mildly. In China and other regions, however, the economies are likely to maintain their high growth as a whole. The NIEs and ASEAN economies are also expected to continue expanding moderately, although the pace of growth is likely to slow. Regarding the

environment surrounding exports of IT-related goods, global demand—particularly that for digital home appliances—seems to have continued to expand. Meanwhile, in the foreign exchange market, the yen has appreciated slightly since summer last year, but from a long-term perspective it has remained at significantly low levels in terms of the real effective exchange rate, which incorporates differentials in the inflation rates between home and abroad (Chart 8[1]).

Imports are expected to follow a moderate uptrend, albeit with some sluggishness for the time being, reflecting developments in the domestic economy.

Business fixed investment has continued to trend upward. Based on the Financial Statements Statistics of Corporations by Industry, Quarterly, business fixed investment in nominal terms was flat in the fourth quarter after having exhibited relatively high growth in the third quarter (Chart 10). By industry and size (Chart 11), investment by large manufacturing firms has been at a high level, although the pace of increase has slowed down somewhat. Investment by small and medium-sized manufacturing firms fell back in the second and third quarters from the upsurge toward the first quarter last year, but it picked up slightly in the fourth quarter. Investment by large nonmanufacturing firms has fluctuated significantly: it rose in the third quarter but retreated sharply in the fourth quarter. Investment by small and medium-sized nonmanufacturing firms has been essentially level on average. Looking at monthly indicators, the aggregate supply of capital goods and shipments of capital goods—which are coincident indicators of machinery investment—have continued to be on an upward trend, albeit with somewhat large fluctuations (Chart 12[1]).⁴ Machinery orders (private demand, excluding orders of shipbuilding and orders from electric power companies)—a leading indicator of machinery investment—declined in the second quarter, but bounced back in the third quarter and increased marginally in the fourth quarter. With these fluctuations

smoothed out, they have been more or less flat, at high levels (Chart 13[1]).⁵ Meanwhile, construction starts (floor area, private, nondwelling use)—a leading indicator of construction investment—fell sharply in the third quarter due to the enforcement of the revised Building Standard Law.⁶ Thereafter, they picked up somewhat in the fourth quarter, aided by large-scale construction starts in the manufacturing and retailing sectors, and increased in January, albeit marginally, compared with the fourth quarter (Chart 13[2]).

Looking at the environment surrounding business fixed investment, corporate profits have remained high, although they are leveling off. According to the *Financial Statements Statistics of Corporations by Industry, Quarterly* (Chart 10[2]), the ratio of current profits to sales has remained relatively high, although it dropped in the third and fourth quarters mainly due to high materials prices, after having recorded a historical high in the second quarter.

Business fixed investment is projected to trend upward, since the increasing trend in domestic and external demand and the generally high levels of corporate profits are likely to be maintained.

<u>Private consumption</u> has been firm. Looking at individual indicators on consumption (Charts 14 and 15), sales at department stores and supermarkets have been essentially level on average. Sales at convenience stores have also been more or less flat. Sales of household electrical appliances have continued to trend upward, assisted by strong sales of digital home appliances such as flat panel TVs and of game consoles. The number of new passenger-car registrations has picked up moderately since summer last year with fluctuations smoothed out, supported mainly by the rapid introduction of new models. As for services consumption, outlays for travel have

⁶ According to the revised Building Standard Law—which took effect on June 20, 2007—a more stringent review of applications for building permits has been introduced, and the procedure has also changed significantly. It has been pointed out that construction starts—including housing starts, mentioned below—were delayed, since those related to the construction business were not fully prepared for these changes to the system.

been firm on average. Sales in the food service industry have also been firm on the whole, although they have lost momentum compared to a while ago.

The *Indices of Aggregated Sales* (in real terms)—which are comprised of major sales indicators of goods and services mentioned above⁷—have been firm (Chart 16[1]). The aggregate supply of consumer goods—which comprehensively captures producers' supply of goods—has been trending up mildly, mainly due to favorable conditions for durable consumer goods, albeit with some fluctuations (Chart 16[2]). Meanwhile, looking at private consumption from the demand side, the index of living expenditure level (two-or-more-person households, in real terms) in the *Family Income and Expenditure Survey* registered a quarter-on-quarter decline in the third quarter, and then picked up in the fourth quarter; it also increased in January compared with the fourth quarter. Total expenditure in the *Survey of Household Economy* (two-or-more-person households, in real terms) fell in the third and fourth quarters on a quarter-on-quarter basis, and then picked up in January compared with the fourth quarter (Chart 14[1]).

Consumer sentiment has become cautious as a whole, due to the rise in prices of petroleum products and food as well as to the weakness in stock prices (Chart 17).

Private consumption is expected to follow a gradual uptrend, with the gradual increase in household income.

Housing investment has remained at a low level, although there have been signs of recovery. In terms of the number of housing starts (Chart 18[1])—a leading indicator—movements toward recovery have gradually become distinct. Looking at the number of housing starts in detail according to the type of housing, owner-occupied housing—consisting mostly of small-scale properties—has been almost flat, after having regained its level prior to the enforcement of the revised

Building Standard Law last fall. Housing for sale and housing for rent have continued to pick up, but the level of construction starts of housing for sale in particular has still been well below the level prior to the enforcement of the revised Law. Looking ahead, housing investment is expected to recover gradually, although it is likely to remain sluggish for the time being, since the effects from the enforcement of the revised Law will persist. From a somewhat longer-term perspective, it will regain its firmness, against the background of the rise in household income and favorable financial conditions. Nevertheless, taking the softness in sales of condominiums into consideration, there is large uncertainty regarding the degree of recovery in housing investment.

Industrial production has been more or less flat lately, partly in reaction to the relatively large increase in the second half of last year. Production rose firmly for two quarters in a row by marking an increase of 2.2 percent and 1.3 percent in the third and fourth quarters respectively on a quarter-on-quarter basis, and then dropped by 1.5 percent in January compared with the fourth quarter (Chart 19). As for developments in January by industry, production of electronic parts and devices fell back from the sharp rise in the second half of last year that took place after the completion of inventory adjustments. Production of transport equipment decreased, mainly because the ramped-up production of automobiles that was required to recover the loss caused by the earthquakes has come to an end. Moreover, production of general machinery fell, mainly due to the drop in boilers and power units which tend to fluctuate substantially.

Shipments rose by 2.1 percent in the third quarter and by 2.0 percent in the fourth quarter on a quarter-on-quarter basis, and then fell by 0.5 percent in January compared with the fourth quarter. They have been more or less flat lately, although their movements since the fourth quarter have been somewhat stronger than production. Looking at the trend by goods (Chart 20), shipments of capital goods (excluding transport equipment) have been on an uptrend, albeit with some fluctuations, in light of steady demand at home and abroad. On the other hand, as for consumer goods, shipments of nondurable goods have trended downward, whereas those of durable goods have been on the rise chiefly in digital home appliances and automobiles. In response to these movements in final demand goods and to the

increase in exports, shipments of producer goods have been on an increasing trend, but they have been relatively weak lately, notably in electronic parts and devices. Meanwhile, shipments of construction goods had registered a marked decline since the middle of last year—affected by the ongoing sluggishness in public investment and by the revised Building Standard Law—but they have recently stopped declining.

Inventories have been essentially in balance with shipments. The inventory cycle (Chart 21) shows that, in the industrial sector as a whole, the shipment-inventory balance (the year-on-year rate of change in shipments minus that in inventories) has been more or less favorable. By goods, inventories of producer goods excluding electronic parts and devices (such as iron and steel) have remained relatively low, while shipments have risen persistently. In durable consumer goods, inventories have been almost in balance with shipments. As for capital goods (excluding transport equipment), although inventories have remained at somewhat high levels, the shipment-inventory balance has improved as a trend, assisted by generally steady demand both at home and abroad. In electronic parts and devices, the shipment-inventory balance has been favorable, as inventories have been on a downtrend on a year-on-year basis. However, because the pace of increase in the supply capacity tends to be rapid for this sector and because there is growing uncertainty about overseas economies, especially that of the United States, future developments in the supply-demand balance at home and abroad continue to require close monitoring. As for construction goods, inventory adjustment pressures have continued to be strong.

As for the outlook, production is expected to increase, after being more or less flat in the short run, in light of developments in demand both at home and abroad. The production forecast index and anecdotal information also suggest that production is likely to be flat or decrease somewhat in the first quarter on a quarter-on-quarter basis.⁹

⁹ Production in the first quarter—based on the production forecast index for February and March—is calculated to decrease, somewhat substantially, by 2.5 percent on a quarter-on-quarter basis. However, certain latitude should be allowed for this calculation, primarily because fluctuations caused by discontinuity are likely to occur when combining the forecast index and original series due to the differences in their coverage and weights.

As for the <u>employment and income situations</u>, household income has continued rising moderately, supported by the increase in the number of employees, while the labor shortage continues to exist (Charts 22[2] and [3]).

In the labor market, overtime hours worked have been virtually flat at high levels (Chart 24[3]). The ratio of job offers to applicants has been at a relatively high level, although it has recently inched downward (Chart 23[1]). ¹⁰ The unemployment rate has been marking a level slightly below 4 percent on average (Chart 23[1]).

In terms of employment (Chart 24[1]), the year-on-year growth rate in the number of employees in the *Labour Force Survey* has generally been moving at around 1.0 percent, but the growth rate dropped slightly in January. The year-on-year growth rate in the number of regular employees in the *Monthly Labour Survey* has recently been moving at around 2.0 percent. Looking at the number of regular employees in the *Monthly Labour Survey* in detail, while both full-time and part-time employees have continued to increase, the growth in part-time employees, in particular, has accelerated since around the end of 2006, resulting in a rise in the ratio of part-time employees from the previous year (Charts 24[1] and [2]).

Nominal wages per employee have remained somewhat lackluster (Chart 22[1]). The year-on-year rate of change in regular payments has stayed slightly positive, since they have been held down by the retirement of the high-wage-earning baby-boomers and by an increase in the hiring of relatively low-wage-earning new graduates under a situation in which firms have persisted in labor cost restraints.¹¹

¹⁰ New job offers have been on a downtrend since autumn 2006, largely due to the moves by Labour Bureaus across Japan to promote appropriate posting by deterring overstatements in the number of job offers. Nevertheless, the number of job advertisements listed in the media of the private sector has been increasing steadily (Chart 23[3]).

¹¹ The retirement of baby-boomers has started to increase since the second half of 2006. To compensate for the loss of the labor force, an increasing number of new graduates has been hired, and some workers of the baby-boom generation themselves have been rehired at lower compensation. A combination of these factors seems to have exerted downward pressure on year-on-year changes in wages per person. However, with the rise in the number of retiring baby-boomers coming to a halt, negative contributions to wages are expected to become smaller.

Both the rise in the ratio of part-time workers—whose wage levels are low—and the increasing number of part-timers working only short hours have pushed wages per person downward. These movements are possibly attributable to: (1) the aforementioned rehiring of baby-boomers

As for overtime payments, although they have remained on a moderate upward trend, the pace of increase has slowed lately. Meanwhile, winter bonuses (special payments in November-January) continued to decline following the decrease in summer bonuses (special payments in June-August). 12

Looking ahead, the gradual increase in household income is likely to continue because the labor shortage will persist and corporate profits are expected to remain generally high.

2. Prices

Import prices (on a yen basis; the three-month rate of change) have increased, mainly due to the rise in crude oil prices, although the pace of increase slowed in January primarily due to the yen's appreciation (Chart 26). Looking at recent developments in international commodity prices in more detail, crude oil prices have continued to be strong partly due to the influx of speculative funds. Prices of crops such as wheat have also continued to increase, due to the ongoing rise in global demand such as that for alternative energy sources and to the adverse weather in major production centers. Prices of nonferrous metals had been softening since fall last year, due to concerns over a slowdown in the U.S. economy, but they have recently rebounded. Meanwhile, domestic commodity prices have been high, reflecting developments in international commodity prices.

with reduced working hours and days, and (2) the hiring of the elderly and women through various forms of employment aimed at easing the labor shortage. In fact, the labor force participation rates of men age 55-64—including the baby-boom generation—and a wide range of women seem to have trended upward.

¹² Winter bonuses (special payments in November-January) in the *Monthly Labour Survey* dropped by 2.8 percent on a year-on-year basis; they posted a sizeable decline even compared to that of summer bonuses (a decline of 2.4 percent in special payments for June-August). This weakness was possibly attributable to: (1) downward pressure caused by the retirement of the baby-boom generation and by the rise in the ratio of part-time workers on special payments was larger than that on regular payments and (2) sluggish profits induced by the rise in materials prices forced small and medium-sized firms to restrain bonuses somewhat strongly.

The three-month rate of change in domestic corporate goods prices (adjusted to exclude the effects of seasonal changes in electricity rates, same hereafter)¹³ has been positive, mainly due to the rise in international commodity prices (Chart 27). In detail, prices of "goods sensitive to exchange rates and overseas commodity prices" have been on the rise due to the upsurge in prices of petroleum and coal products. Prices of "other materials" have continued to increase mildly, notably in prices of chemical products and plastic products, mainly as a result of high material costs to date. Prices of "others" have edged up, aided by the rise in prices of processed Prices of "iron and steel and construction goods" have climbed foodstuffs. moderately due to the rise in prices of scrap and waste. Prices of "electric power, gas and water" have also increased. Meanwhile, prices of "machinery" have been flat lately. Looking at domestic demand products as a whole including imports, prices of raw materials and of intermediate goods have risen, mainly in petroleum-related products. Final goods prices have been flat lately as a whole, since prices of domestic products have risen reflecting movements in prices of petroleum products and processed foodstuffs while prices of imports have fallen.

The year-on-year rate of change in <u>corporate services prices</u> (excluding external factors)¹⁴ has been moving around zero percent recently (Chart 28).¹⁵ Looking at recent developments by category, the year-on-year changes in prices of "other services" have been positive since spring last year, reflecting improvements in supply-demand conditions as well as increases in costs such as labor costs. Moreover, prices of real estate services have continued to move up, assisted by the rise in office space rental against the background of improved supply-demand conditions of office spaces in the Tokyo metropolitan area. Prices of information

¹³ The figures are adjusted to exclude a large seasonal fluctuation in electric power charges to observe the underlying changes in domestic corporate goods prices. Industrial and commercial electric power charges are set relatively high during July-September, when consumption increases substantially.

¹⁴ "Excluding external factors" means that international air passenger transportation, ocean liner, ocean tramper, ocean tanker, oceangoing ship chartering services, and international air freight transportation are excluded from all items.

¹⁵ All items, including external factors, had continued to increase at a pace slightly faster than 1 percent on a year-on-year basis since April last year, but the growth rate has recently slowed somewhat. This is largely attributable to the moderation in oceangoing ship chartering services and ocean freight transportation in reaction to the upsurge caused by the rapid tightening of supply-demand conditions in shipping capacity last year.

services have continued to increase as a trend, albeit with some fluctuations, due to tightening supply-demand conditions as a result of active software investment by firms. On the other hand, prices of advertising services have been somewhat weak, since firms have been cautious about increasing advertisement placements. Meanwhile, prices of communications and broadcasting services have continued to fall, due to the reduction in cellular phone services charges. Prices of leasing and rental have also been declining, affected by the drop in prices of office automation equipment leasing.

The year-on-year rate of increase in <u>consumer prices</u> (excluding fresh food, same hereafter) has been rising since around the end of last year, due to the increase in prices of petroleum products and food products (Chart 29). Looking at recent developments in more detail, prices of goods have increased at a faster pace on a year-on-year basis, chiefly in petroleum products and food products. Services prices have climbed at a modest pace, partly due to the increase in prices of services related to domestic duties, along with the ongoing moderate rise in prices of "eating out."

Domestic corporate goods prices are likely to continue increasing for the time being, primarily reflecting the rise in international commodity prices. The year-on-year rate of change in consumer prices is projected to follow a positive trend due to the rise in prices of petroleum products and food products in the short run and the positive output gap in the longer run.

3. Financial Developments

(1) Financial Markets

As for <u>interest rate developments in the money markets</u>, the overnight call rate (uncollateralized) has been at around 0.5 percent (Chart 30[1]). Regarding interest rates on term instruments, the Euroyen interest rate (TIBOR, 3-month) and FB rate (3-month) have been more or less flat on the whole (Chart 31[1]). Interest rates on Euroyen futures have been essentially flat on the whole, despite temporary increases (Chart 31[2]).

<u>Yields on 10-year government bonds</u> (newly issued 10-year JGB) had been more or less flat, but they have recently dropped to around 1.35 percent, mainly in response to developments in long-term interest rates in the United States and Europe (Chart 30[2]).

<u>Yield spreads between corporate bonds and government bonds</u> have been more or less flat on the whole, although the widening of spreads has been observed for some industries (Chart 33).

Stock prices have remained weak in response to unstable U.S. and European stock price movements. The Nikkei 225 Stock Average is moving at around 13,000 yen (Chart 34).

In the <u>foreign exchange market</u>, the yen's exchange rate against the U.S. dollar had been more or less level, but it has appreciated sharply from the end of February through early March, mainly due to growing concerns over an economic slowdown in the United States. The yen is currently being traded at around 103 yen to the U.S. dollar (Chart 35).

(2) Corporate Finance and Monetary Aggregates

<u>Credit demand in the private sector</u> has been more or less flat. Ample cash flow has slowed the increase in corporate demand for external funds.

Regarding <u>credit supply</u>, private banks have remained accommodative in their loan provision. Related DIs of business surveys, which have been at their mid-1990s levels, indicate that firms have perceived the lending attitudes of financial institutions as accommodative. Nevertheless, those of small and medium enterprises have become slightly less accommodative (Chart 36).

<u>Lending rates</u> have been at extremely low levels on the whole. The average contracted interest rates on new loans and discounts, with the monthly fluctuations smoothed out, have been more or less unchanged (Chart 37).

The <u>amount outstanding of lending by private banks</u> has continued to increase at a moderate pace. Its monthly average outstanding, after adjustment, ¹⁶ grew by 1.1 percent in January on a year-on-year basis, compared to 0.8 percent in December and 1.3 percent in November (Chart 38).

In the <u>corporate bond and CP</u> markets, the issuing environment continues to be favorable as a whole. Issuance spreads on corporate bonds and CP issued by firms with low credit ratings have expanded slightly, while they have remained tight chiefly for firms with high credit ratings. The <u>amount outstanding of CP and corporate bonds issued</u> has been above the previous year's level. It increased by 3.9 percent in January, on a year-on-year basis, compared to 3.8 percent in December and 4.5 percent in November (Chart 39).

According to business surveys, the <u>financial positions</u> of firms have continued to be favorable as a whole, although those of small and medium enterprises have deteriorated slightly (Chart 36).

The <u>money stock</u> $(M_2 + CDs)$ has increased by around 2 percent annually. Its January reading was 2.1 percent on a year-on-year basis, following 2.1 percent in December and 2.0 percent in November (Chart 40).

The <u>number of corporate bankruptcies</u> was up by 7.6 percent in January compared to the year-ago level, to 1,174 cases (Chart 41).



(1) Real GDP





(3) Indexes of Business Conditions (Composite Indexes)
















(1) Exports of IT-Related Goods (Real, Breakdown by Goods)







(2) Corporate Profits (Ratio of Profits to Sales) 1,2








(1) Large Manufacturing Firms




(2) Medium-Sized and Small Manufacturing Firms

(4) Medium-Sized and Small Nonmanufacturing Firms






Coincident Indicators for Business Fixed Investment

(2) Indices of Capacity Utilization and Production Capacity DI







(2) Construction Starts (Floor Area, Private, Nondwelling Use)











(1) Indices of Aggregated Sales (Real)



(2) Aggregate Supply of Consumer Goods






Indicators for Housing Investment





(2) Production by Industries




Shipments Breakdown by Type of Goods

(2) Breakdown of Final Demand Goods



Inventory Cycle






(1) Breakdown of Total Cash Earnings^{1,2,5}

(3) Employee Income^{1,3,4}






(1) Unemployment Rate and Ratio of Job Offers to Applicants






(1) Number of Employees³

(3) Non Scheduled Hours Worked (Monthly Labour Survey)¹










Import Prices and International Commodity Prices


(2) Import Price Index (Yen Basis, Changes from a Quarter Earlier and 3 Months Earlier)







Domestic Corporate Goods Price Index⁷






(1) Consumer Price Index (Excluding Fresh Food)





(1) Short-Term







(1) Interest Rates on Term Instruments




(2) Euroyen Interest Rates Futures (3-Month) ¹









(2) Yield Spread ^{2, 4}







(2) Lending Attitude of Financial Institutions as Perceived by Firms «Tankan¹» «Other Surveys»






(1) Lending by Domestic Commercial Banks¹


(2) Lending by Other Financial Institutions


(1) Amount Outstanding of Commercial Paper

(2) Amount Outstanding of Corporate Bonds (Changes from a Year Earlier)







(1) Changes from a Year Earlier




(2) Ratio of Money Stock to Nominal GDP




