3. Future treatment

In view of the considerable improvement in U.S. dollar funding conditions, the Bank of Japan, in cooperation with the Bank of England, the European Central Bank, and the Swiss National Bank, will phase out the offering of U.S. Dollar Funds-Supplying Operations from May 2014. The Bank of Japan will continue to conduct monthly three-month U.S. Dollar Funds-Supplying Operations until April 30, 2014, and weekly one-week U.S. Dollar Funds-Supplying Operations at least until July 31, 2014. It should be noted that standing liquidity swap arrangements introduced in October 2013 provide a framework for the reintroduction of U.S. Dollar Funds-Supplying Operations if warranted by market conditions.
