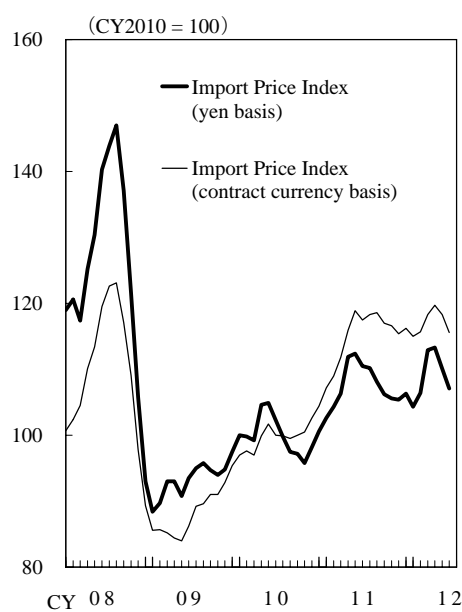
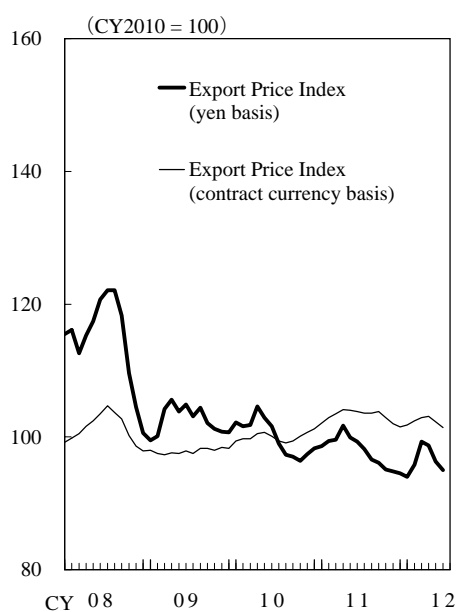
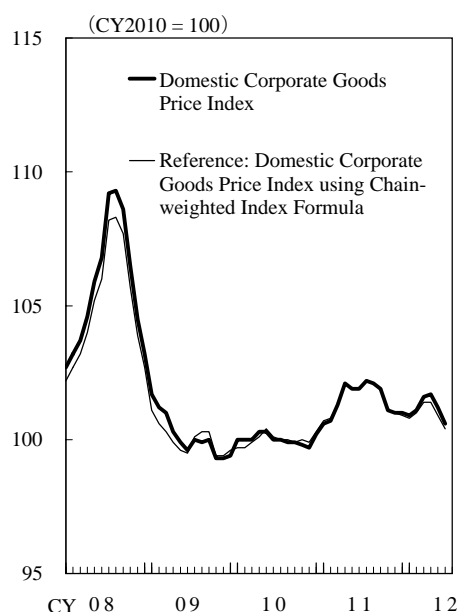
(Preliminary Figures for June 2012)

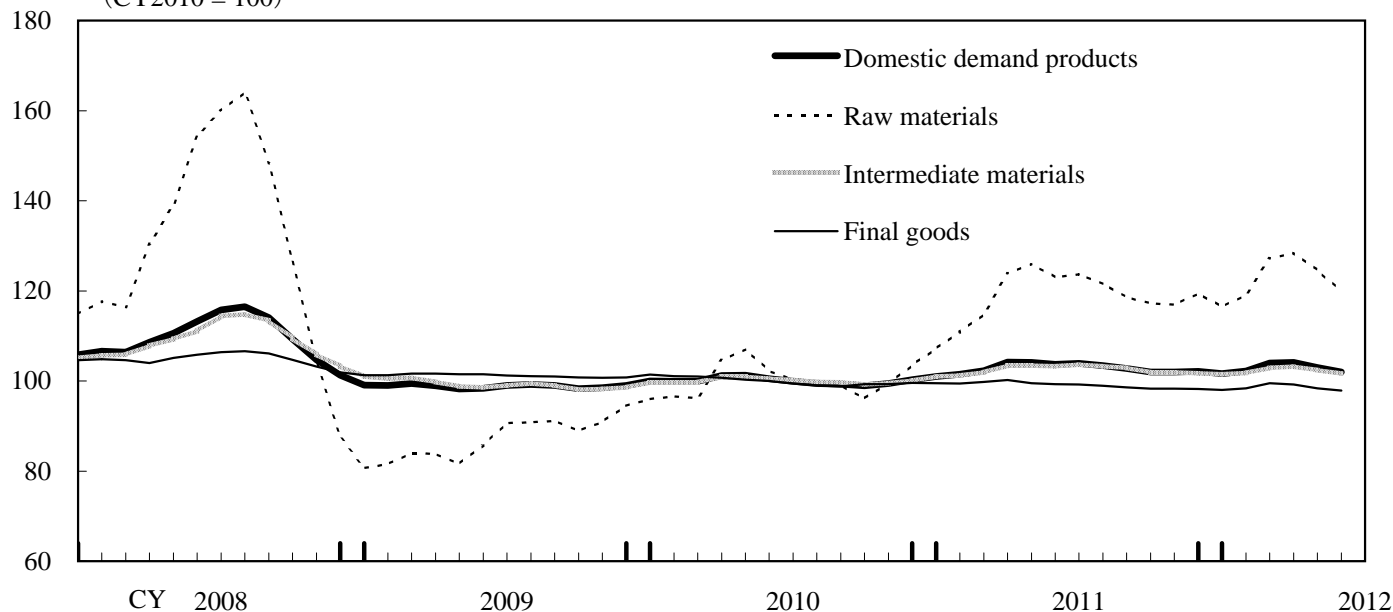
