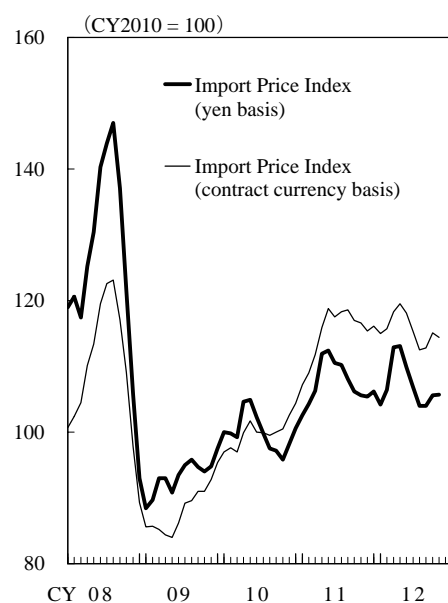
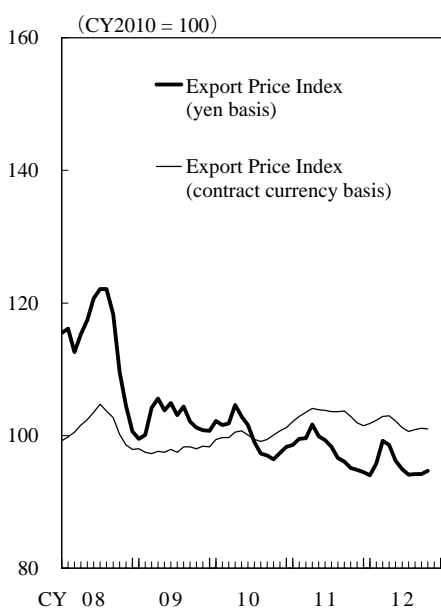
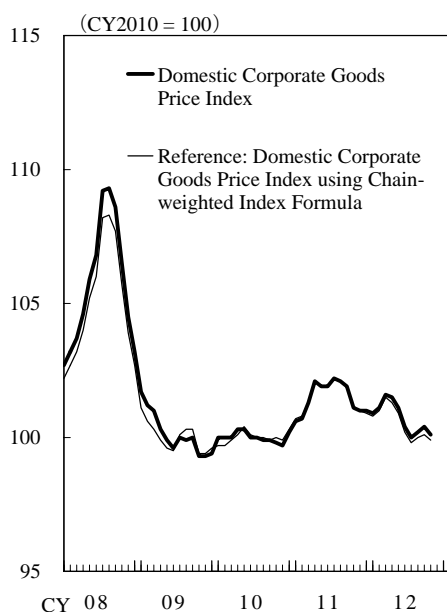
Monthly Report on the Corporate Goods Price Index (Preliminary Figures for October 2012)

- ❖ The Domestic Corporate Goods Price Index fell 0.3 percent from the previous month.
The index excluding extra charges for summer electricity fell 0.1 percent from the previous month.
- ❖ The Export Price Index (contract currency basis) fell 0.1 percent from the previous month.
- ❖ The Import Price Index (contract currency basis) fell 0.6 percent from the previous month.

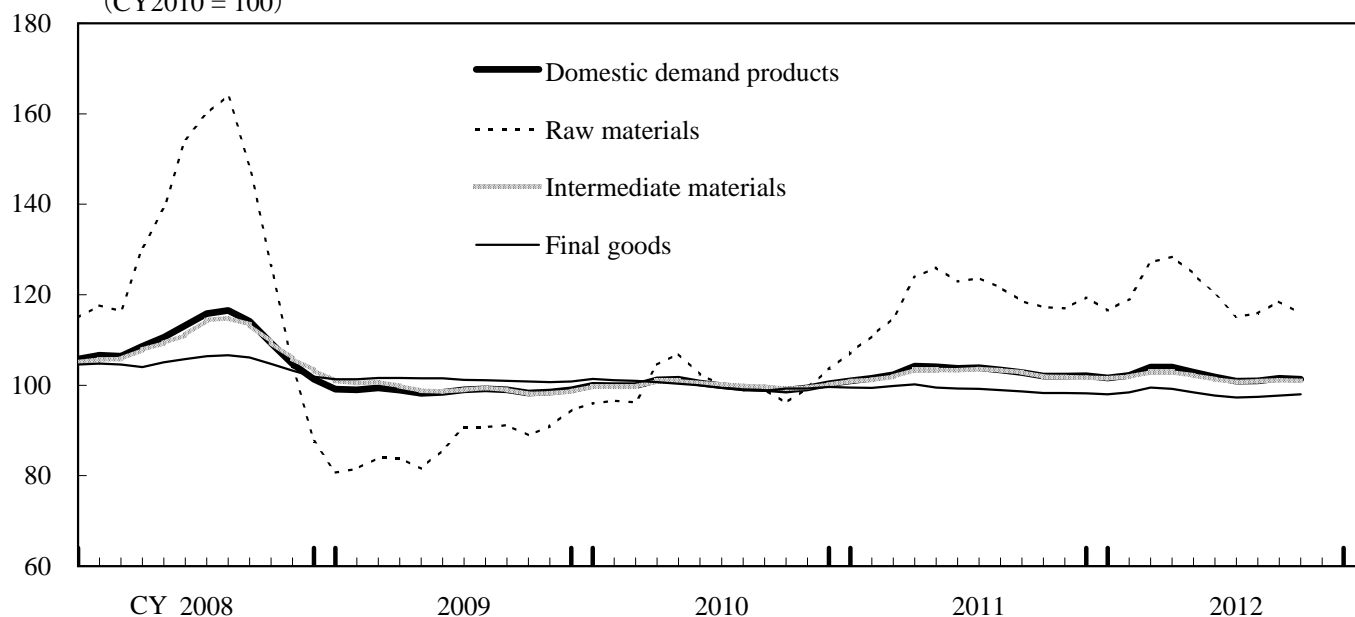
