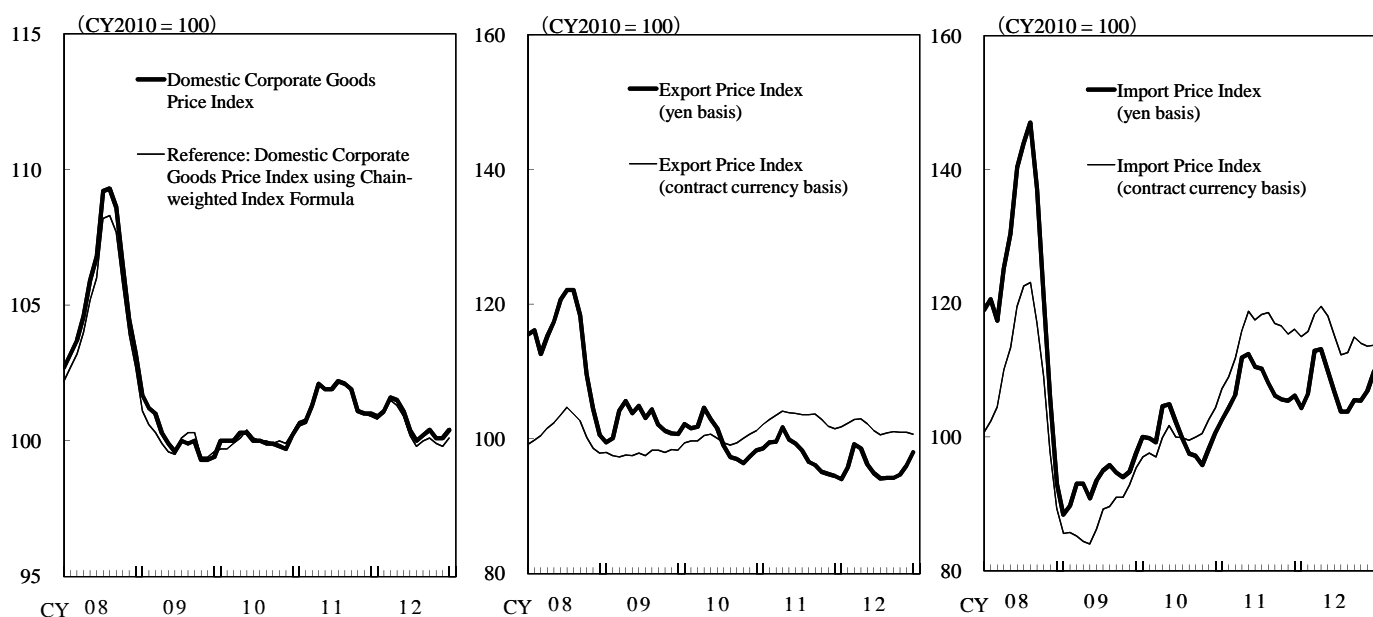
Monthly Report on the Corporate Goods Price Index (Preliminary Figures for December 2012)

- ❖ The Domestic Corporate Goods Price Index rose 0.3 percent from the previous month.
- ❖ The Export Price Index (contract currency basis) fell 0.3 percent from the previous month.
- ❖ The Import Price Index (contract currency basis) rose 0.1 percent from the previous month.

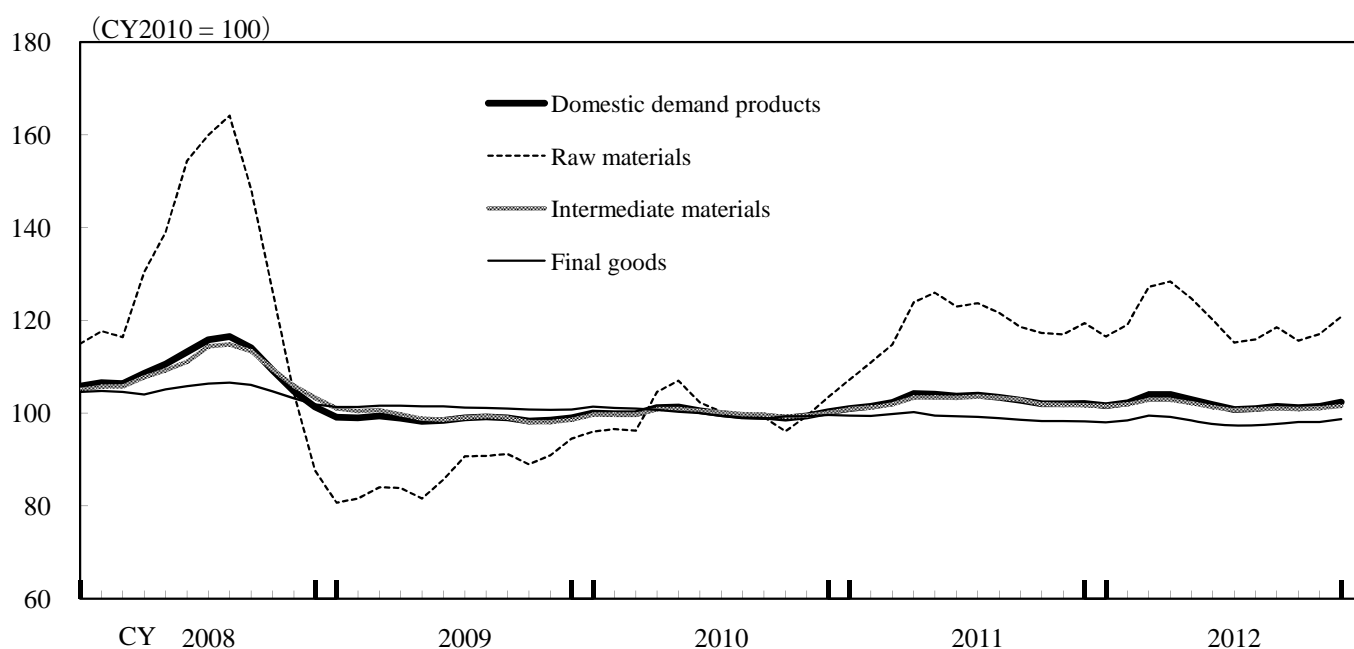
