## Monthly Report on the Corporate Goods Price Index

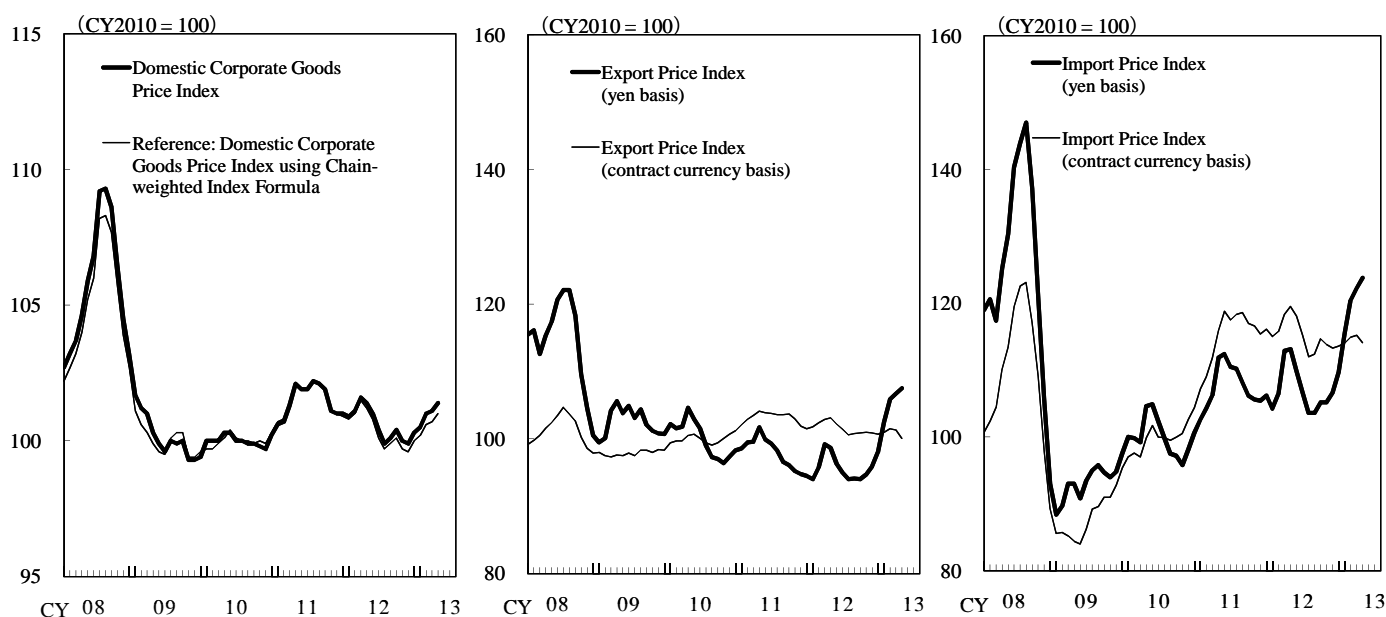
( Preliminary Figures for April 2013 )

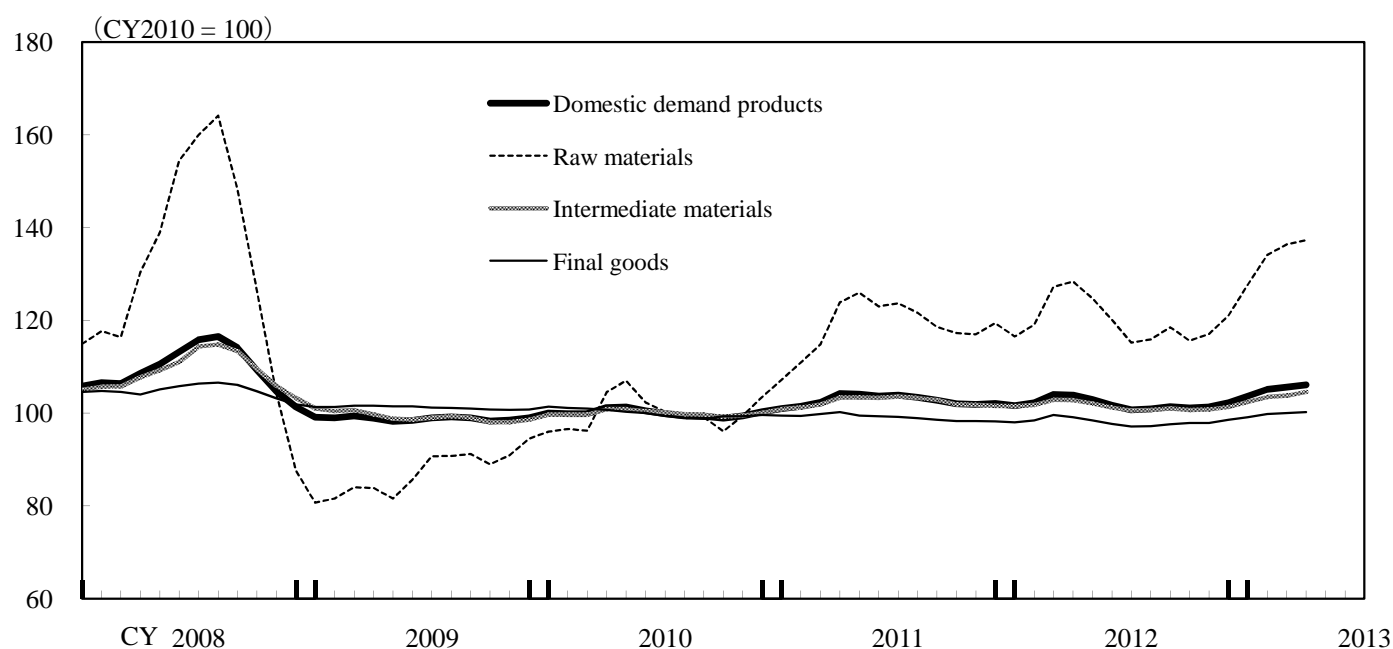
