## Monthly Report on the Corporate Goods Price Index

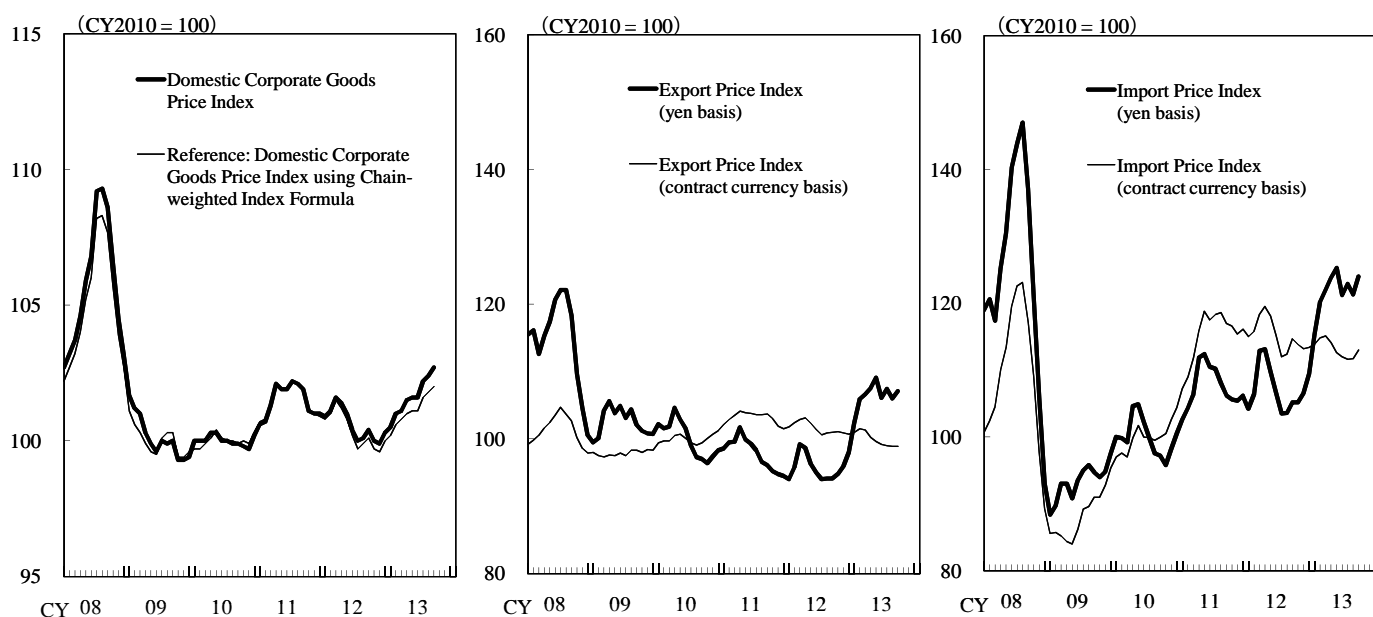
( Preliminary Figures for September 2013 )

- ❖ The Domestic Corporate Goods Price Index rose 0.3 percent from the previous month.
- ❖ The Export Price Index (contract currency basis) was unchanged from the previous month.
- ❖ The Import Price Index (contract currency basis) rose 1.2 percent from the previous month.

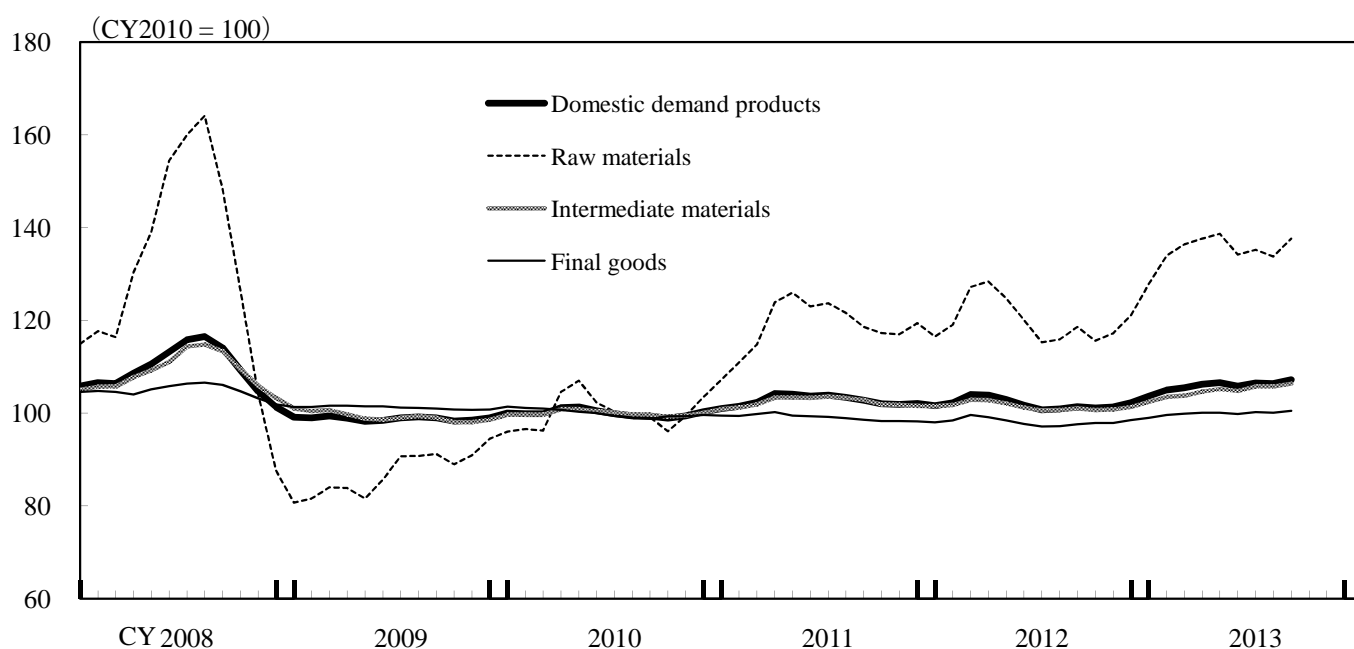
