Monthly Report on the Corporate Goods Price Index

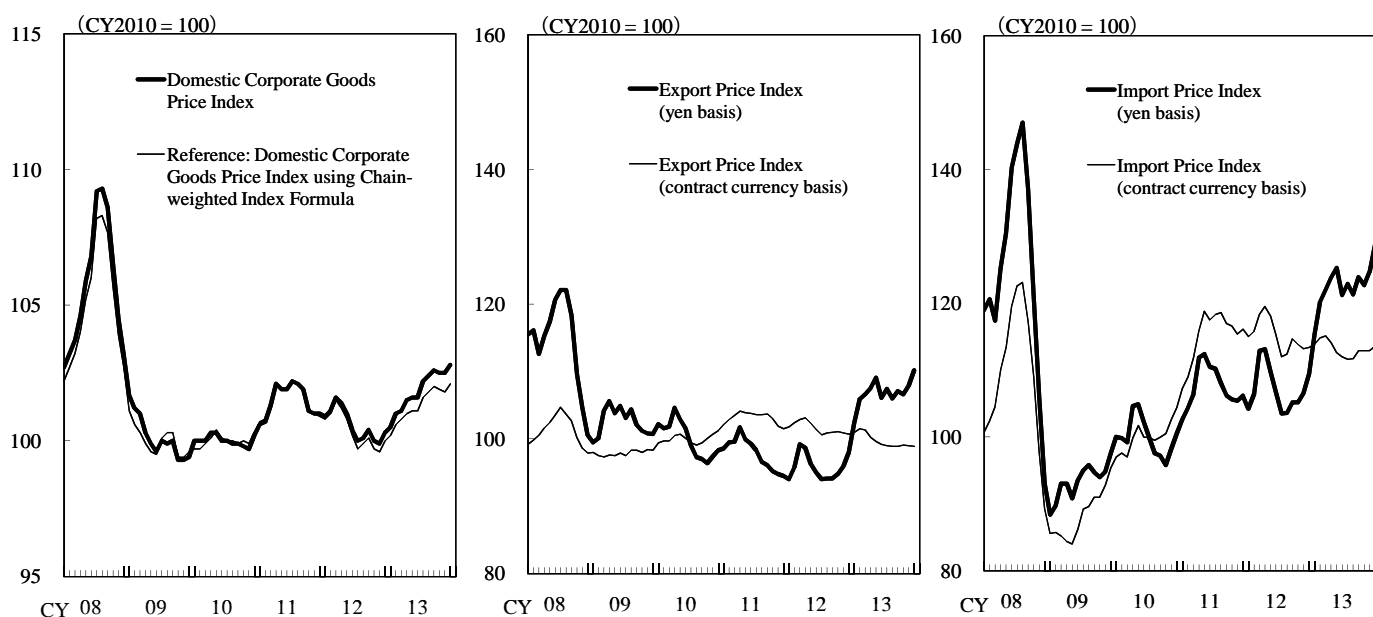
(Preliminary Figures for December 2013)

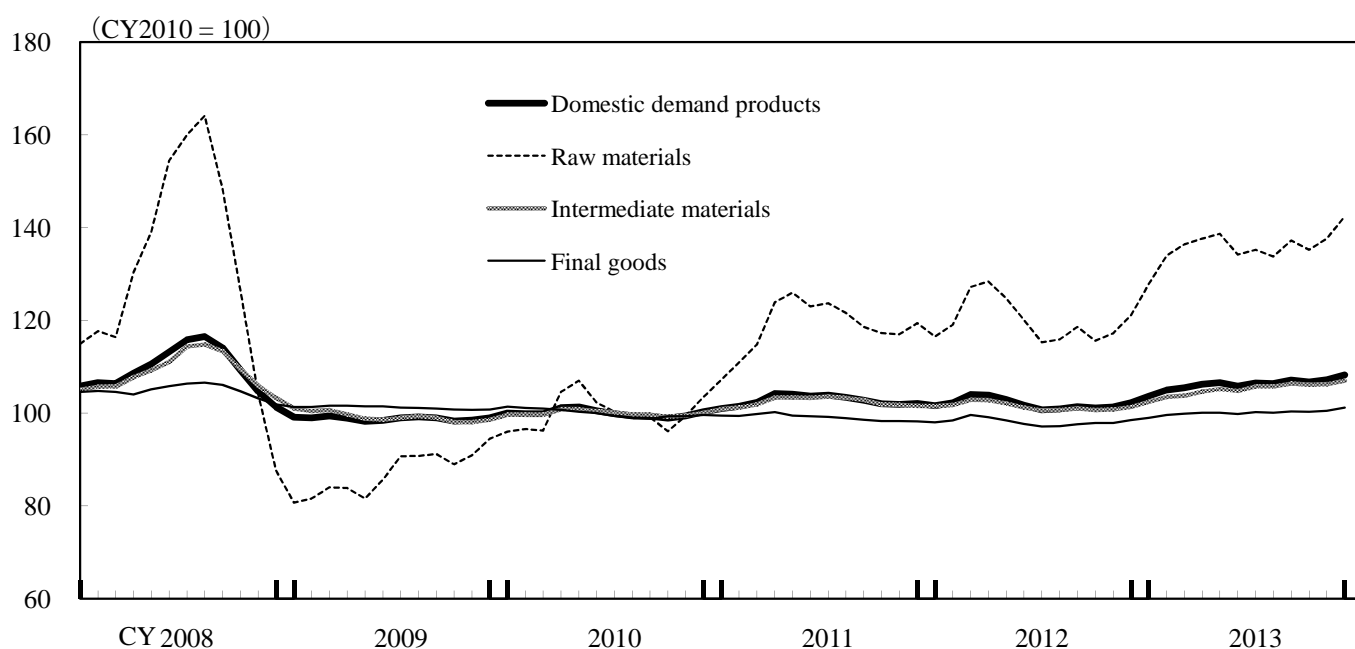
