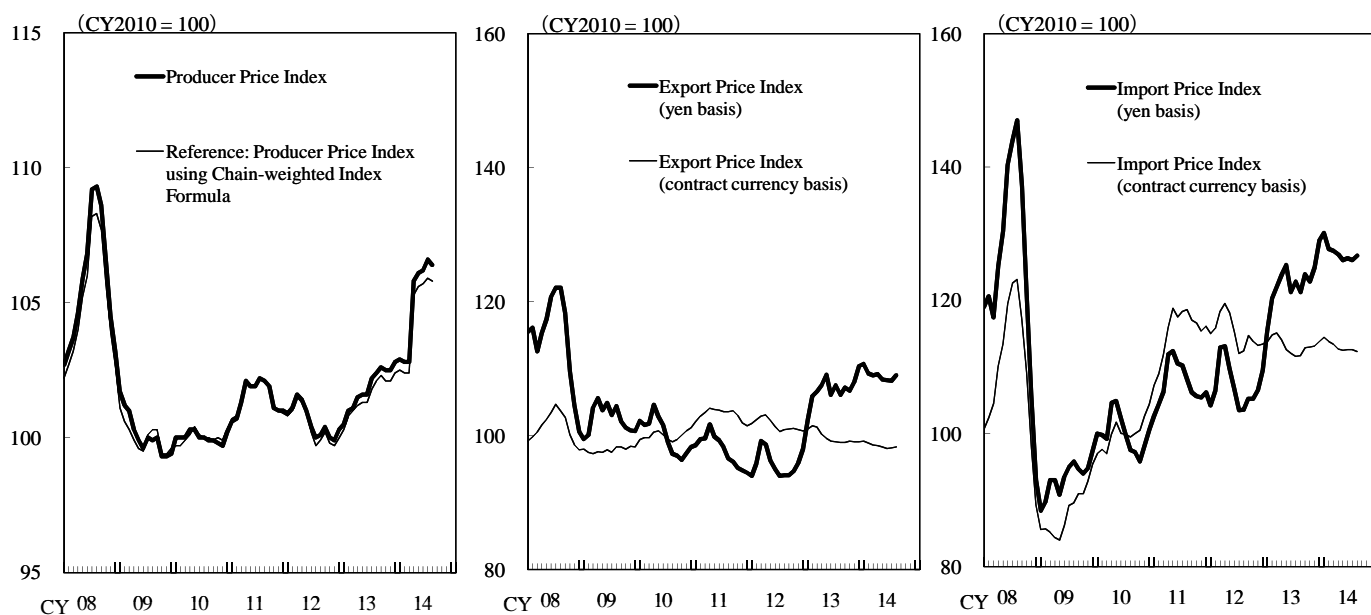
## Monthly Report on the Corporate Goods Price Index ( Preliminary Figures for August 2014 )

- ❖ The Export Price Index (contract currency basis) rose 0.1 percent from the previous month.
- ❖ The Import Price Index (contract currency basis) fell 0.3 percent from the previous month.

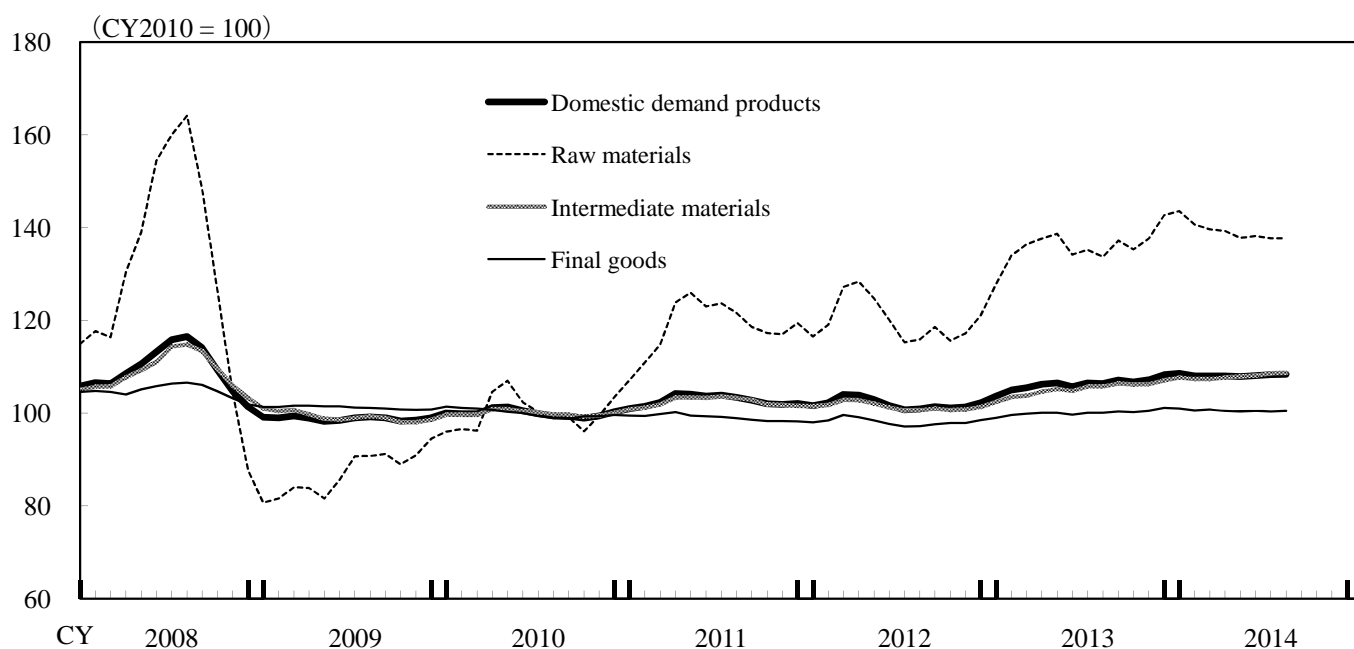
