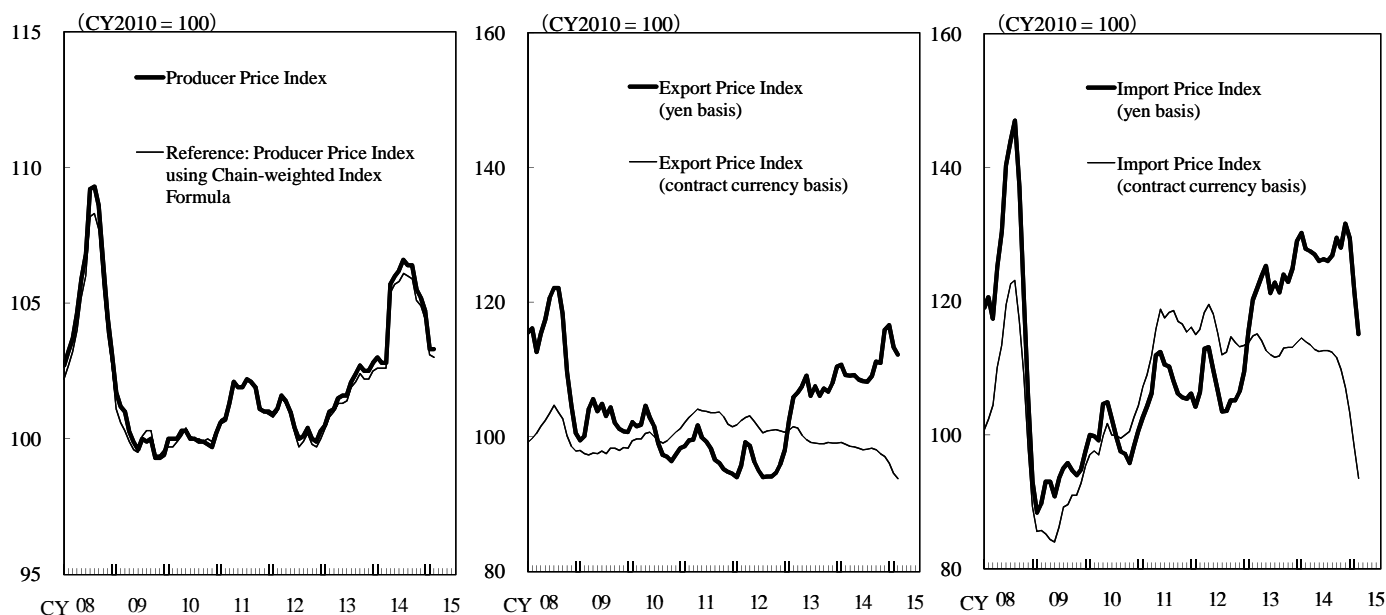
Monthly Report on the Corporate Goods Price Index (Preliminary Figures for February 2015)

- ❖ The Export Price Index (contract currency basis) fell 0.8 percent from the previous month.
- ❖ The Import Price Index (contract currency basis) fell 4.9 percent from the previous month.

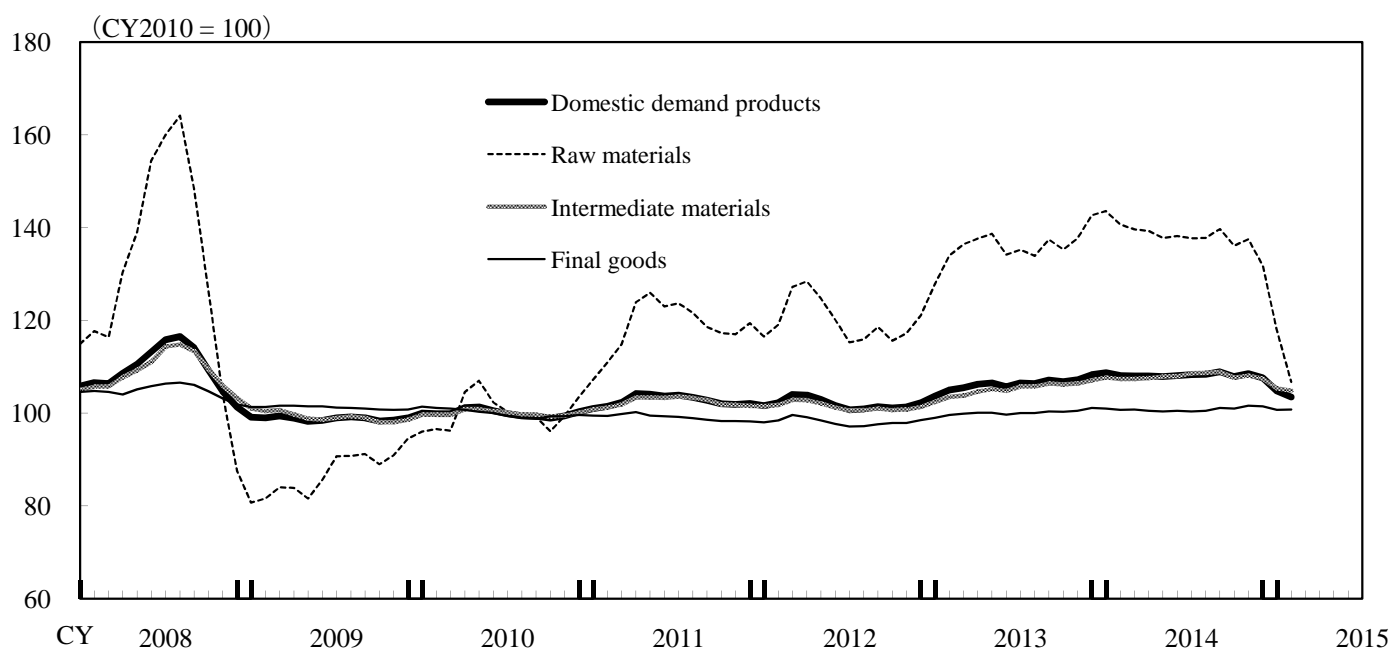
