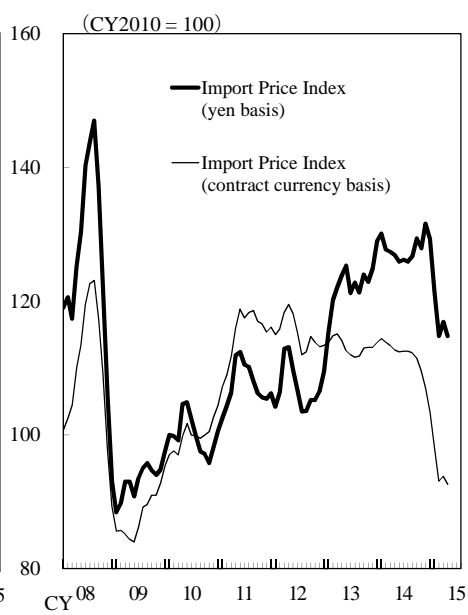
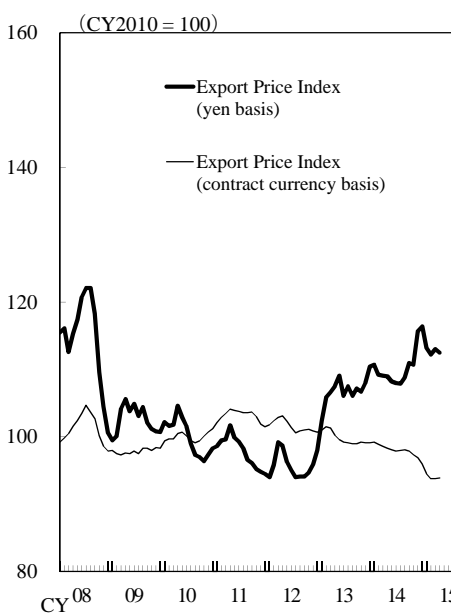
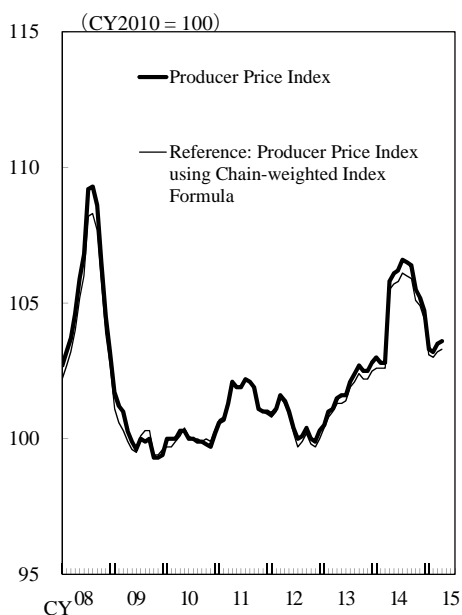
(Preliminary Figures for April 2015)

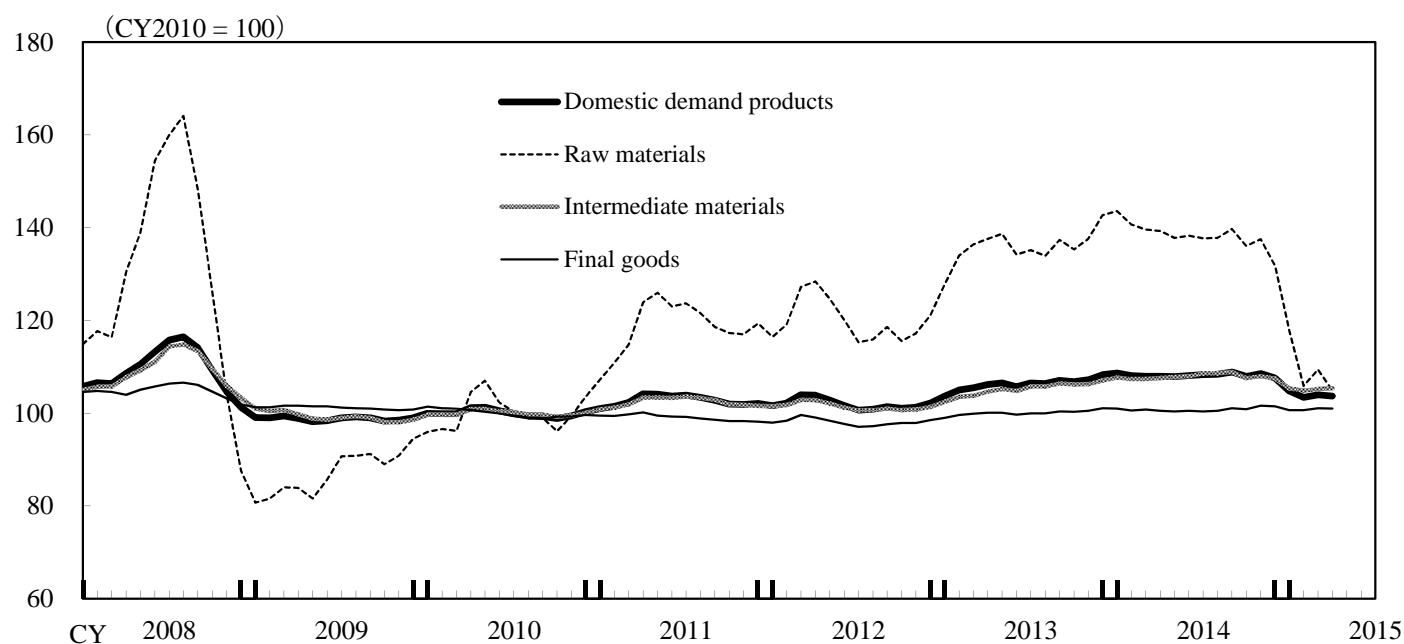
