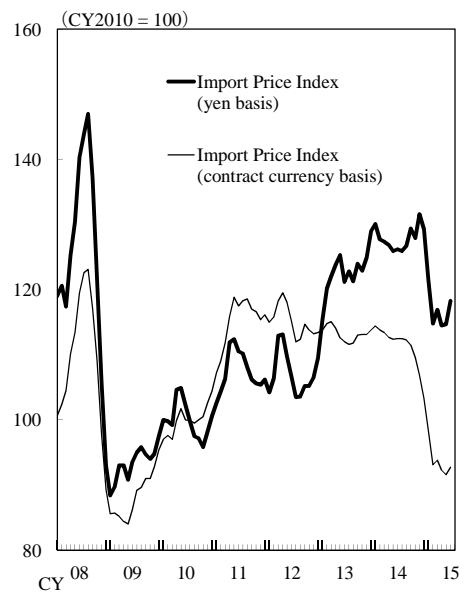
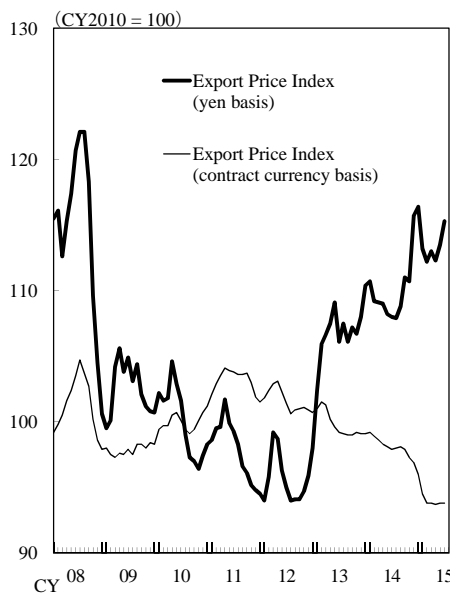
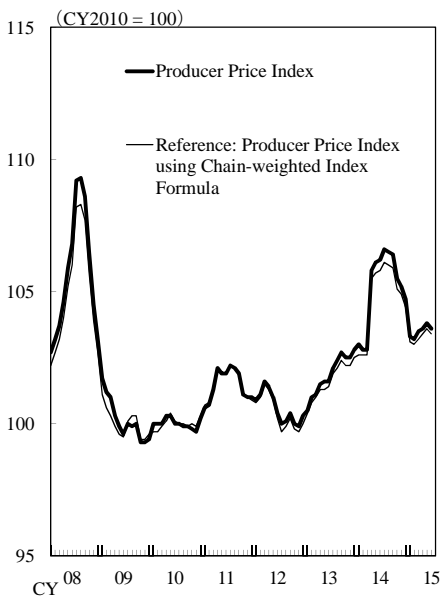
(Preliminary Figures for June 2015)

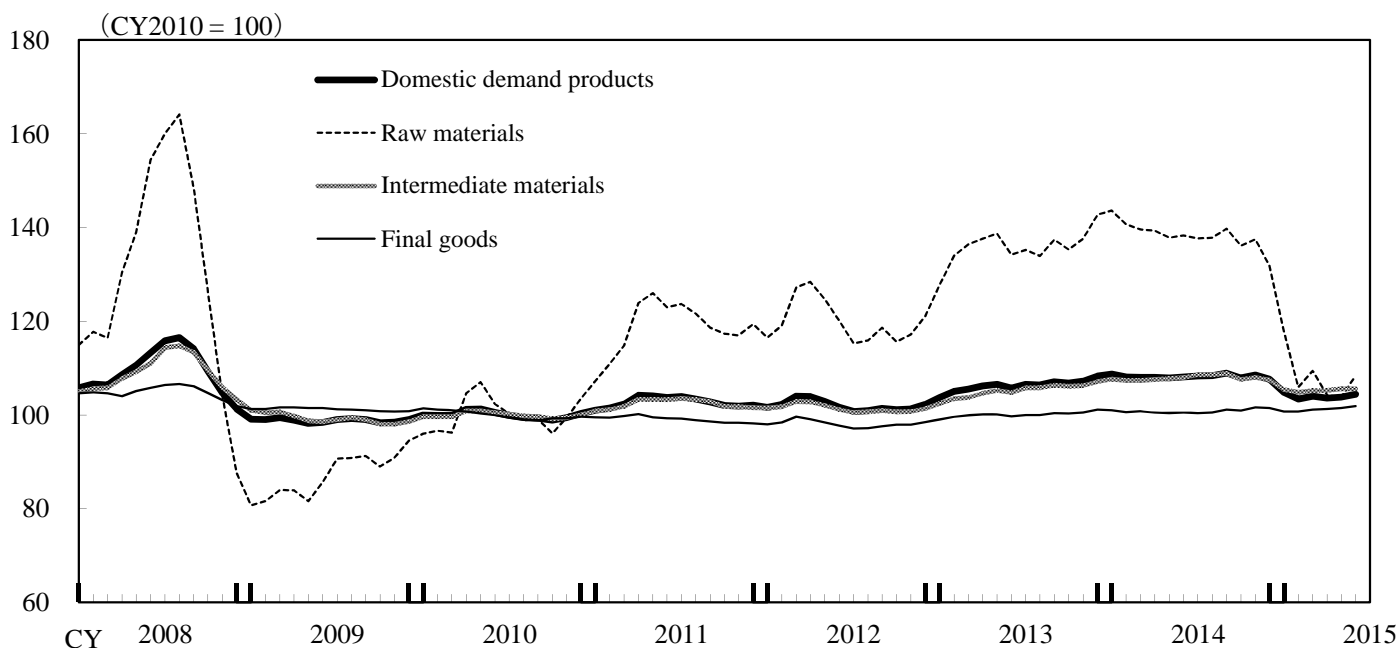
