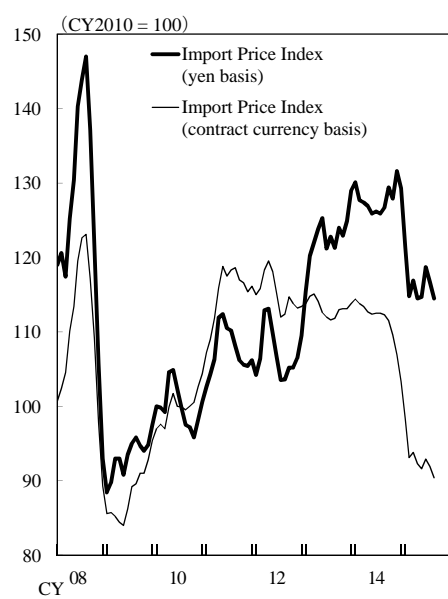
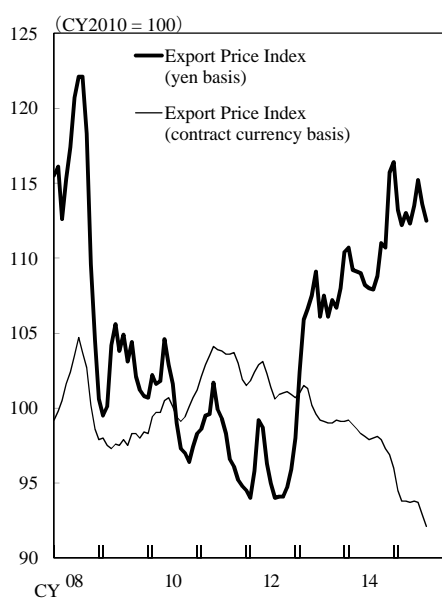
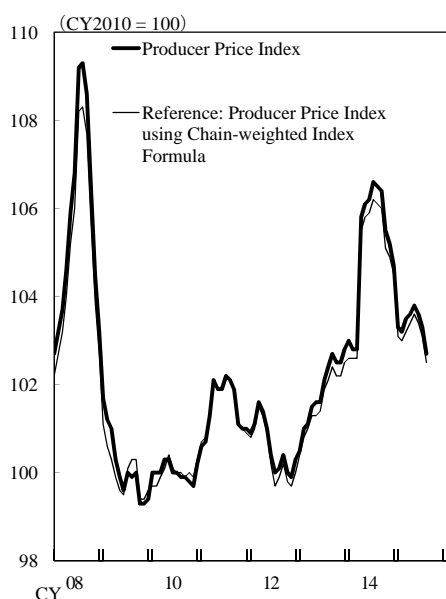
Monthly Report on the Corporate Goods Price Index (Preliminary Figures for August 2015)

- ❖ The Import Price Index (contract currency basis) fell 1.6 percent from the previous month.

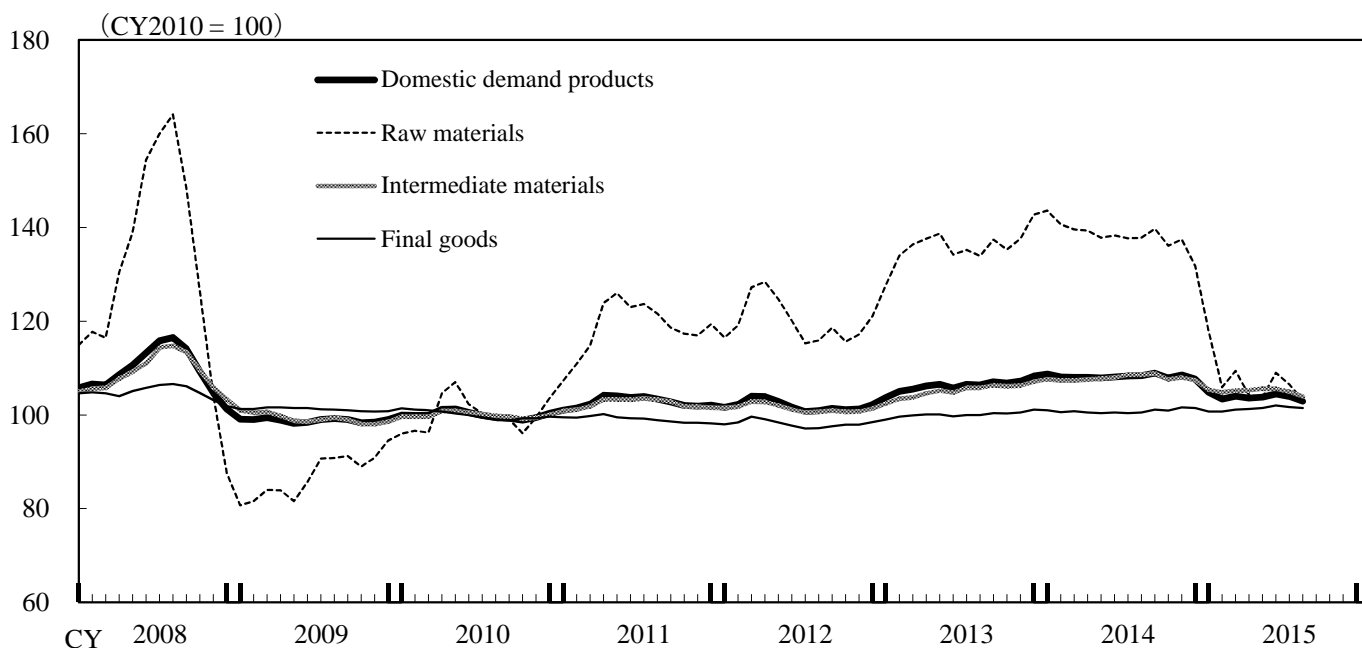
