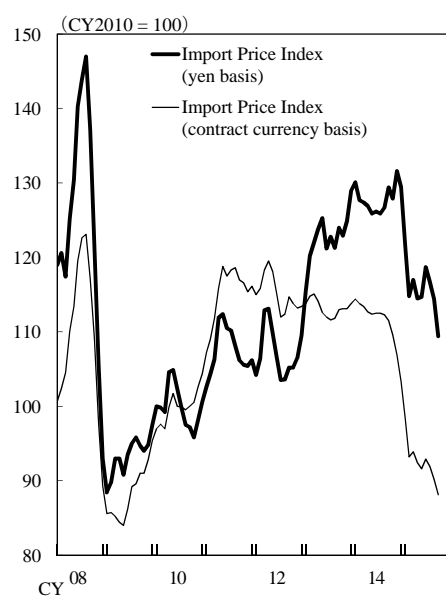
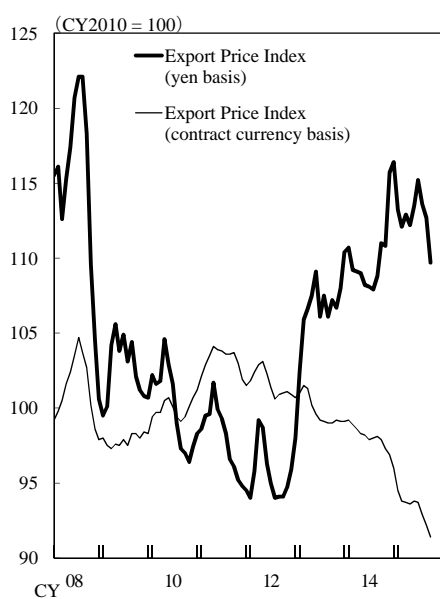
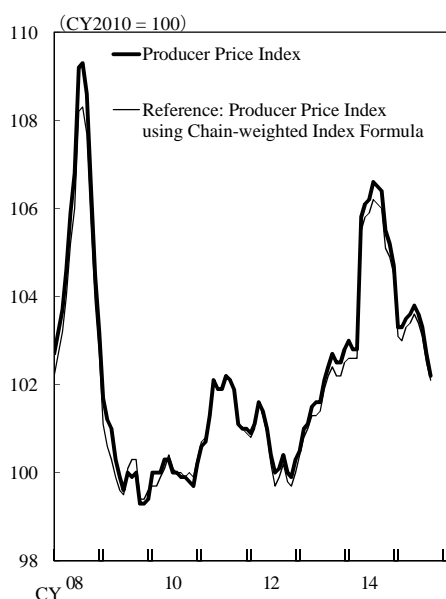
Monthly Report on the Corporate Goods Price Index (Preliminary Figures for September 2015)

- ❖ The Export Price Index (contract currency basis) fell 0.9 percent from the previous month.
- ❖ The Import Price Index (contract currency basis) fell 2.3 percent from the previous month.

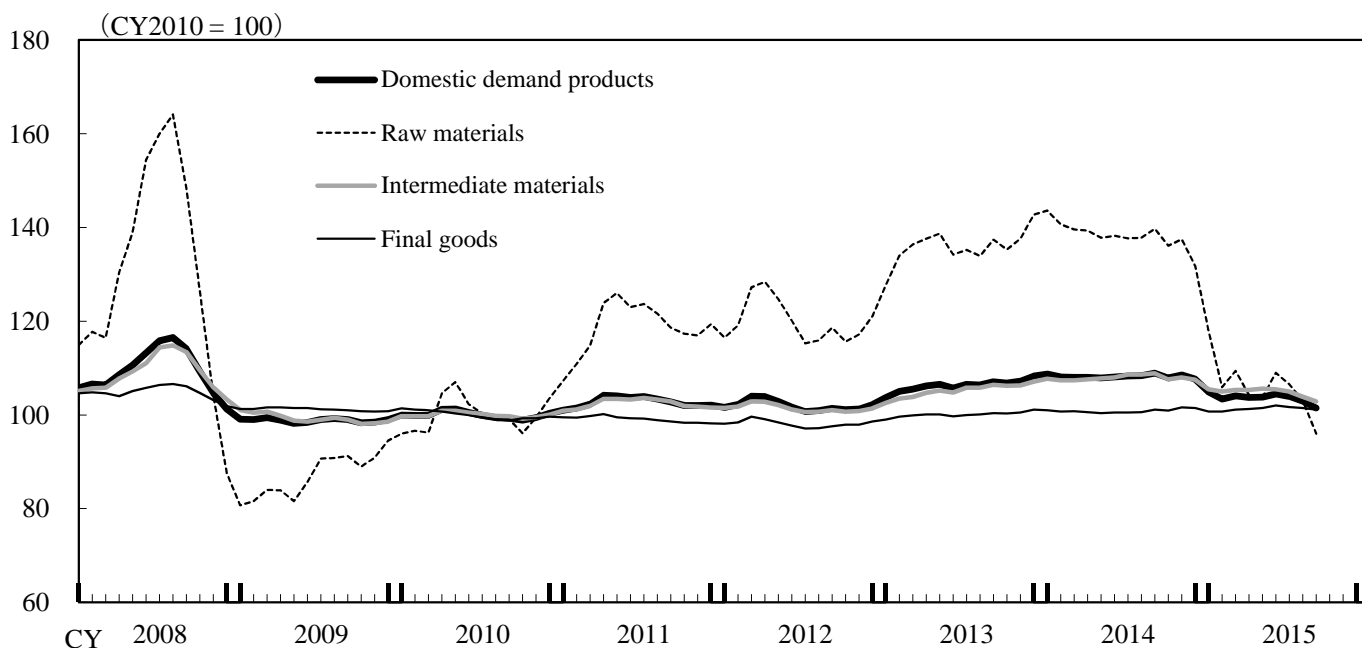
