## Monthly Report on the Corporate Goods Price Index

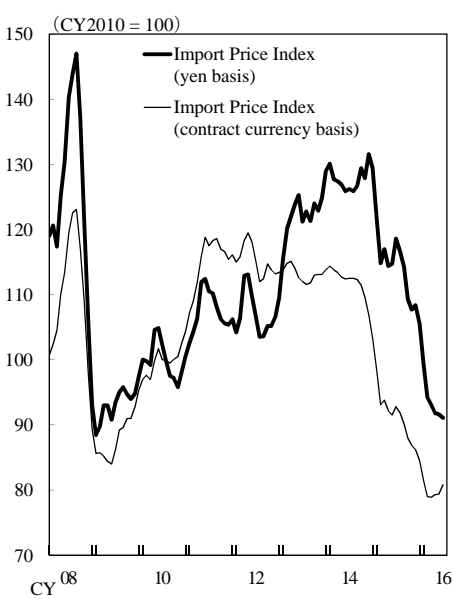
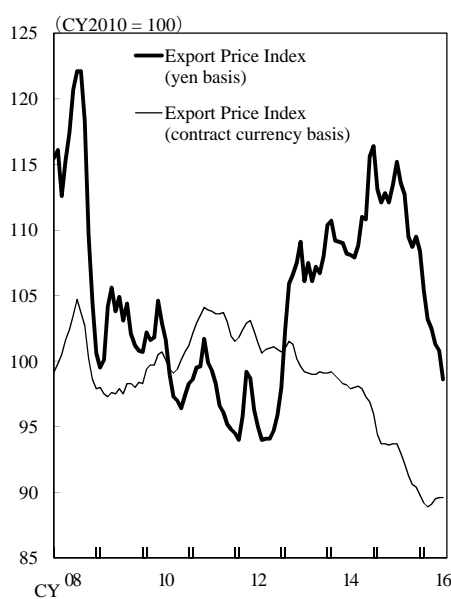
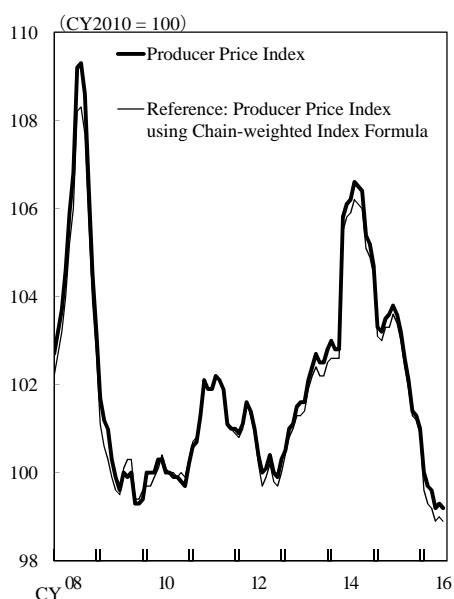

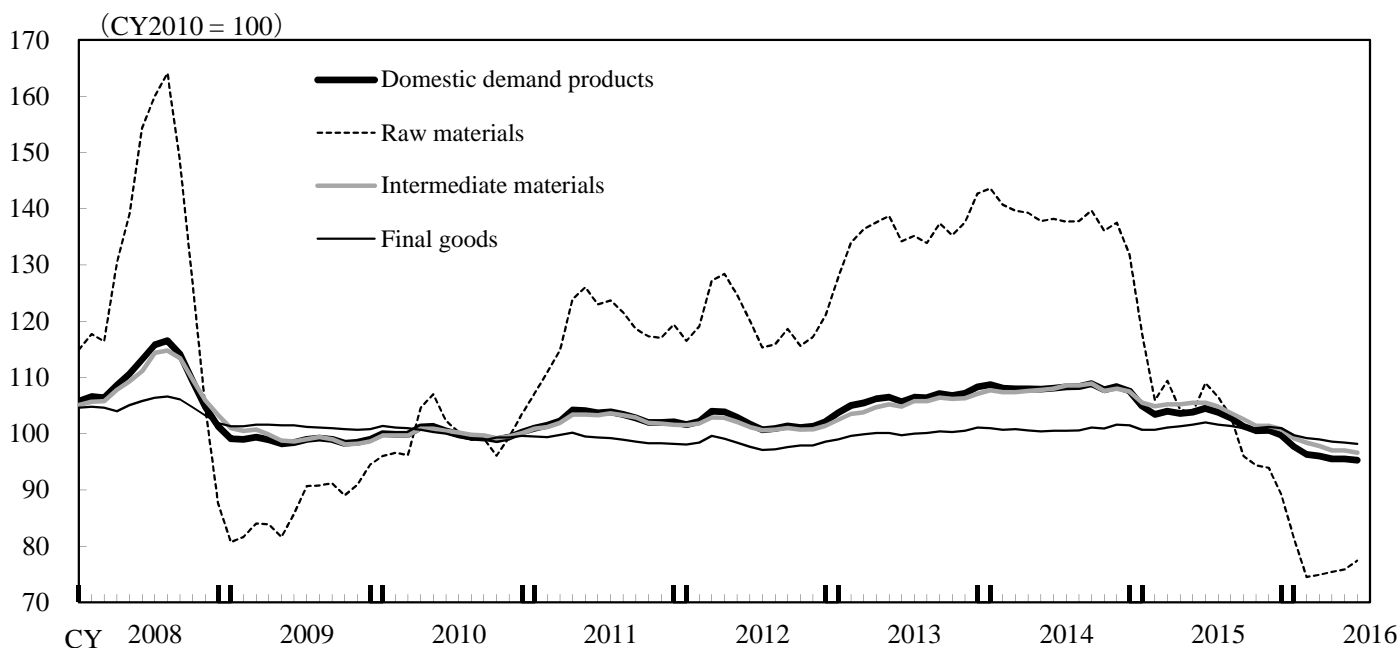
