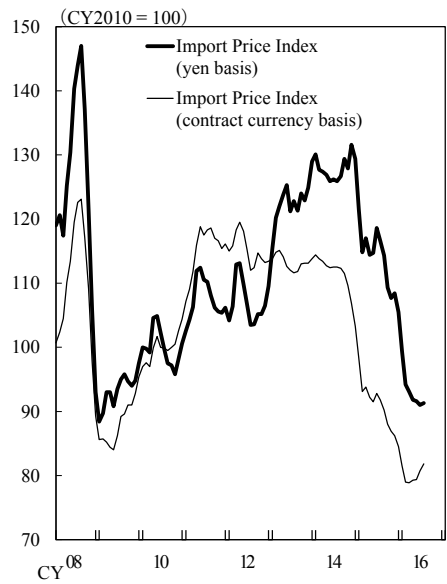
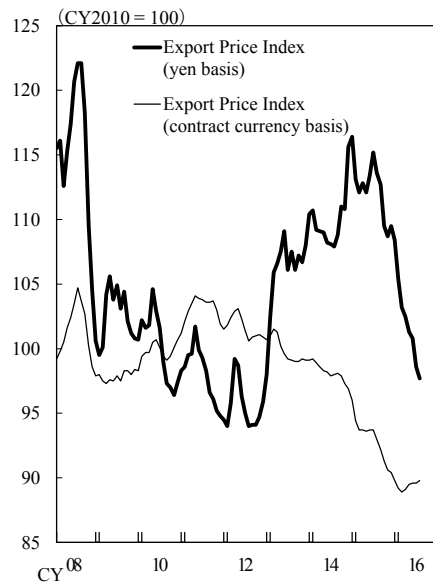
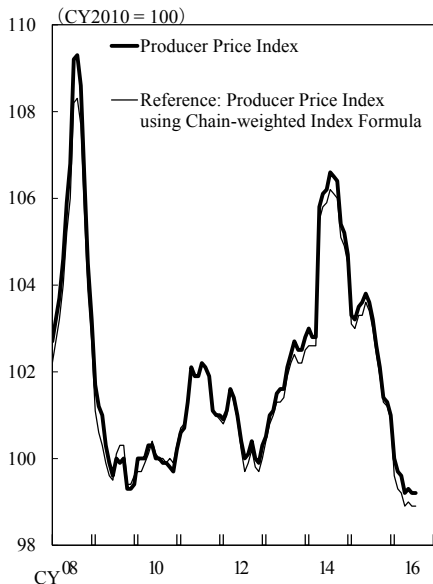
Monthly Report on the Corporate Goods Price Index (Preliminary Figures for July 2016)

- ❖ The Producer Price Index was unchanged from the previous month.
The index excluding extra charges for summer electricity fell 0.3 percent from the previous month.
- ❖ The Export Price Index (contract currency basis) rose 0.2 percent from the previous month.
- ❖ The Import Price Index (contract currency basis) rose 1.4 percent from the previous month.

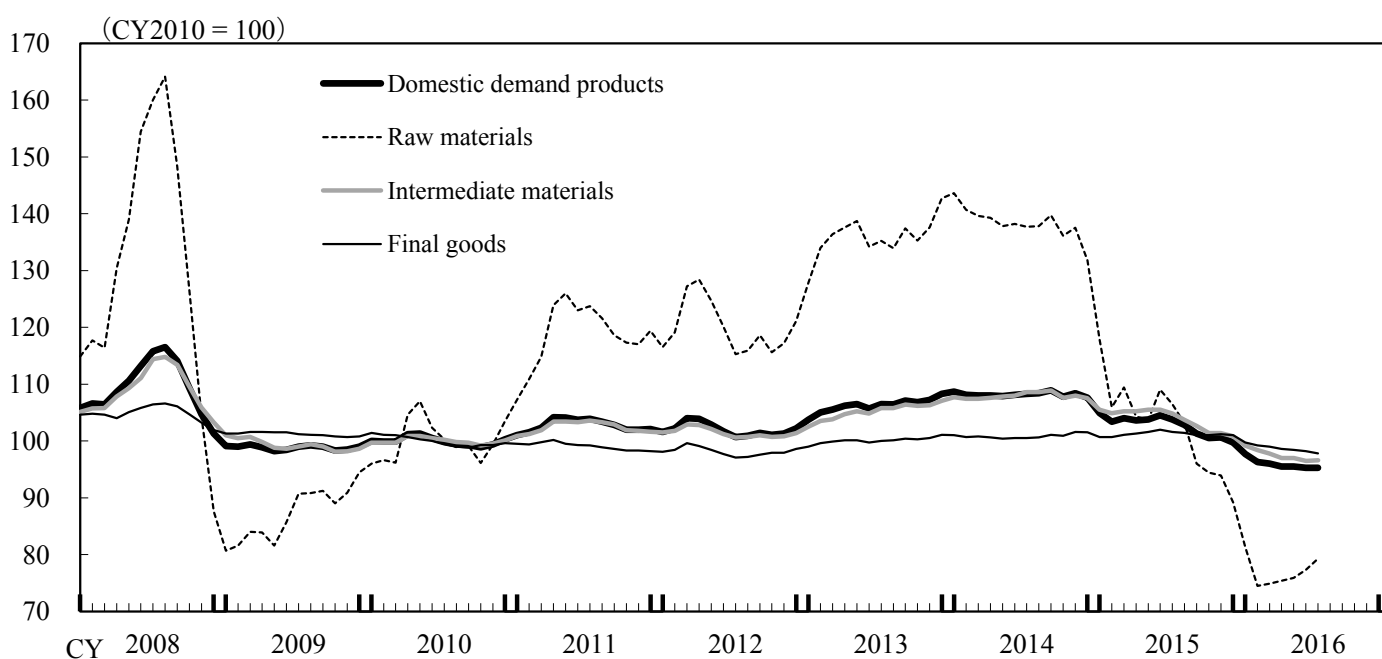
