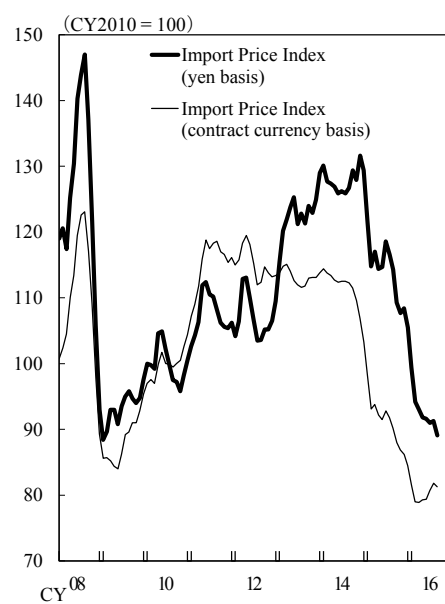
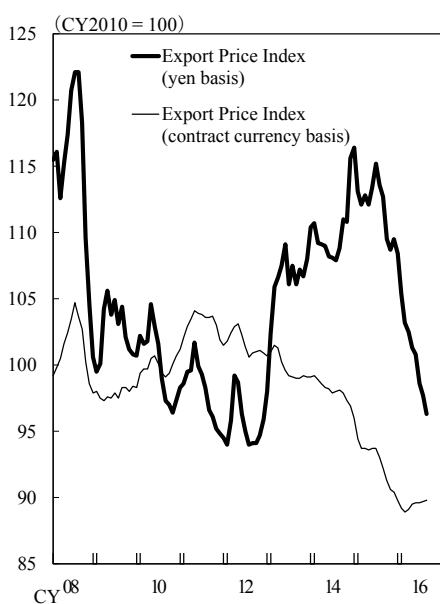
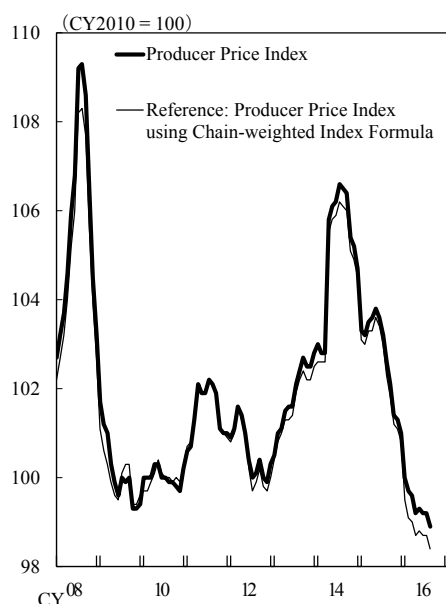
Monthly Report on the Corporate Goods Price Index (Preliminary Figures for August 2016)

- ❖ The Export Price Index (contract currency basis) rose 0.1 percent from the previous month.
- ❖ The Import Price Index (contract currency basis) fell 0.6 percent from the previous month.

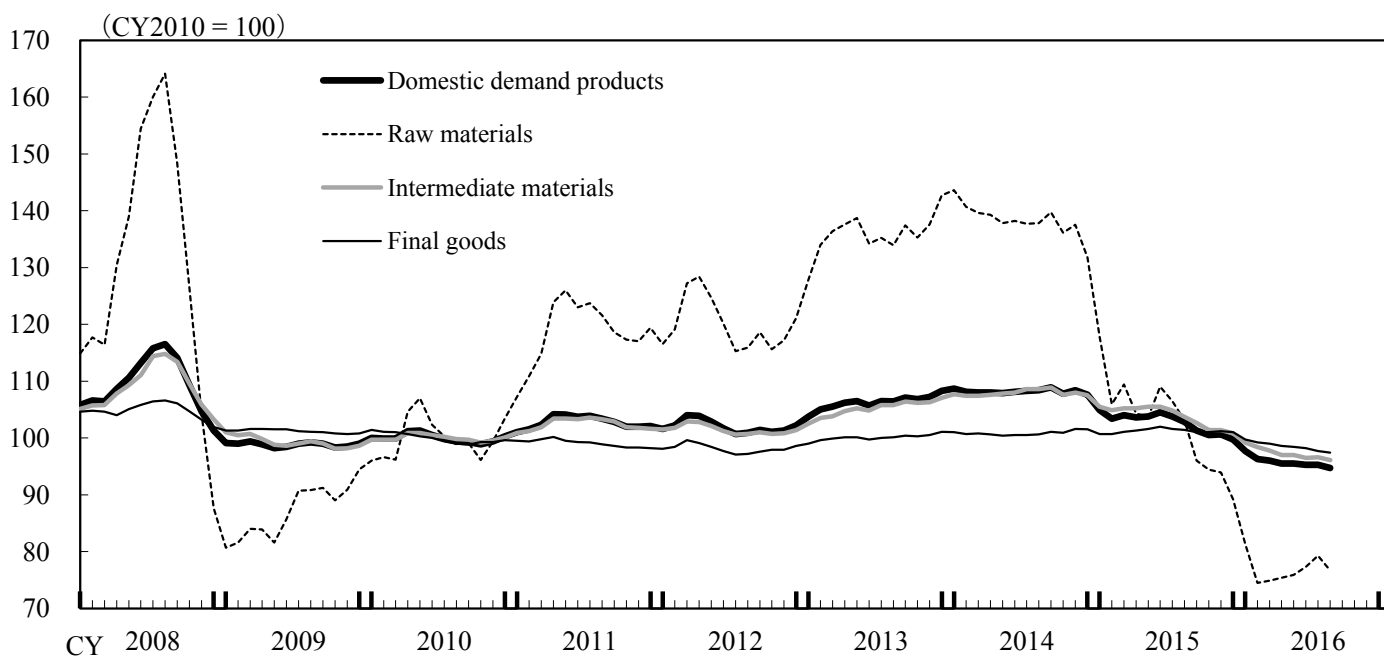
