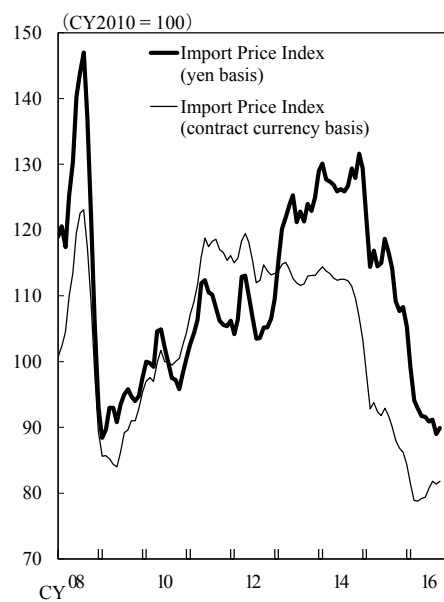
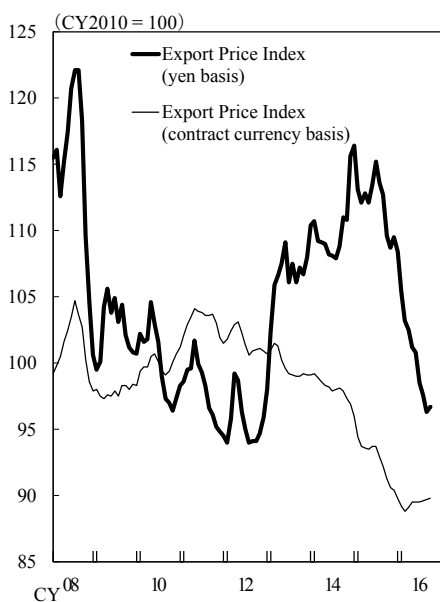
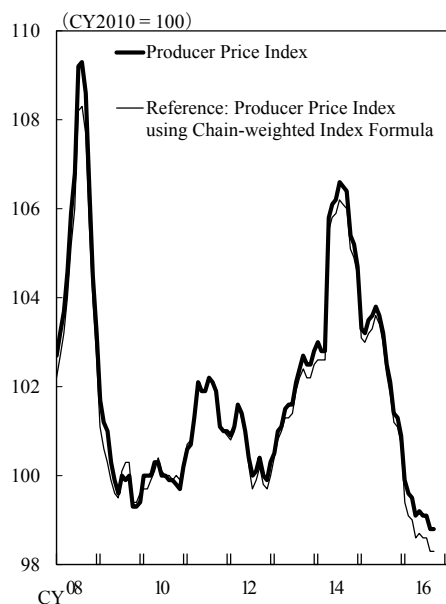
Monthly Report on the Corporate Goods Price Index (Preliminary Figures for September 2016)

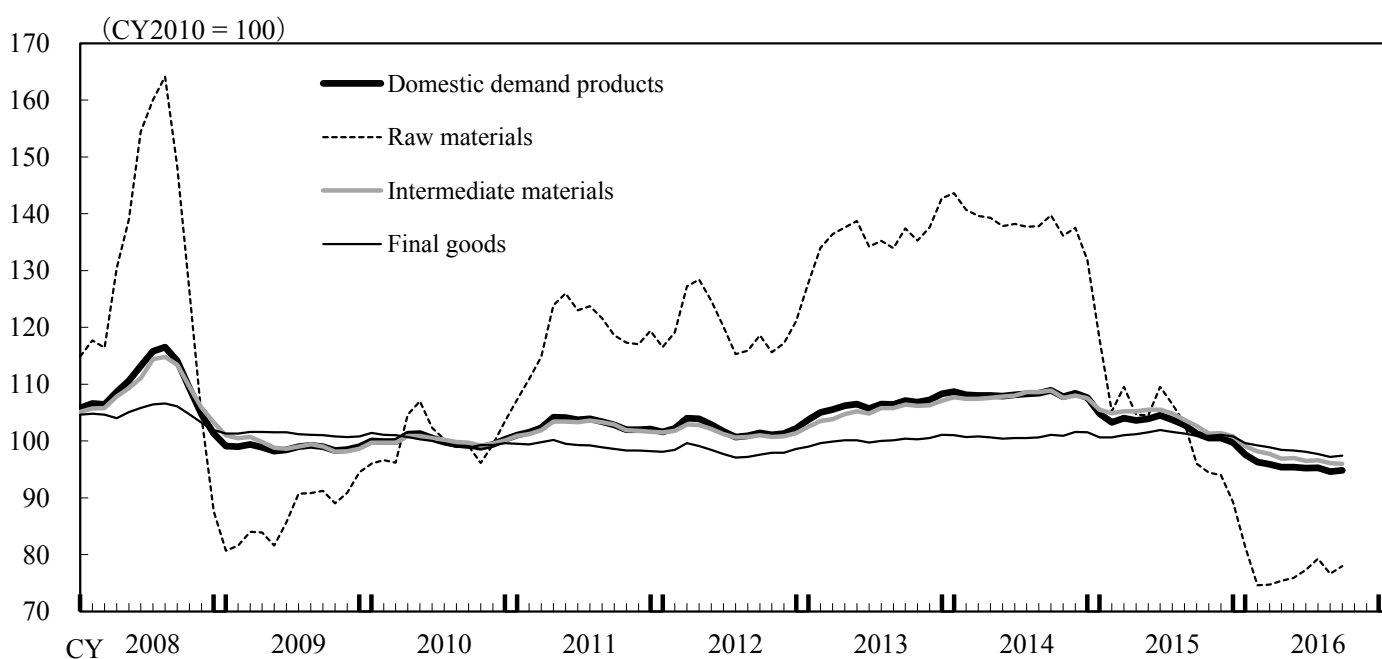
