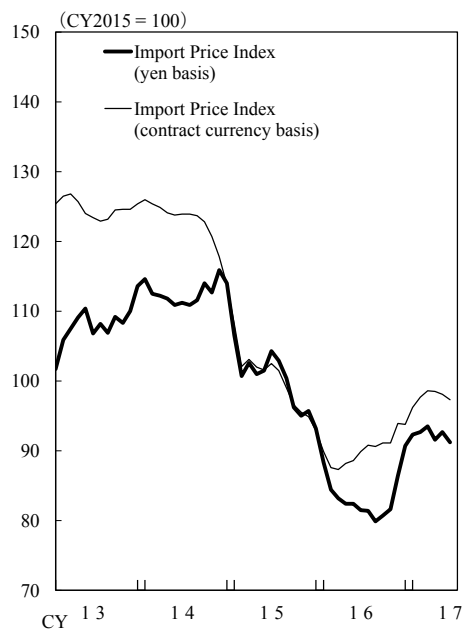
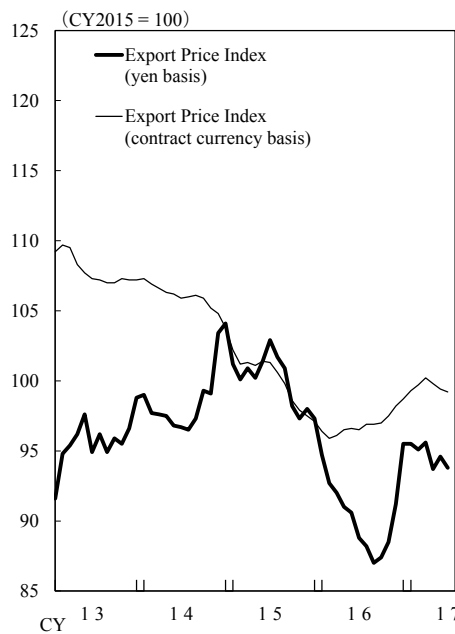
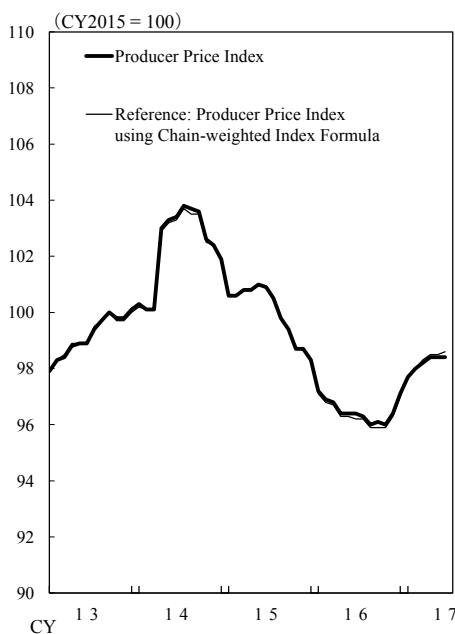
- ❖ The Producer Price Index was unchanged from the previous month.

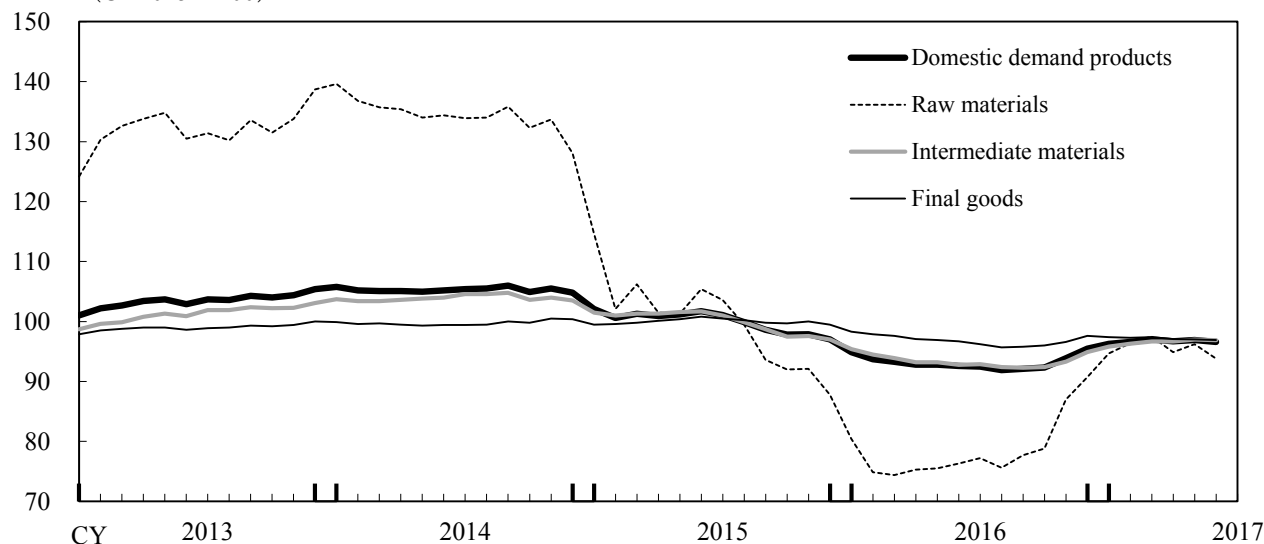
