Monthly Report on the Corporate Goods Price Index (Preliminary Figures for August 2018)

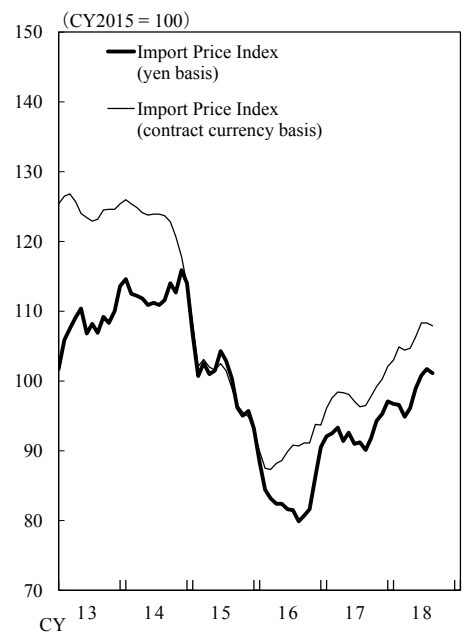
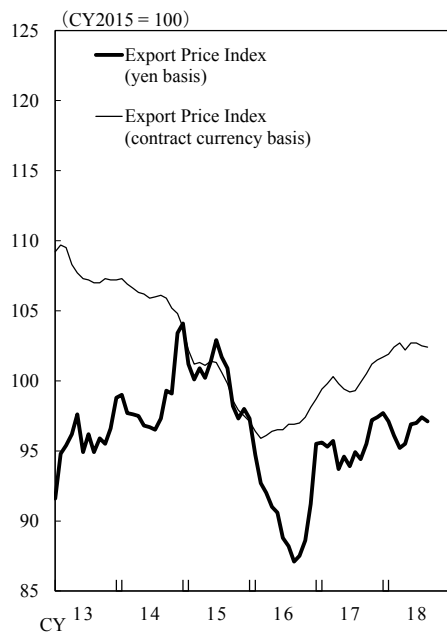
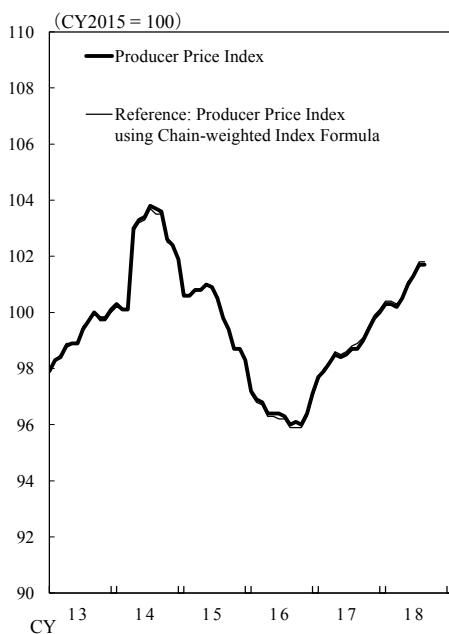
- ❖ The Producer Price Index was unchanged from the previous month.

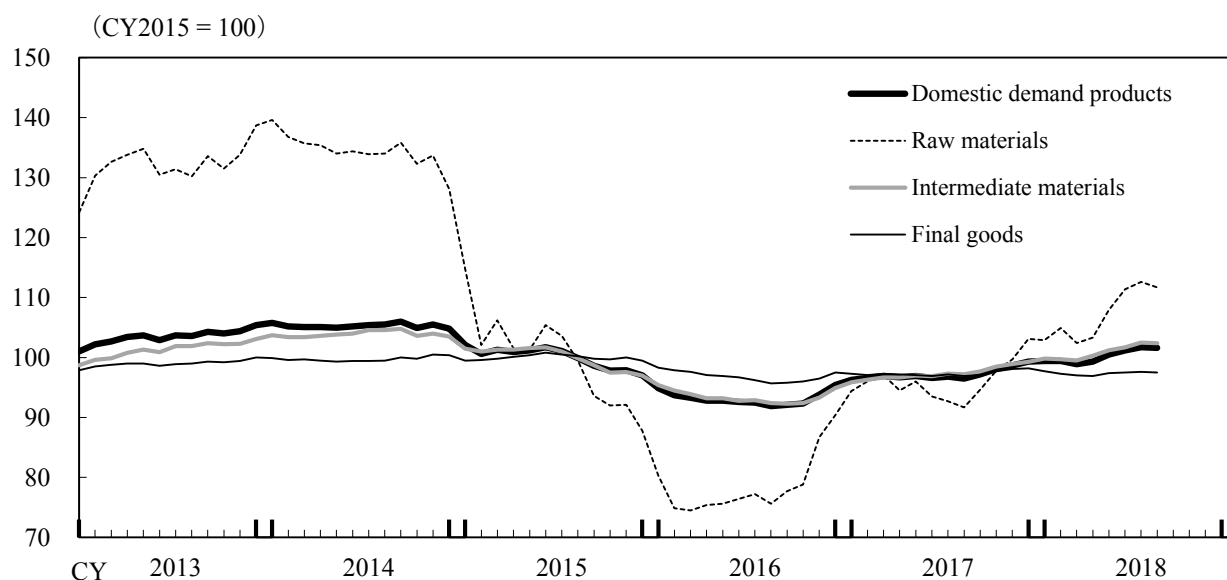
