## Monthly Report on the Corporate Goods Price Index ( Preliminary Figures for April 2019 )

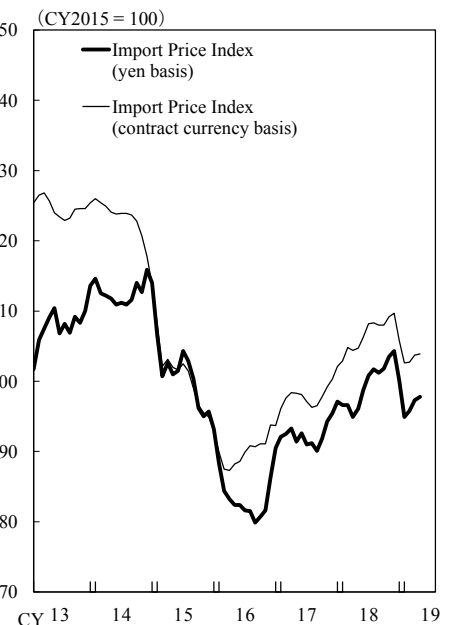
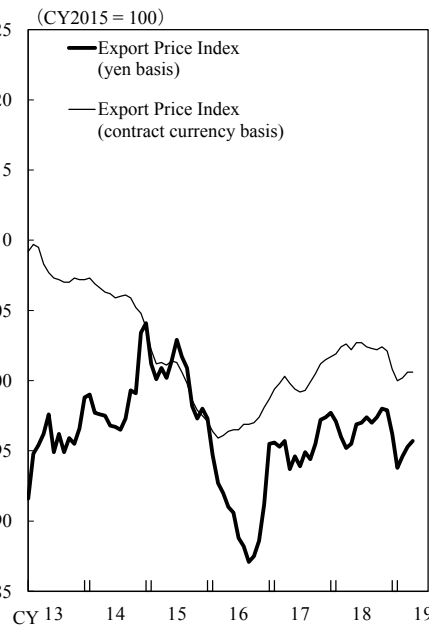
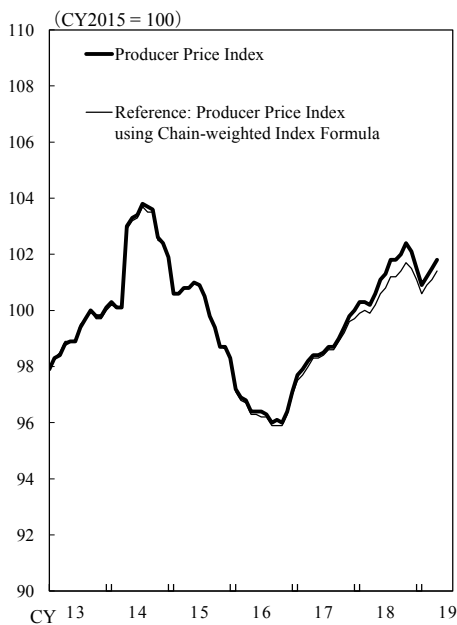
- ❖ The Producer Price Index rose 0.3 percent from the previous month.

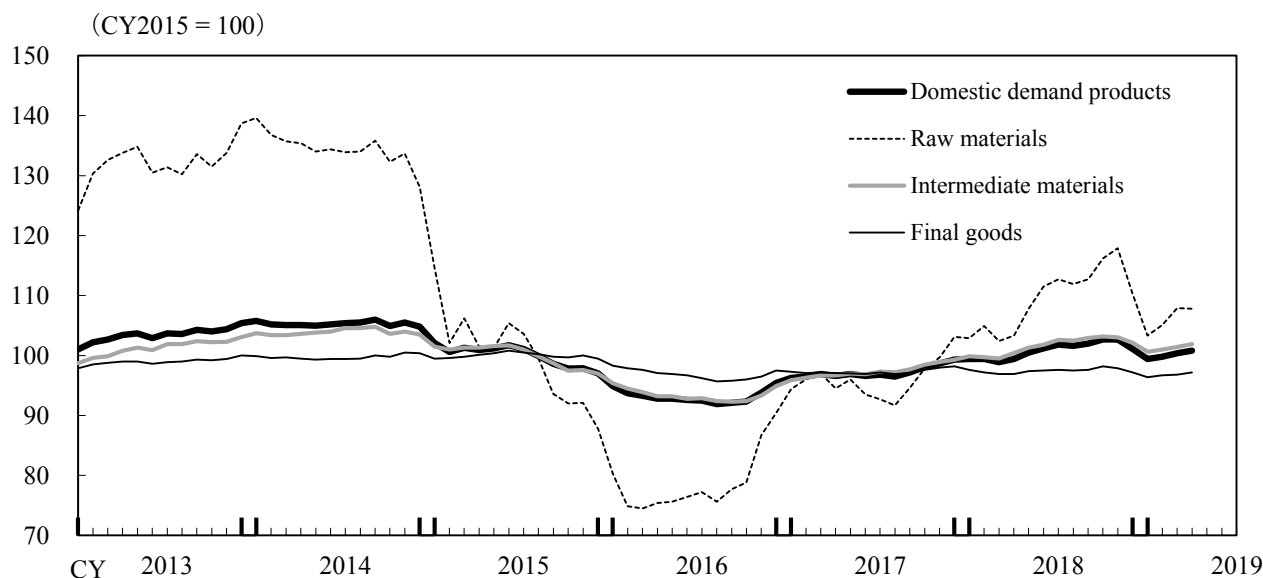
