Monthly Report on the Corporate Goods Price Index (Preliminary Figures for August 2019)

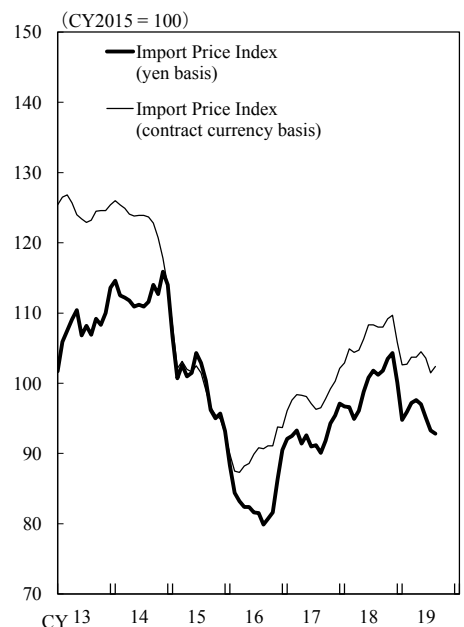
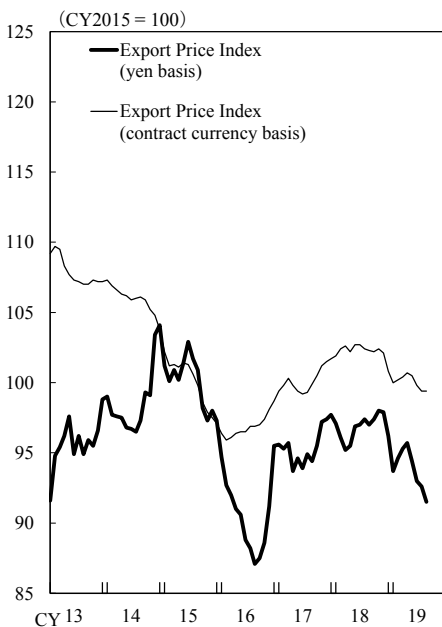
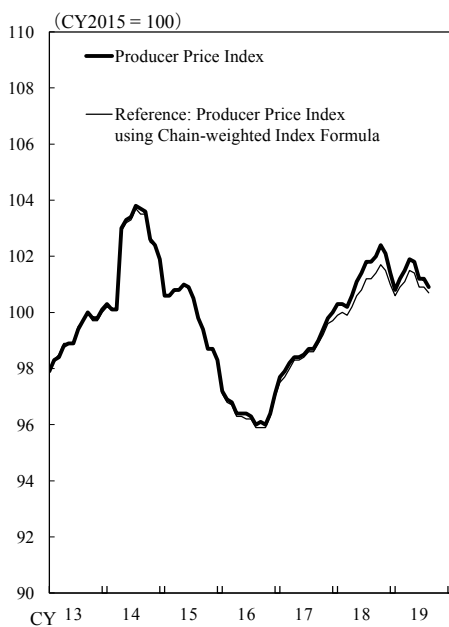
- ❖ The Producer Price Index fell 0.3 percent from the previous month.

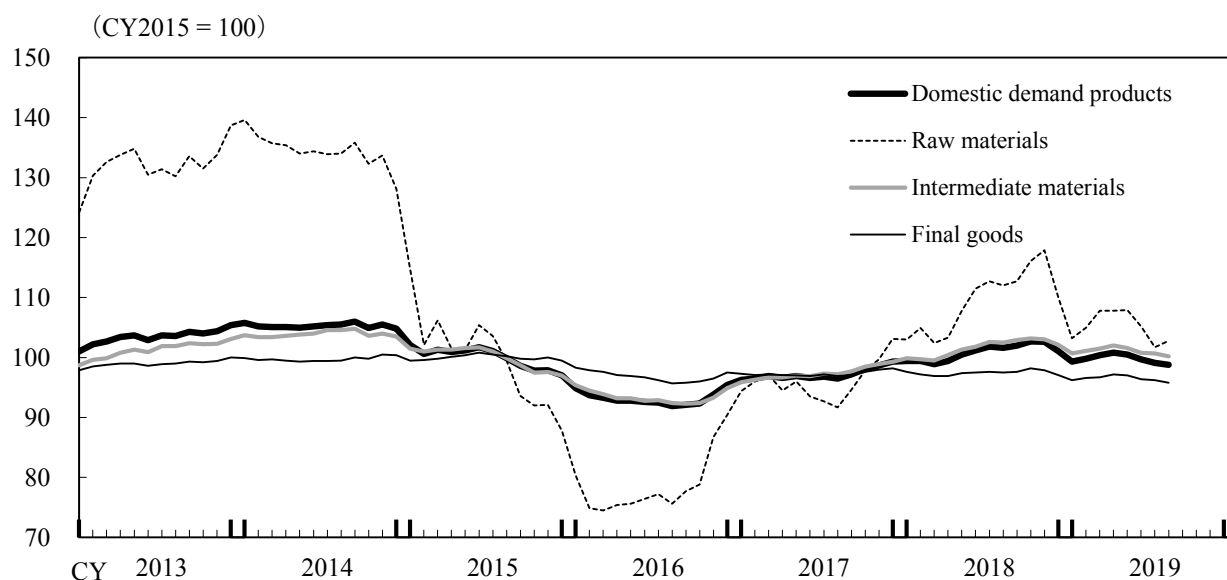
