Monthly Report on the Corporate Goods Price Index

(Preliminary Figures for October 2025)

- ❖ The Producer Price Index rose 0.4 percent from the previous month.

 The index excluding extra charges for summer electricity rose 0.6 percent from the previous month.
- ❖ The Export Price Index (contract currency basis) rose 1.0 percent from the previous month.
- ❖ The Import Price Index (contract currency basis) rose 0.7 percent from the previous month.






