- ❖ The Producer Price Index fell 0.2 percent from the previous month.
- ❖ The Export Price Index (contract currency basis) rose 0.6 percent from the previous month.
- ❖ The Import Price Index (contract currency basis) fell 1.0 percent from the previous month.

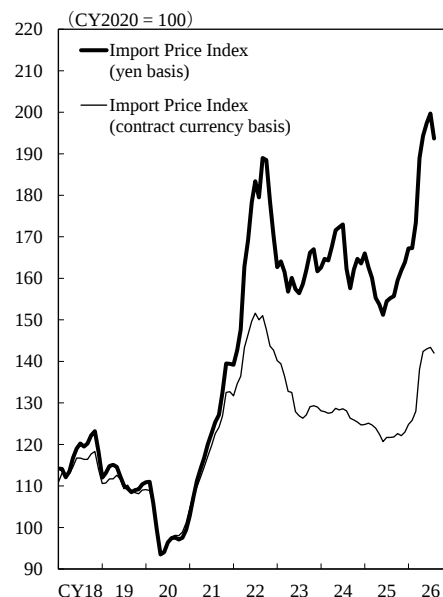
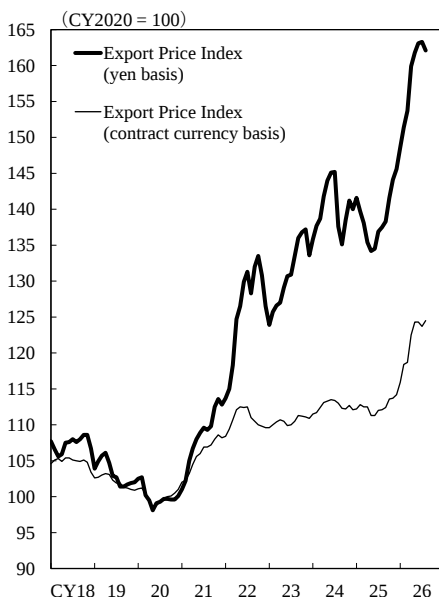
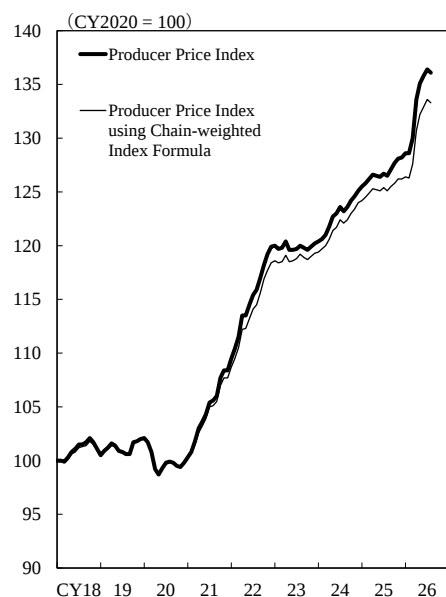
