Monthly Report on the Services Producer Price Index (Preliminary Figures for March 2026)

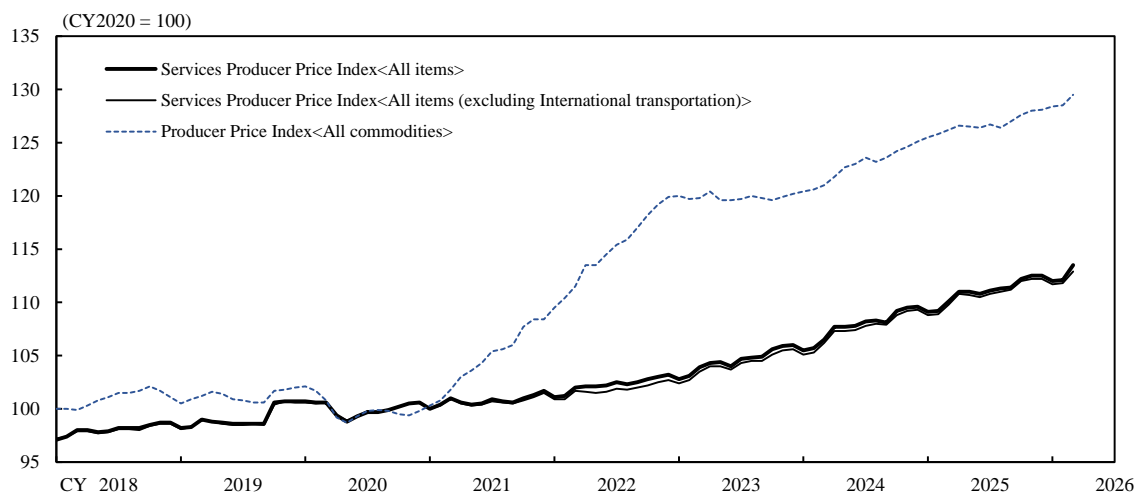
The Services Producer Price Index (All items) rose 3.1 percent from the previous year.
