Monthly Report on the Corporate Goods Price Index (Preliminary Figures for February 2019)

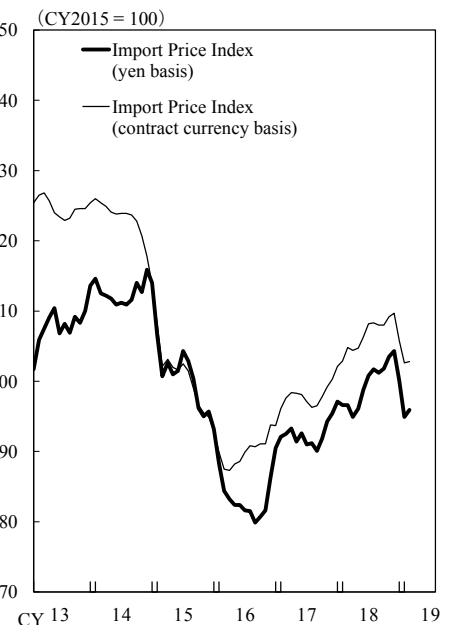
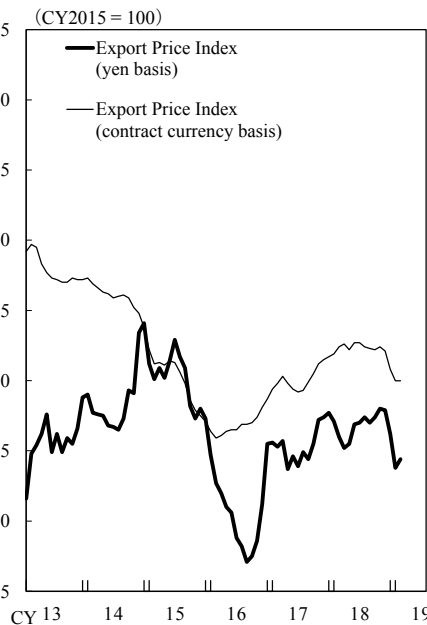
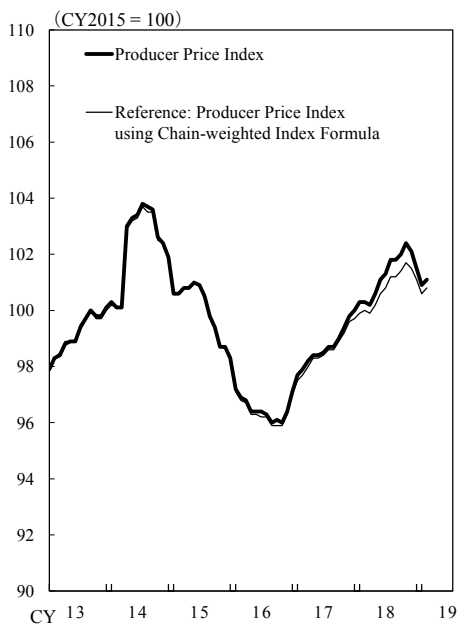
- ❖ The Producer Price Index rose 0.2 percent from the previous month.

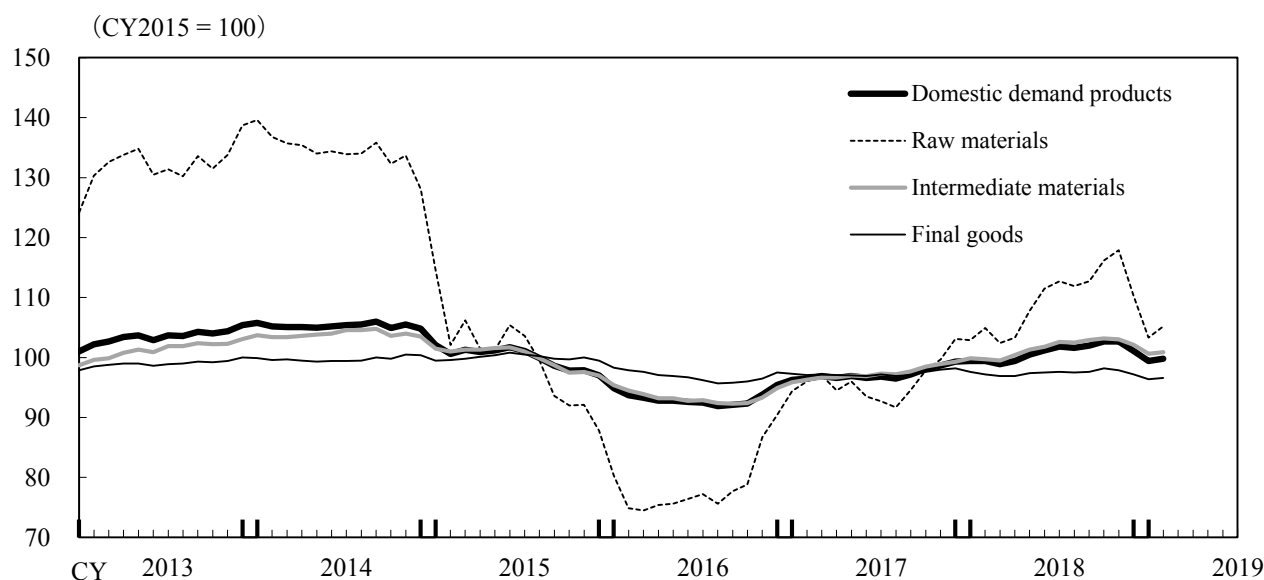
