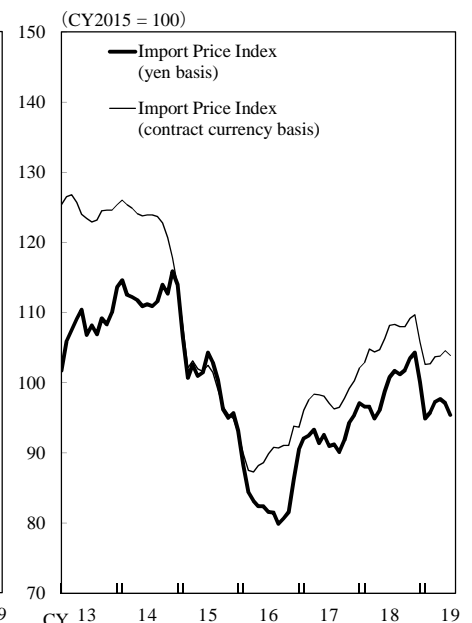
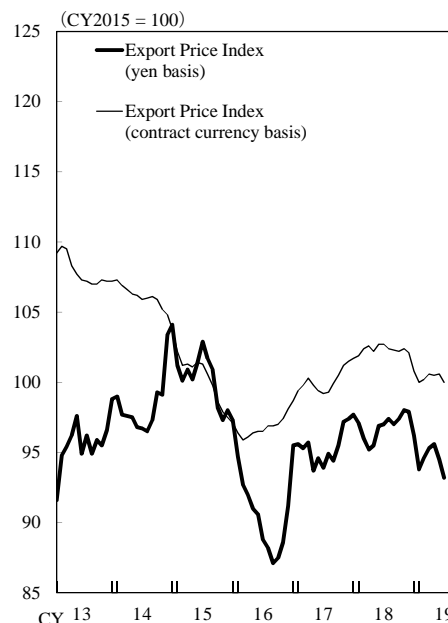
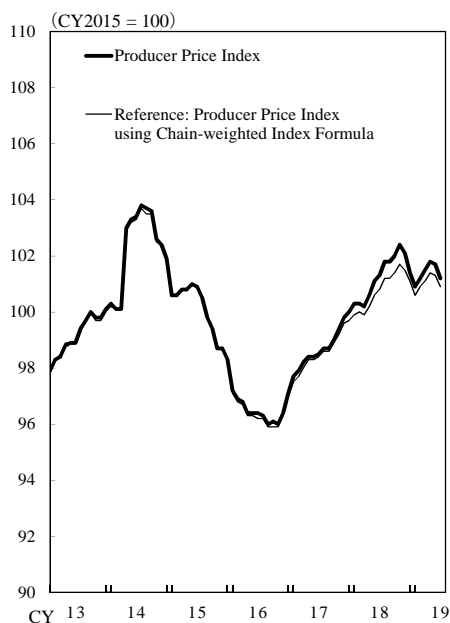
- ❖ The Producer Price Index fell 0.5 percent from the previous month.

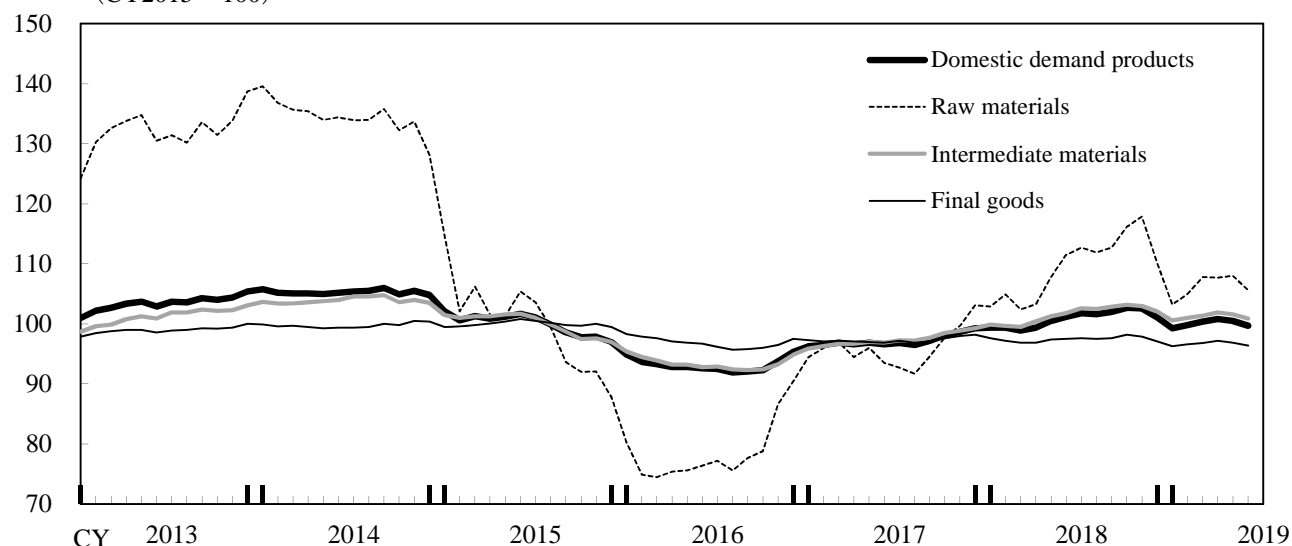
