## Monthly Report on the Corporate Goods Price Index ( Preliminary Figures for November 2020 )

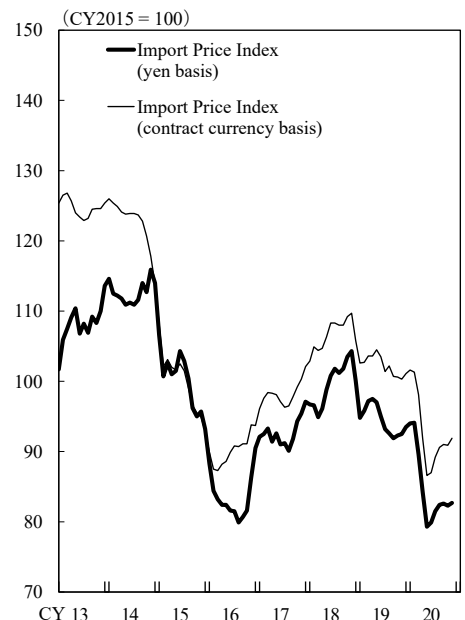
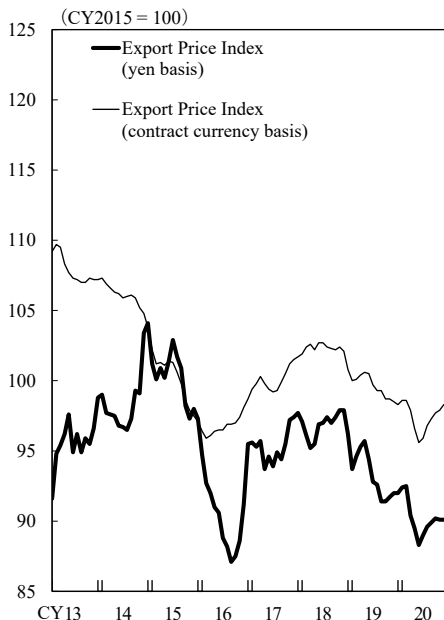
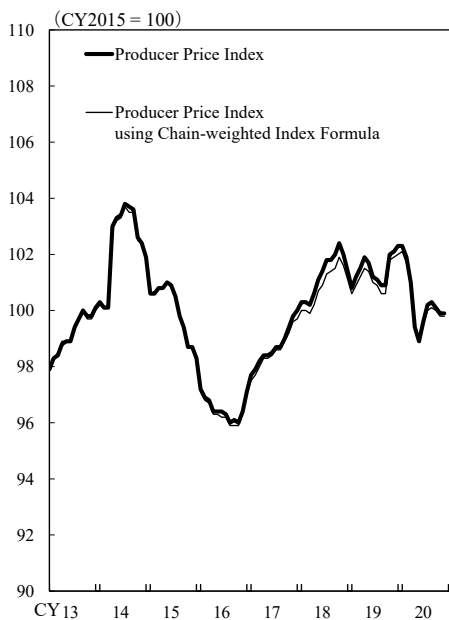
- ❖ The Producer Price Index was unchanged from the previous month.

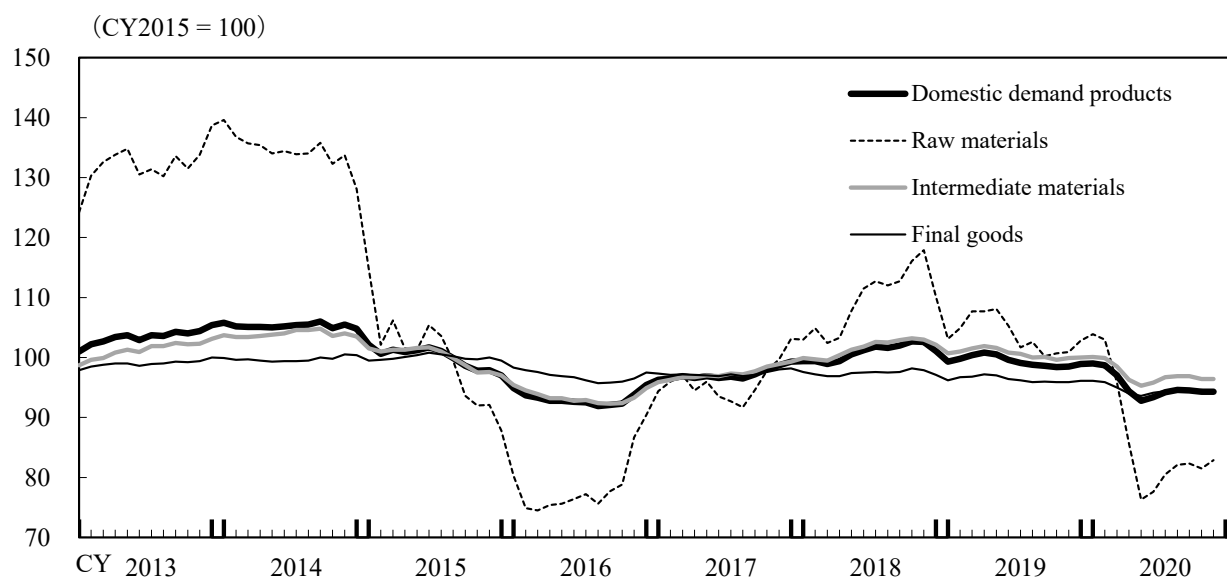
