Monthly Report on the Services Producer Price Index (Preliminary Figures for April 2020)

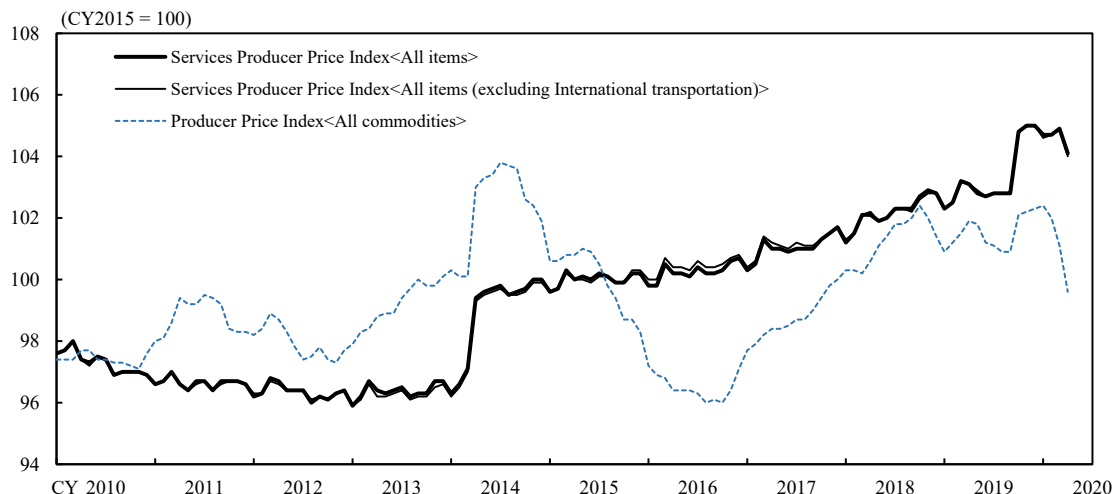
The Services Producer Price Index (All items) rose 1.0 percent from the previous year.

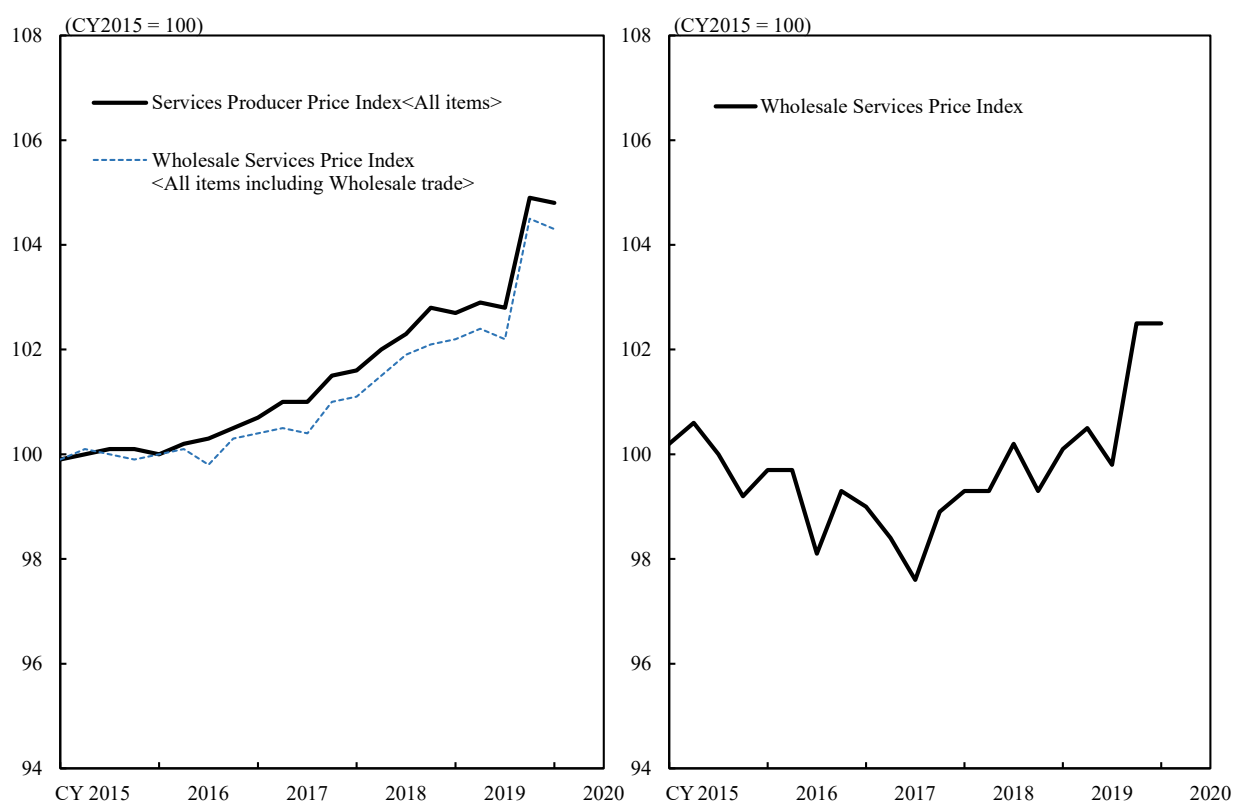

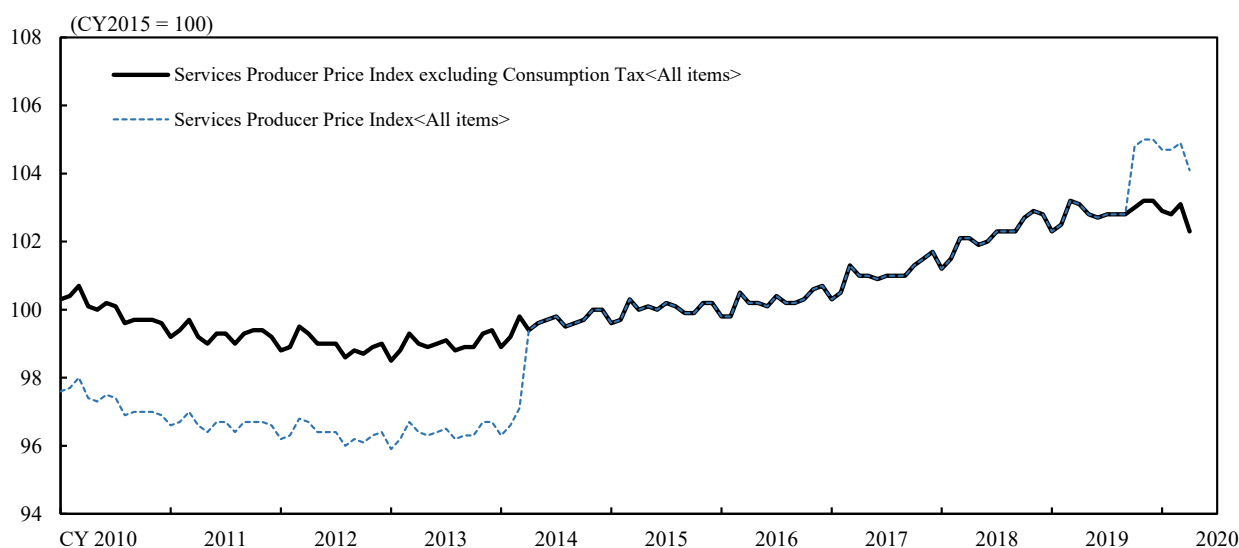
