Monthly Report on the Services Producer Price Index (Preliminary Figures for July 2021)

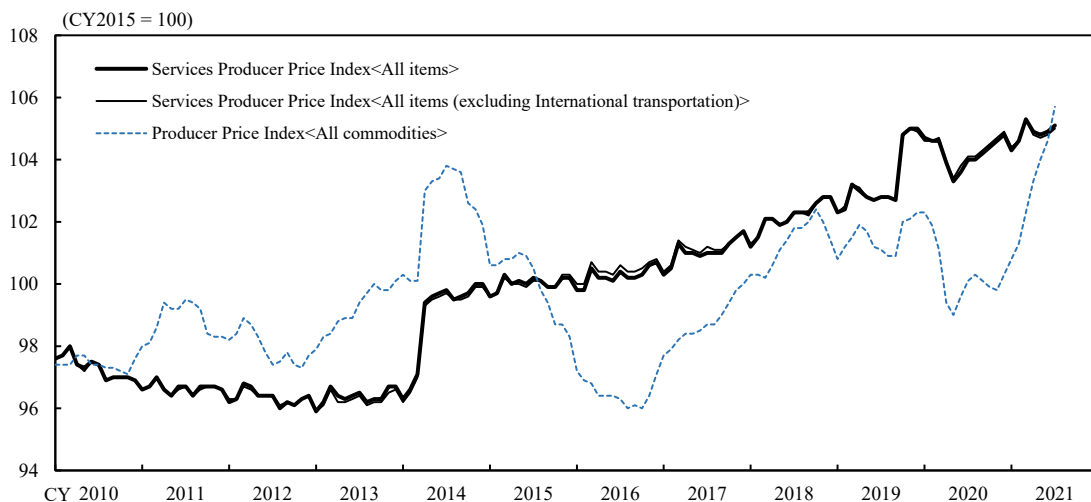
The Services Producer Price Index (All items) rose 1.1 percent from the previous year.
