Holding the "Bond Market Group" Meeting

As announced in the "Expanding Forums for Dialogue with Market Participants" released on January 28, 2015, the Financial Markets Department of the Bank will hold the first round of the "Bond Market Group" meetings in the following manner.

In order to make best use of the "Bond Market Survey" which started this February and facilitate more attentive dialogue with bond market participants, the Financial Markets Department will divide participants into relatively small groups and hold the meeting with each group.

4. Topic

The Bank will explain (1) the results of the "Bond Market Survey," (2) liquidity in the JGB Market, and (3) recent developments in the financial markets and market operations. The Bank will also exchange views with participants on these topics.
