Changes in Items in "Sources of Changes in Current Account Balances at the Bank of Japan and Market Operations"

In line with the amendment to the funds-supplying operation to support financial institutions in disaster areas, the Bank of Japan will change the formats of "Sources of Changes in Current Account Balances at the Bank of Japan and Market Operations." The details are as follows.

1. Daily data

The item "Funds-supplying operation to support financial institutions in disaster areas, etc" in "BOJ Loans and Market Operations" will be renamed "Funds-supplying operation to support financial institutions in disaster areas."

2. Monthly (final figures) data and long-term time-series data

The item "Funds-supplying operation to support financial institutions in disaster areas" will be added to "BOJ Loans and Market Operations (excluding the Loan Support Program)" and "Amount outstanding."

The item "Funds-supplying operation to support financial institutions in disaster areas" in "BOJ Loans and Market Operations (excluding the Loan Support Program)" and "Amount outstanding" will be renamed "Funds-supplying operation to support financial institutions in disaster areas (abolished)."

The item "Funds-supplying operation to support financial institutions in disaster areas of the Kumamoto Earthquake" in "BOJ Loans and Market Operations (excluding the Loan Support Program)" and "Amount outstanding" will be renamed "Funds-supplying operation to support financial institutions in disaster areas of the Kumamoto Earthquake (abolished)."
