Monthly Report on the Corporate Goods Price Index (Preliminary Figures for January 2019)

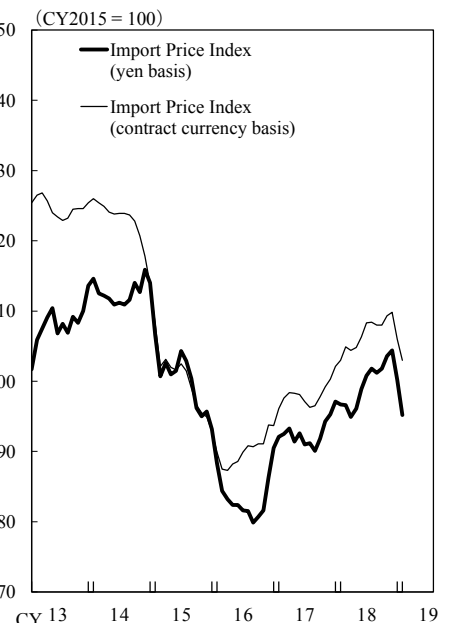
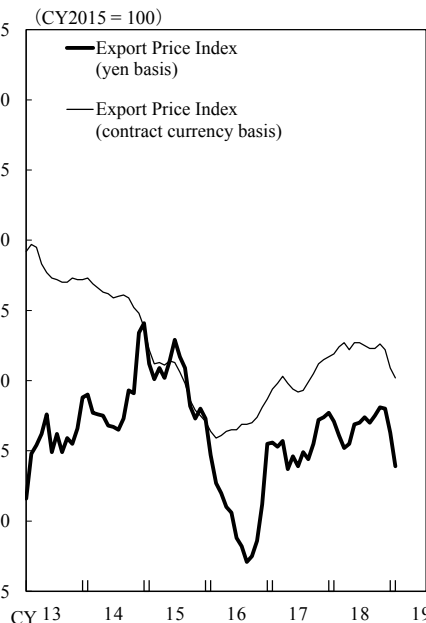
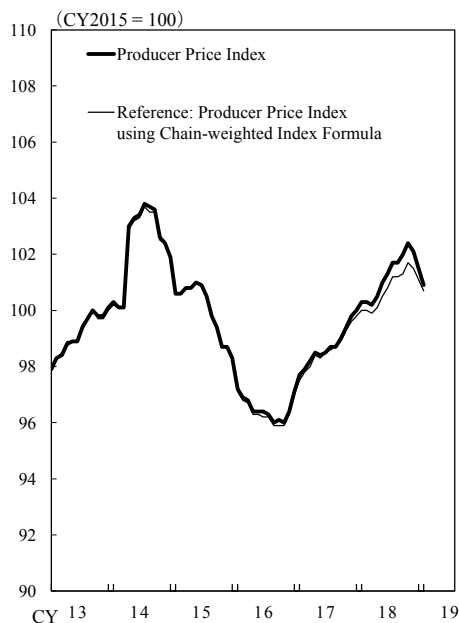
- ❖ The Producer Price Index fell 0.6 percent from the previous month.

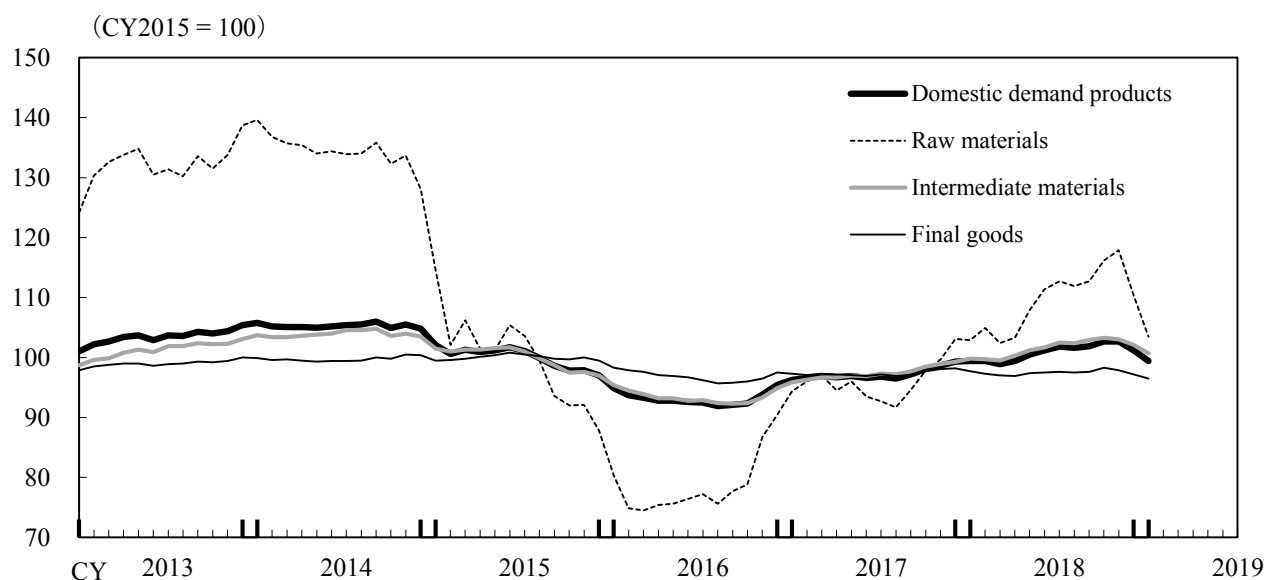
