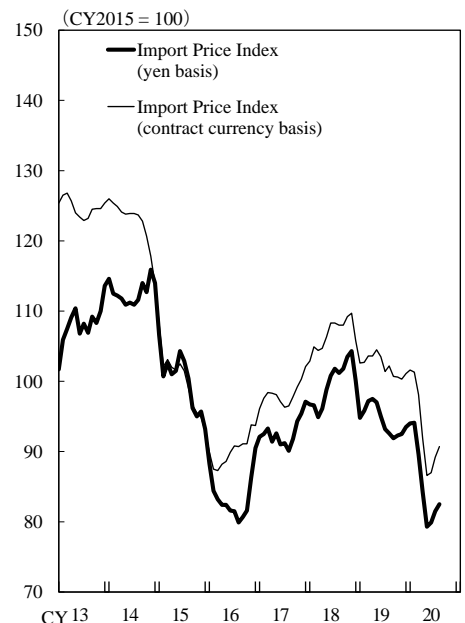
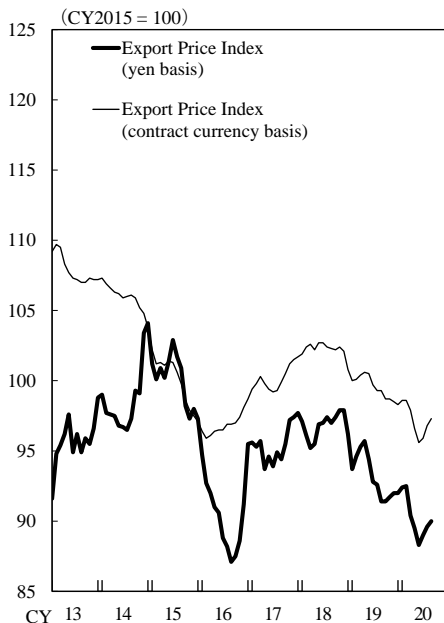
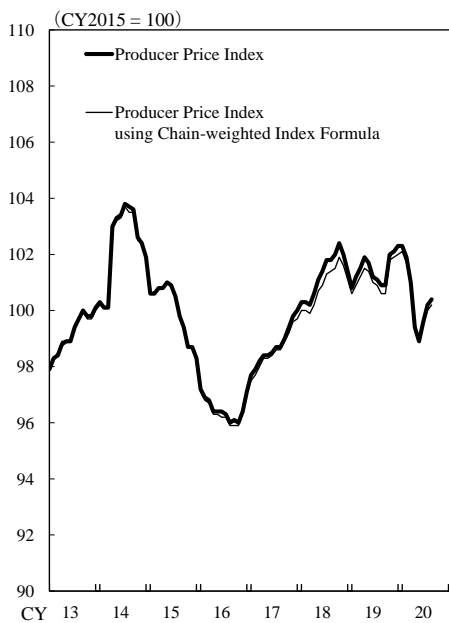
- ❖ The Producer Price Index rose 0.2 percent from the previous month.

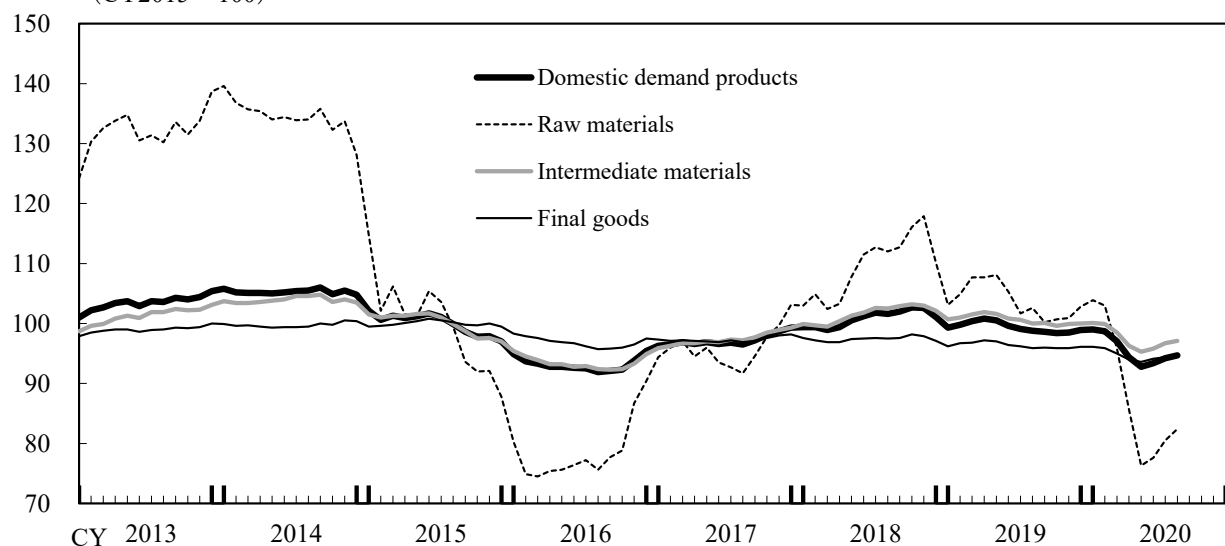

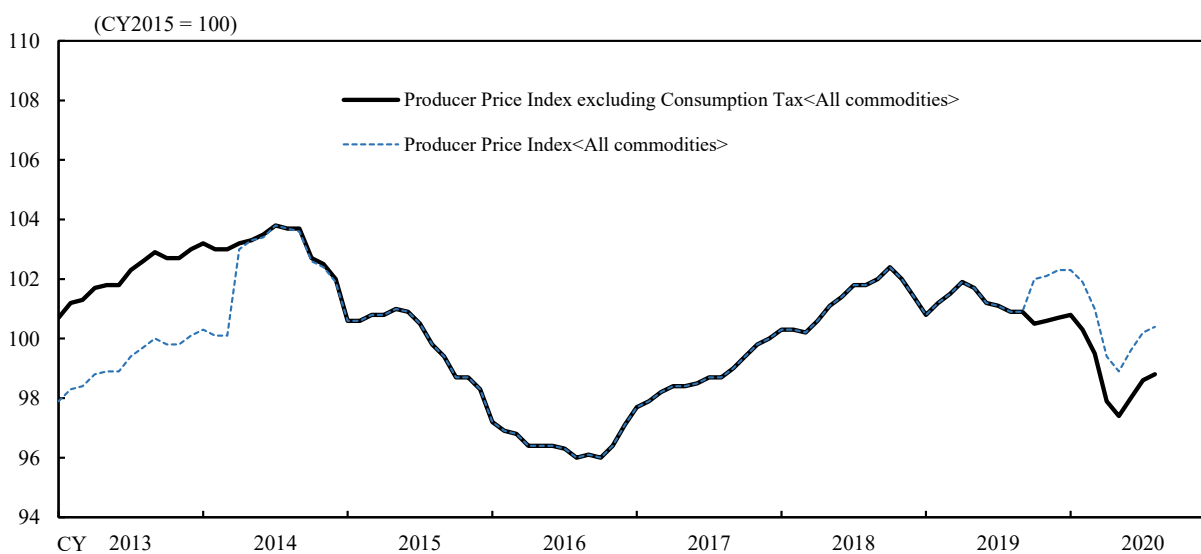
