Monthly Report on the Corporate Goods Price Index (Preliminary Figures for December 2020)

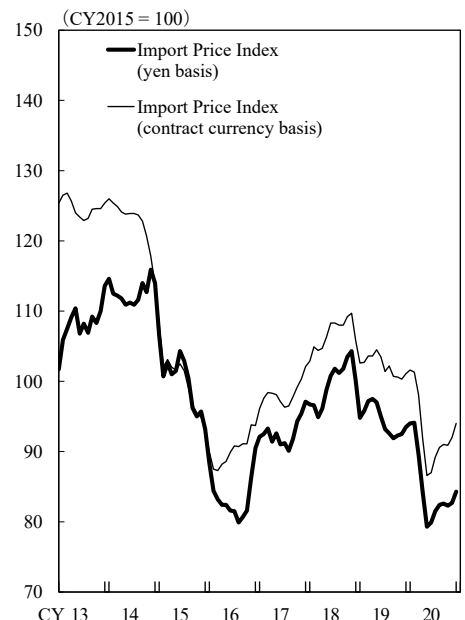
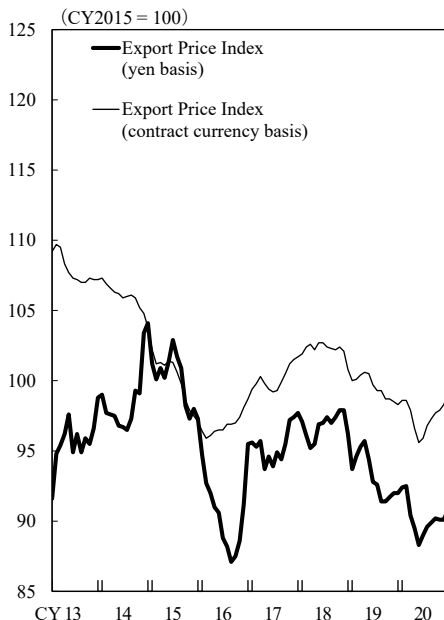
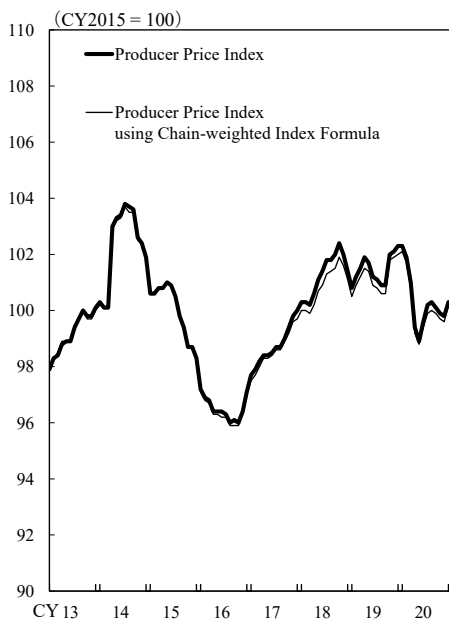
- ❖ The Producer Price Index rose 0.5 percent from the previous month.

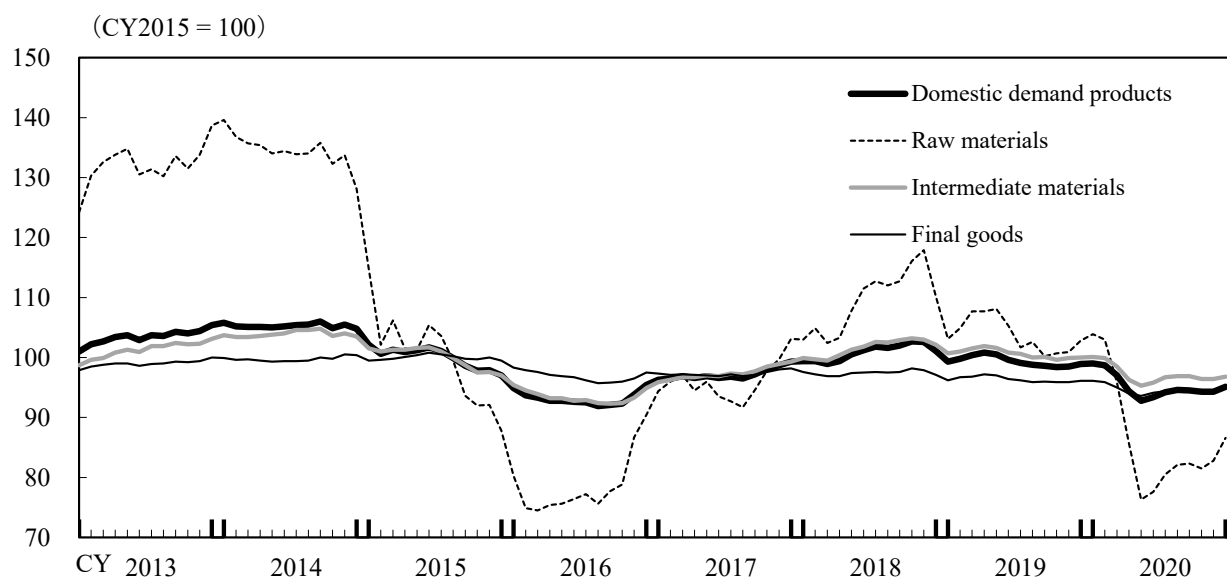
