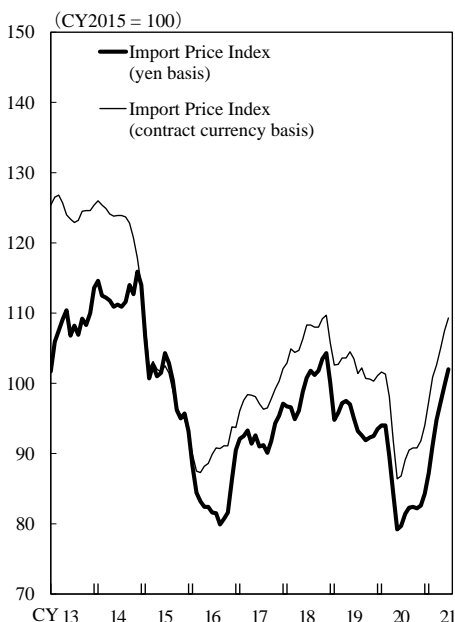
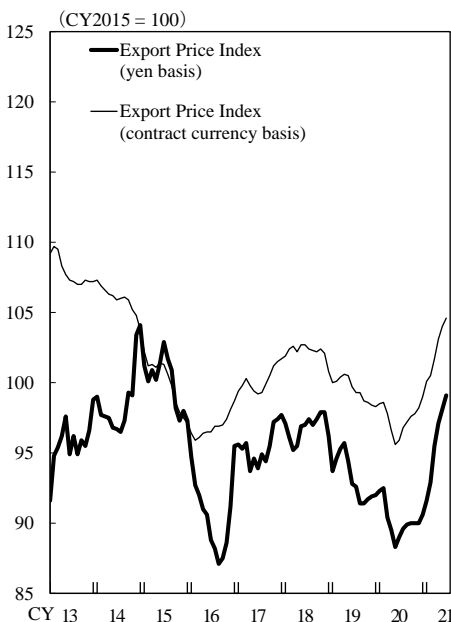
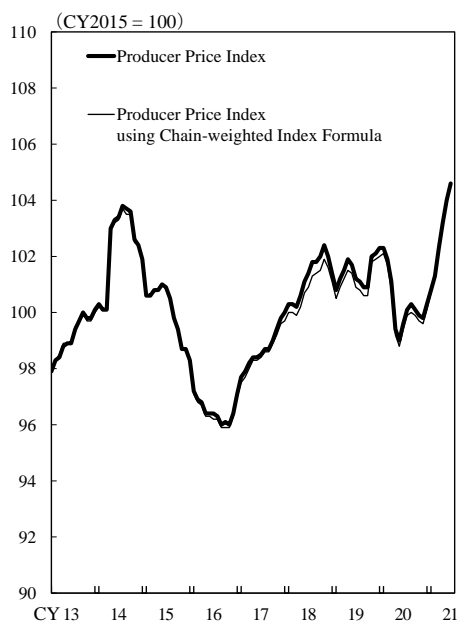
- ❖ The Producer Price Index rose 0.6 percent from the previous month.

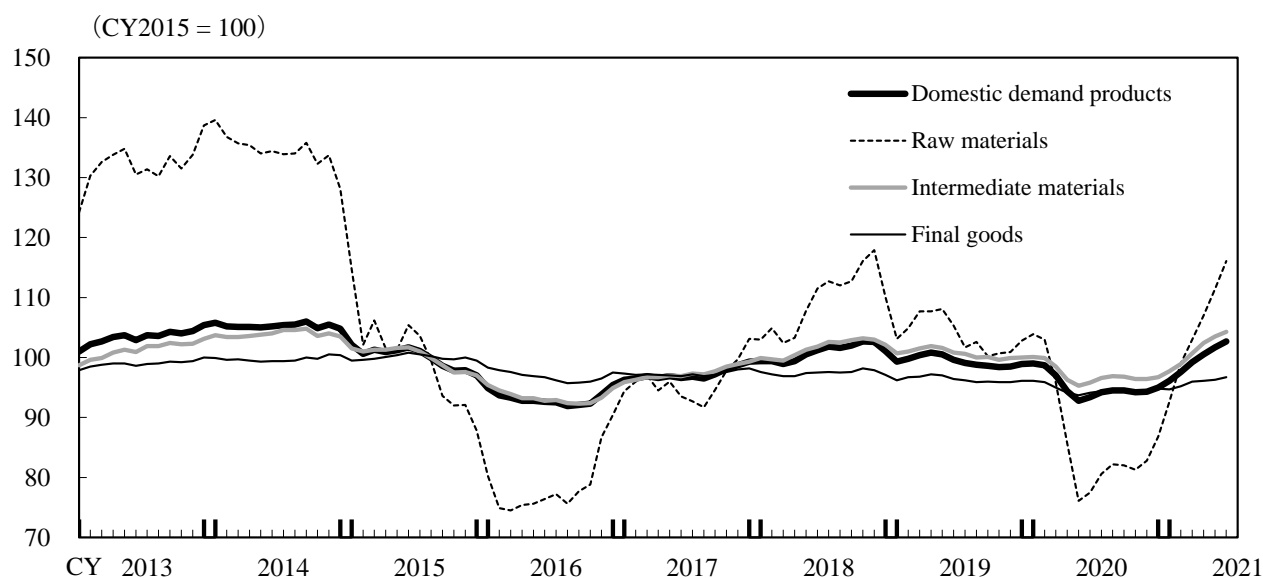
