( Preliminary Figures for July 2021 )

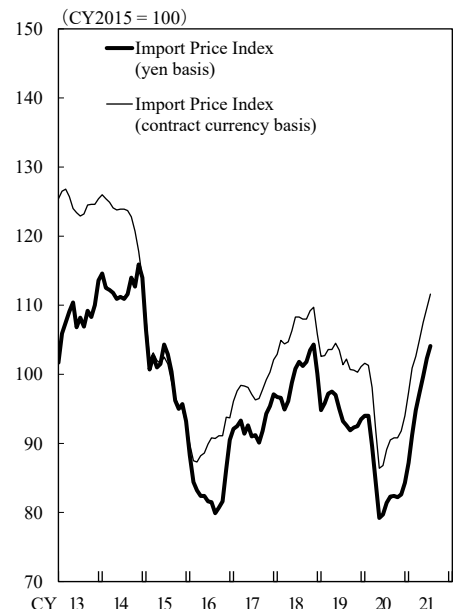
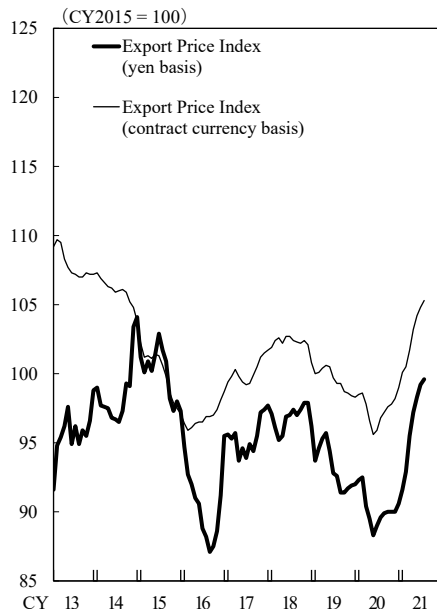
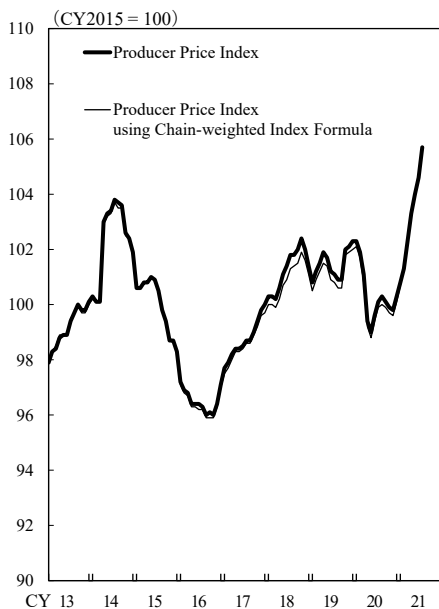
- ❖ The Producer Price Index rose 1.1 percent from the previous month.

- ❖ The Export Price Index (contract currency basis) rose 0.5 percent from the previous month.
- ❖ The Import Price Index (contract currency basis) rose 1.8 percent from the previous month.

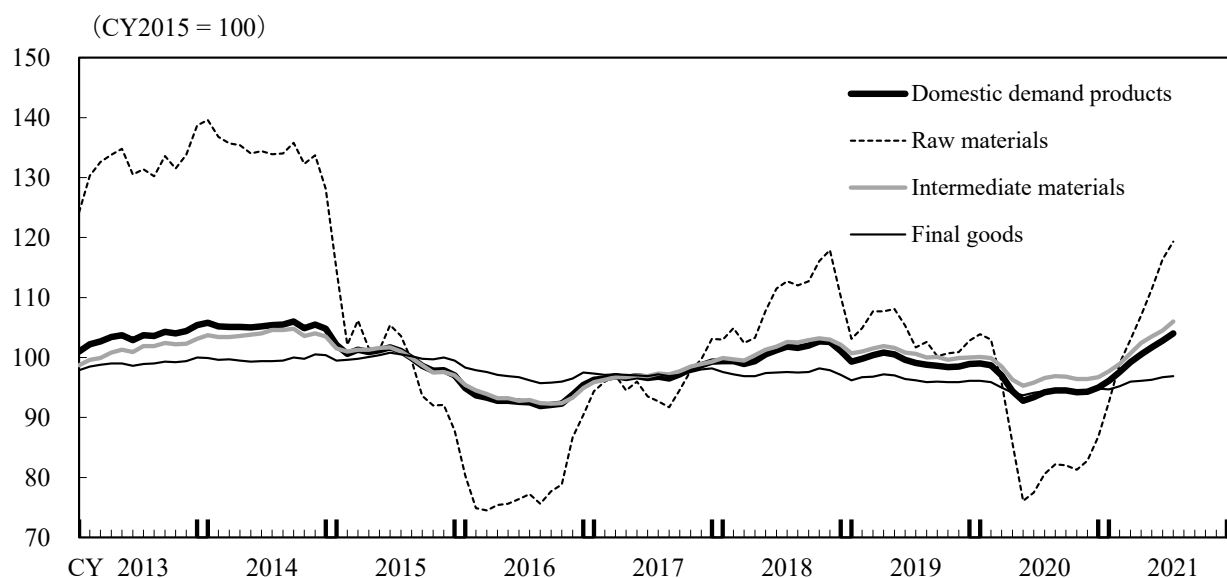
