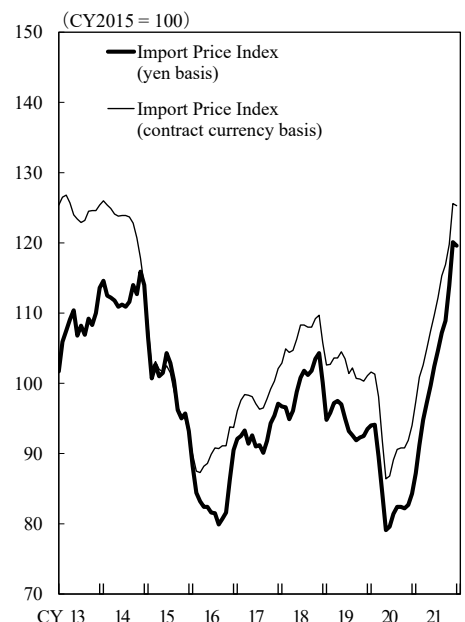
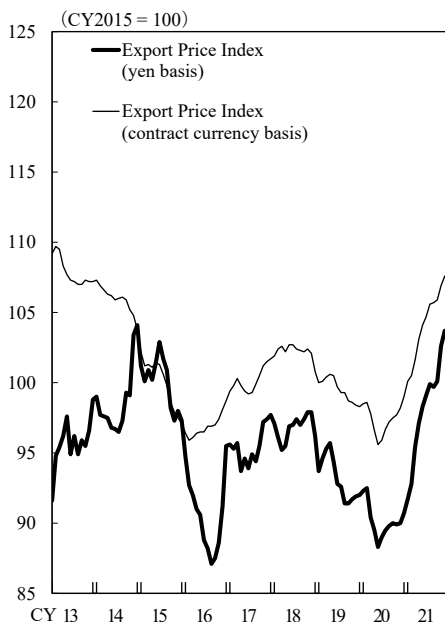
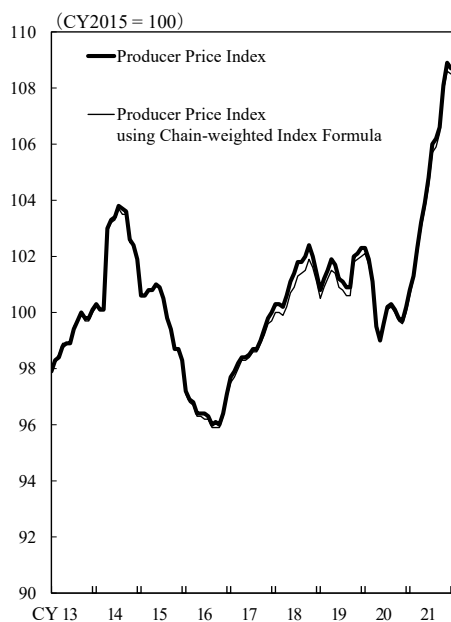
- ❖ The Producer Price Index fell 0.2 percent from the previous month.

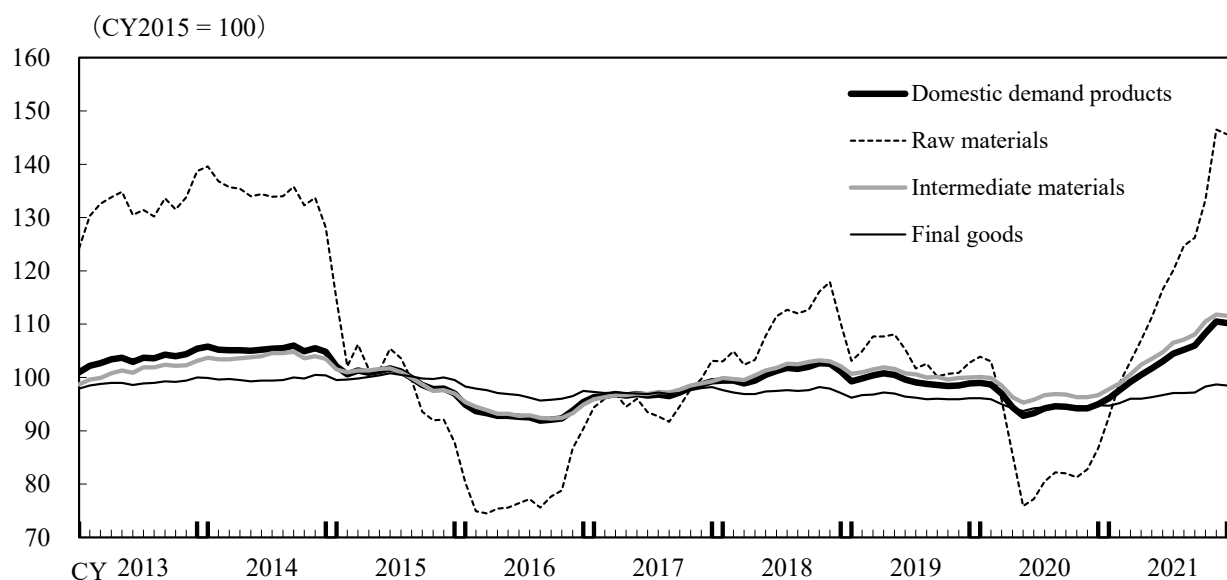
