- ❖ The Import Price Index (contract currency basis) fell 0.1 percent from the previous month.

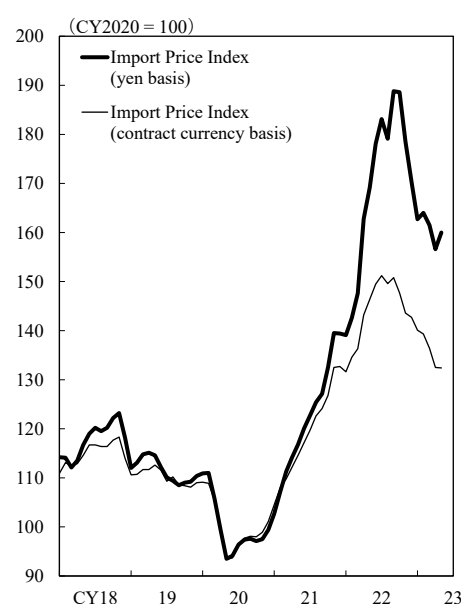
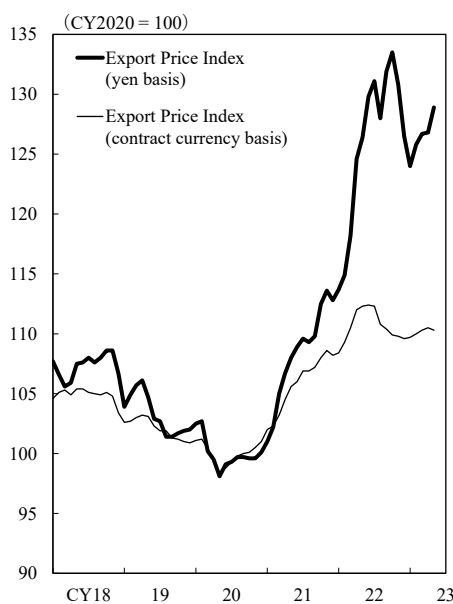
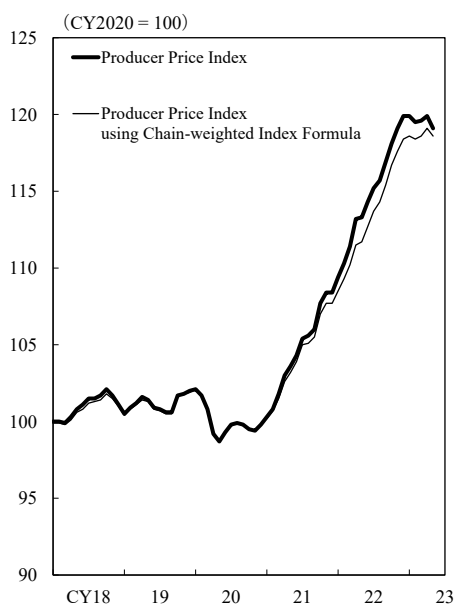
