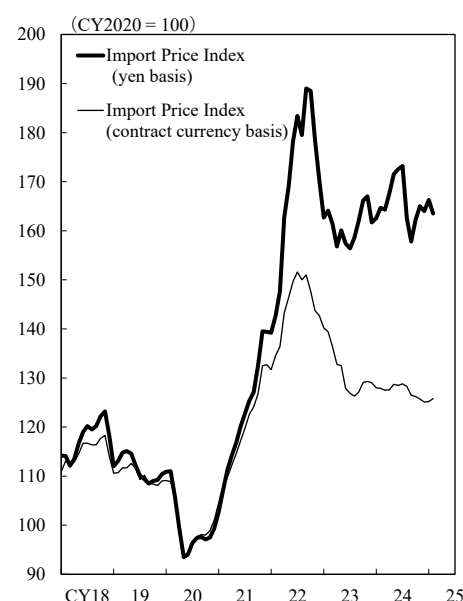
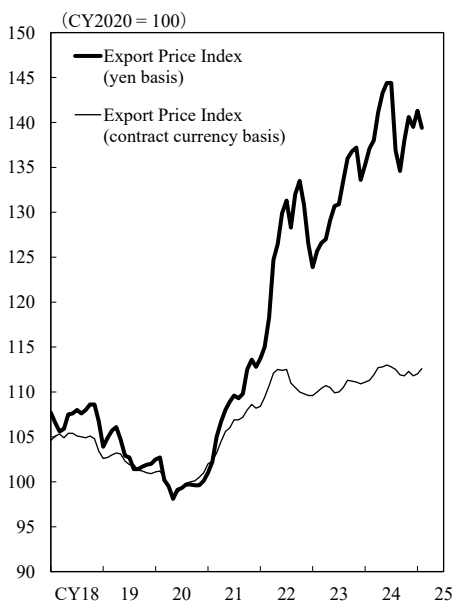
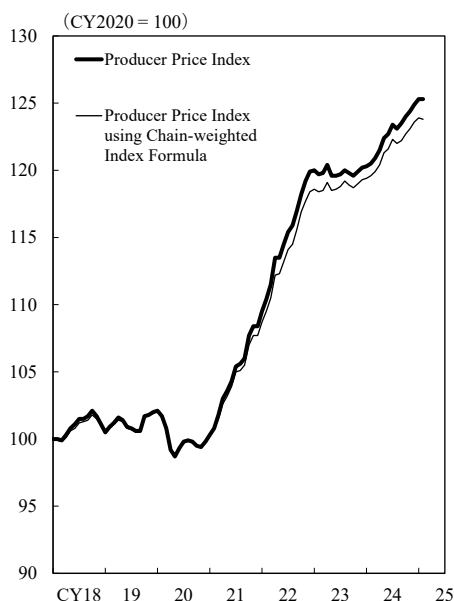
## Monthly Report on the Corporate Goods Price Index ( Preliminary Figures for February 2025 )

- ❖ The Export Price Index (contract currency basis) rose 0.5 percent from the previous month.
- ❖ The Import Price Index (contract currency basis) rose 0.5 percent from the previous month.
