- ❖ The Export Price Index (contract currency basis) fell 0.1 percent from the previous month.
- ❖ The Import Price Index (contract currency basis) was unchanged from the previous month.

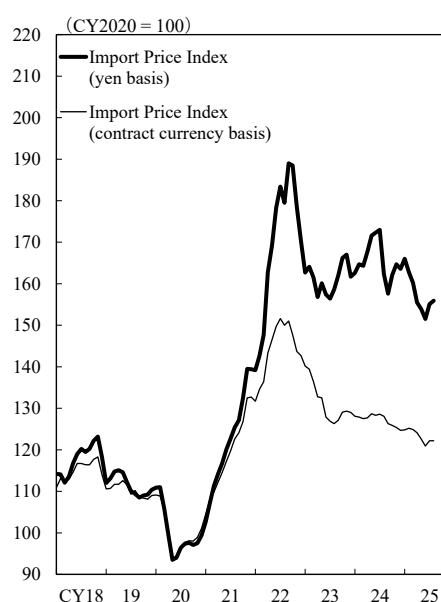
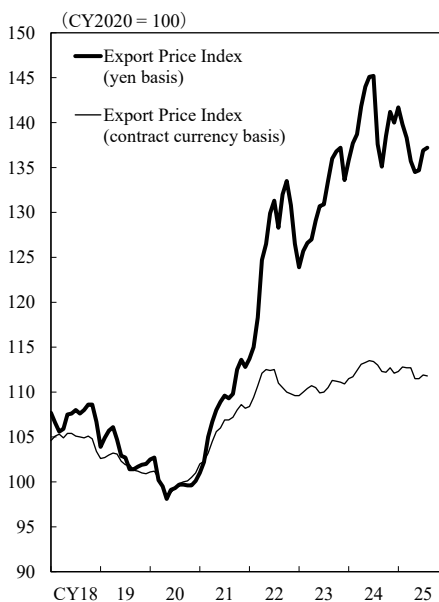
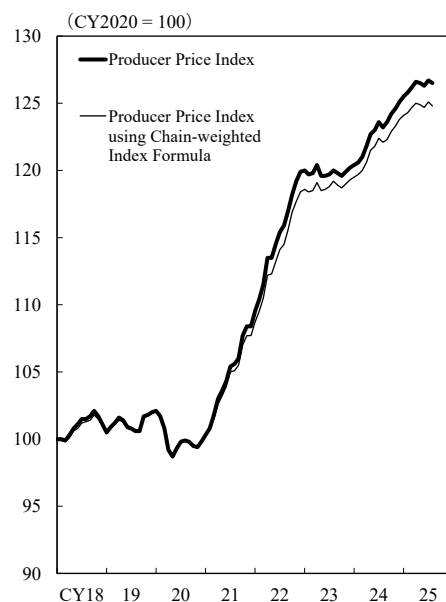
