## Monthly Report on the Services Producer Price Index ( Preliminary Figures for September 2019 )

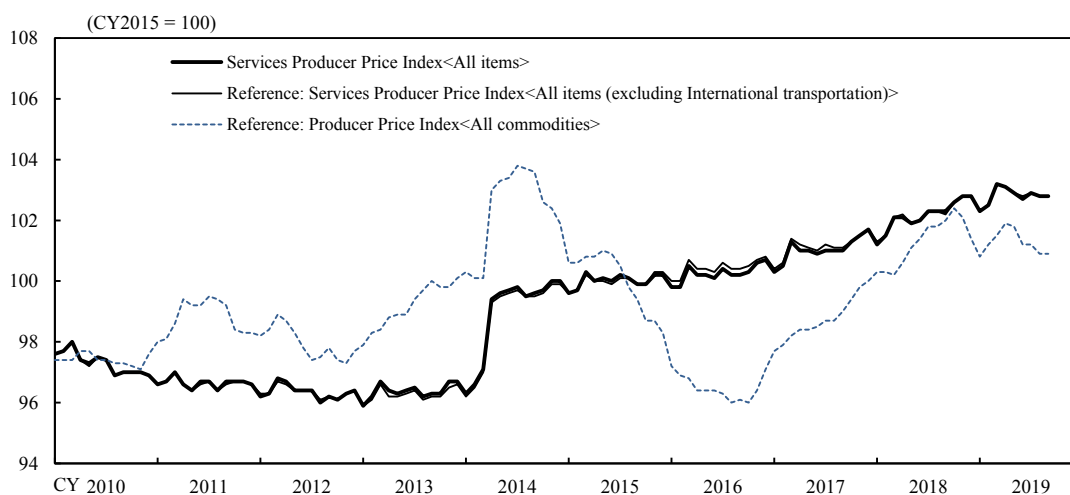
The Services Producer Price Index (All items) rose 0.5 percent from the previous year.
