## Monthly Report on the Services Producer Price Index ( Preliminary Figures for November 2019 )

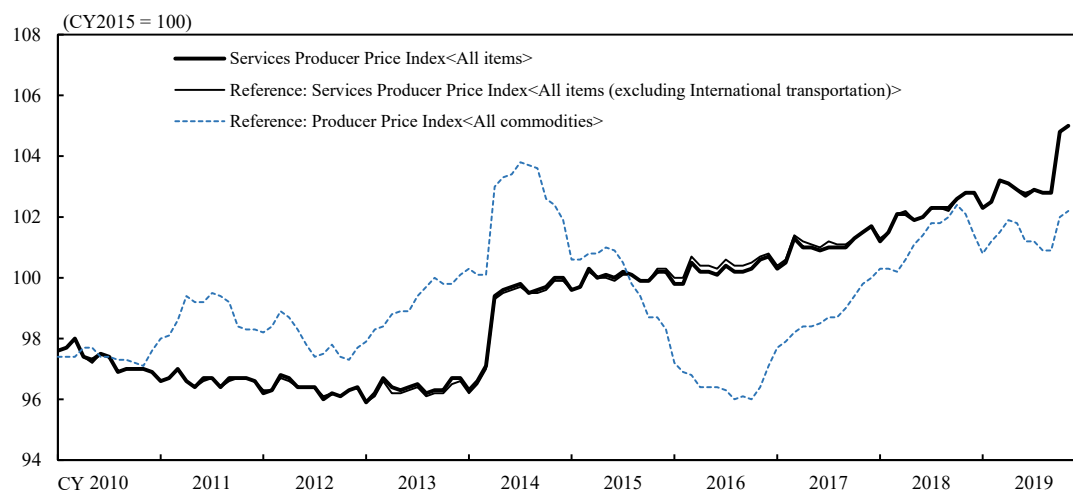
The Services Producer Price Index (All items) rose 2.1 percent from the previous year.

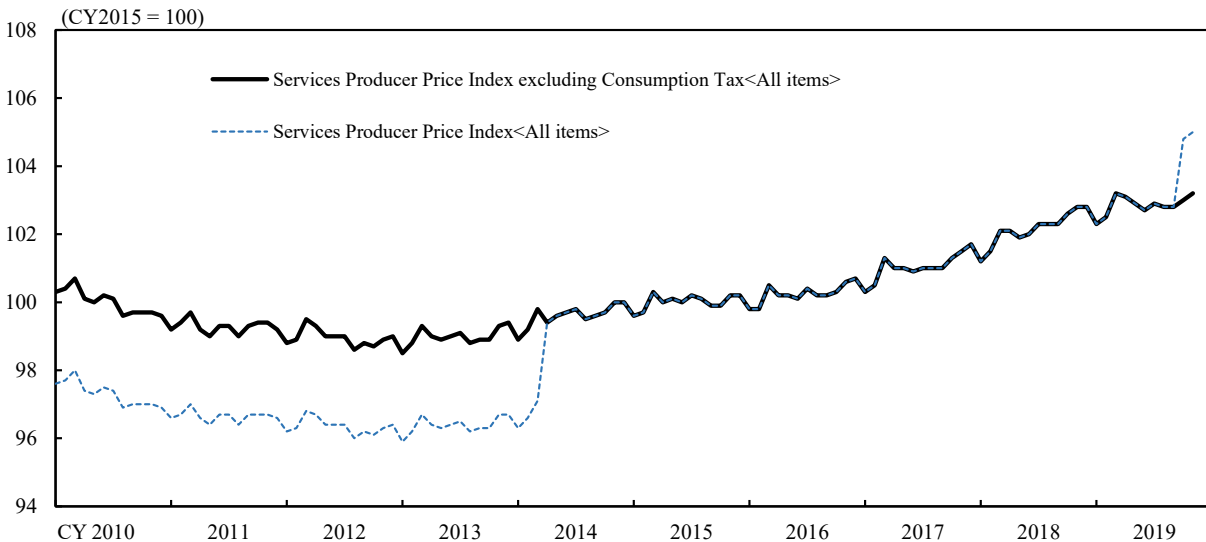
