Monthly Report on the Services Producer Price Index (Preliminary Figures for May 2020)

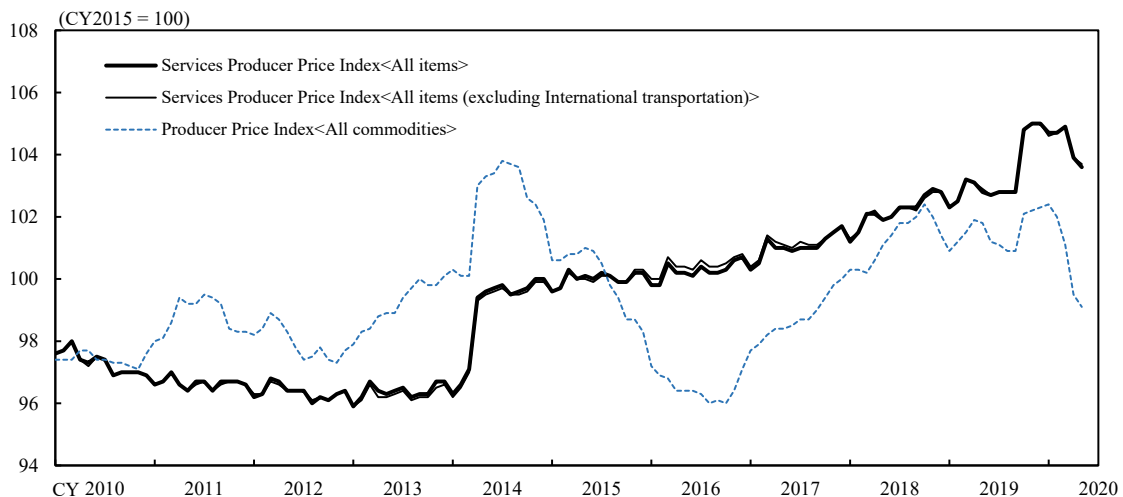
The Services Producer Price Index (All items) rose 0.8 percent from the previous year.

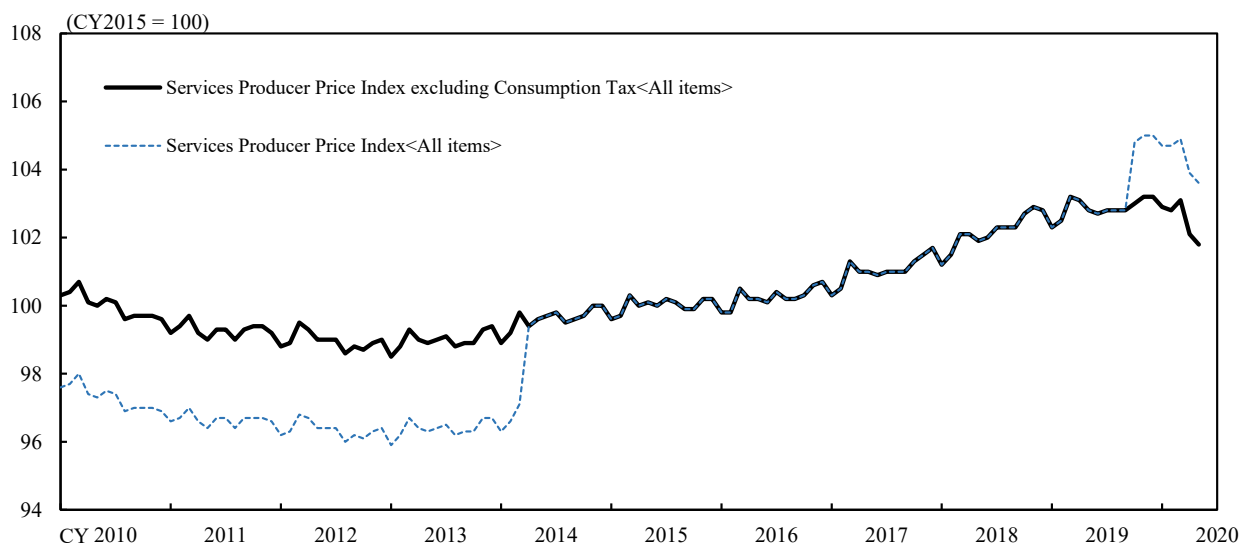
