## Monthly Report on the Services Producer Price Index ( Preliminary Figures for January 2025 )

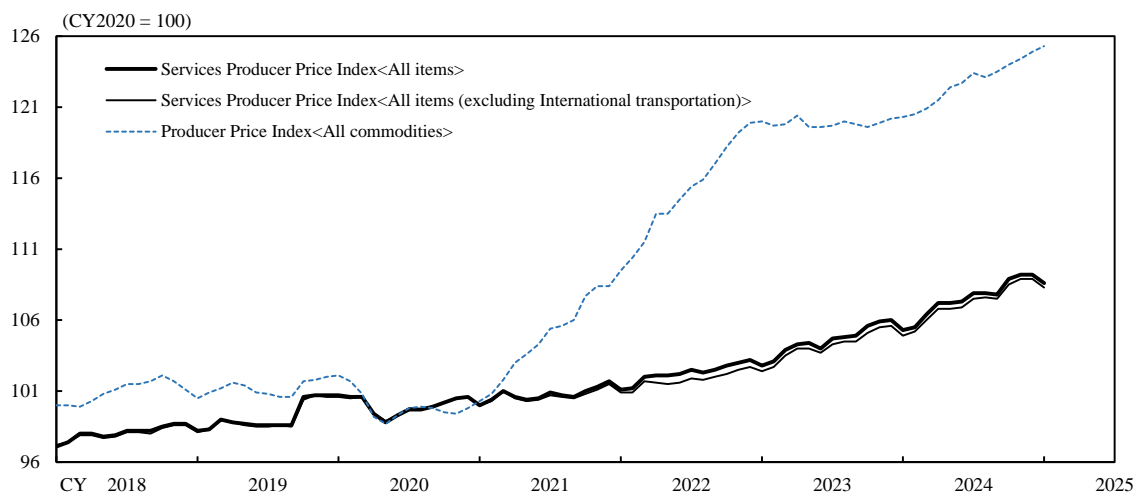
The Services Producer Price Index (All items) rose 3.1 percent from the previous year.
