Monthly Report on the Services Producer Price Index (Preliminary Figures for July 2025)

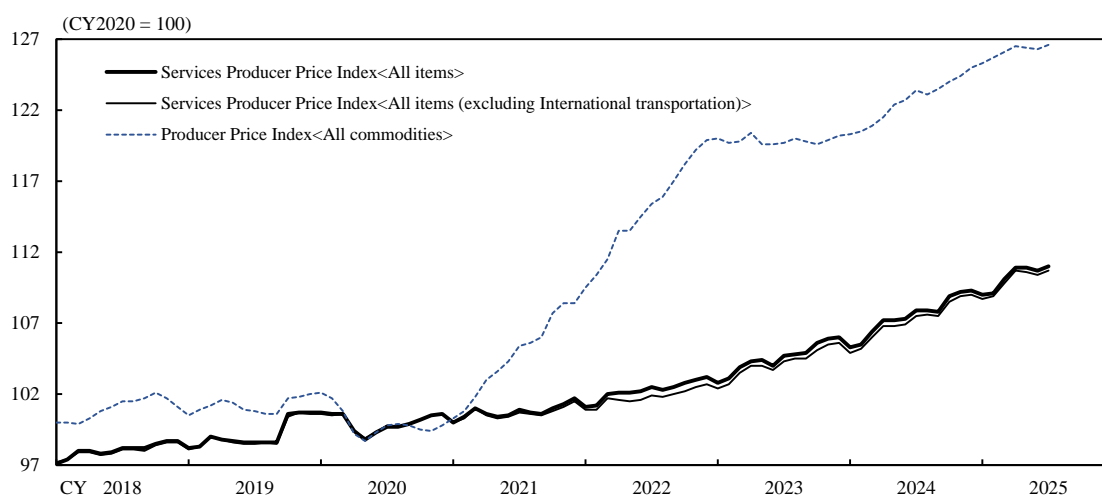
The Services Producer Price Index (All items) rose 2.9 percent from the previous year.
