Monthly Report on the Services Producer Price Index (Preliminary Figures for September 2025)

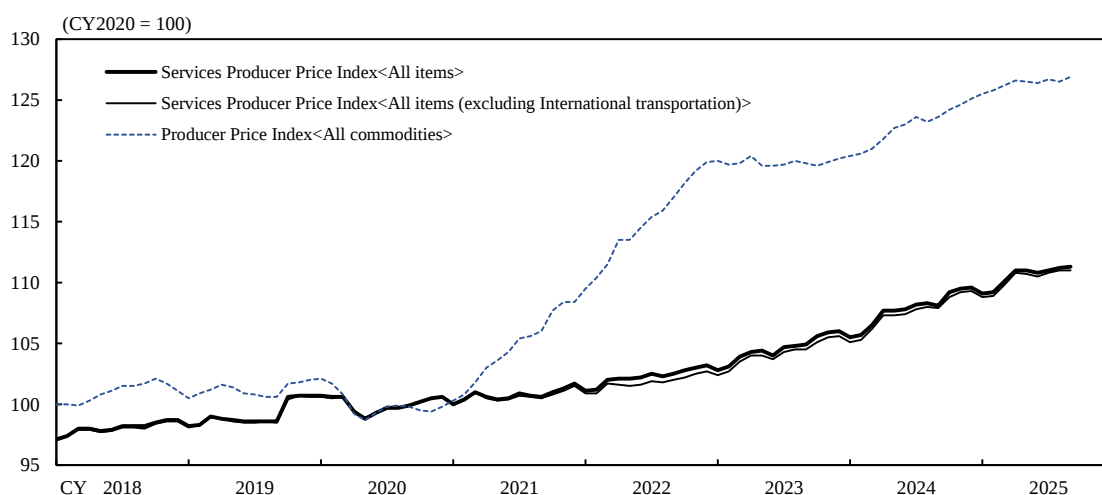
The Services Producer Price Index (All items) rose 3.0 percent from the previous year.
