Monthly Report on the Services Producer Price Index (Preliminary Figures for December 2025)

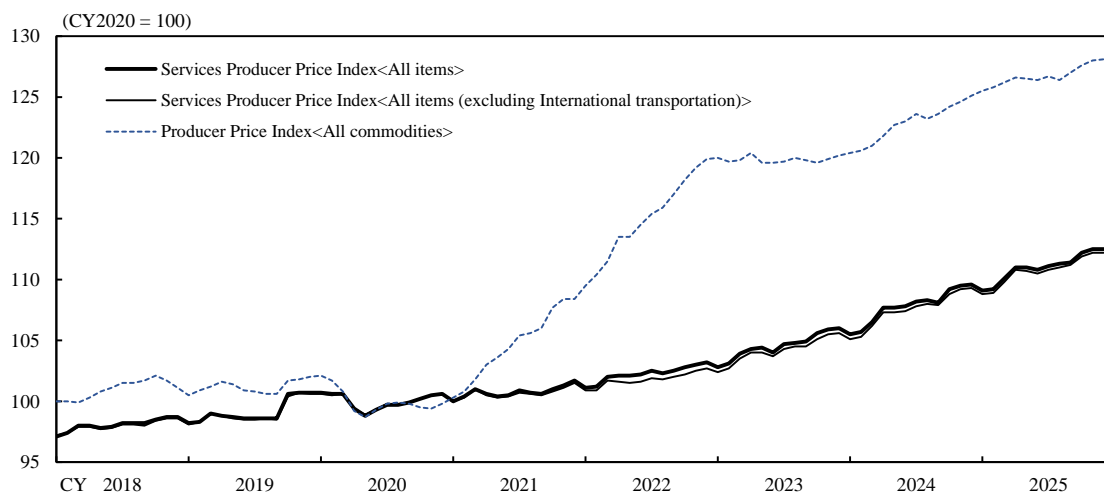
The Services Producer Price Index (All items) rose 2.6 percent from the previous year.
